## A RESOLUTION OF THE CITY OF ALBION, NEBRASKA REGARDING PLACEMENT OF TRAFFIC CONTROL SIGNS IN ORDER TO REGULATE TRAFFIC AND PARKING

**WHEREAS,** the City Council is authorized by Section 3-115 of the City of Albion Municipal Code to provide for, by resolution, the placing of stop signs, restricted parking, or other signs, signals, standards or mechanical devices in any street or alley for the purpose of regulating or prohibiting traffic and parking thereon; and,

**WHEREAS**, the City Council of the City of Albion, Nebraska has determined that it is in the public interest to prohibit parking along the south side of Walnut Street from the alley between 5<sup>th</sup> Street to 6<sup>th</sup> Street eastward to the 5<sup>th</sup> Street Intersection;

**THEREFORE**, **BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF ALBION**, **NEBRASKA**, that parking shall be prohibited along the south side of Walnut Street from the alley between 5<sup>th</sup> Street to 6<sup>th</sup> Street eastward to the 5<sup>th</sup> Street Intersection and signs shall be placed indicating the public of the same; and,

**BE IT FURTHER RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ALBION, NEBRASKA,** that RESOLUTION 117(23) REGARDING PLACEMENT OF TRAFFIC CONTROL SIGNS IN ORDER TO REGULATE TRAFFIC AND PARKING is hereby repealed.
