2. Discussion and possible action on Resolution No. 20210608-002 ratifying the disaster declaration signed by the Mayor on February 15, 2021 and consenting to its continuation

through July 15, 2021; repealing conflicting ordinances and resolutions; including a severability clause; and establishing an effective date.

Upon a motion by Mayor pro-tem Wright and seconded by Council Member Townsend, Council approved Resolution No. 20210608-002. The motion passed on a 5-0 vote. Council Member Svoboda was absent.

3. 5. Discussion and possible action to approve accounts payable reports for April 2021.

6. Discussion and possible action on an utility agreement for water, sewer and utility line extension with Holigan Development, LLC and MHCDV1 Angleton, LLC for the Reserve Development.

Upon a motion by Council Member Townsend and seconded by Council Member Booth, Council denied the utility agreement. The motion passed on a 5-0 vote. Council Member Svoboda was absent.

7. Discussion and possible action on a letter of intent with FMSbonds, Inc. for underwriting services & G-17 Disclosure.

8. Discussion and possible actions on any of Governor Abbott's latest executive orders, Brazoria County's emergency declarations and impact on the City of Angleton and how to proceed with city business in the future.

Upon a motion by Council Member Townsend and seconded by Mayor pro-tem Wright, Council approved to continue the leave through Families First Coronavirus Response Act: Employer Paid Leave (FFCRA) until the Department of Labor discontinues it in September 2021. The motion passed on a 5-0 vote. Council Member Svoboda was absent.

9. Update on the Brazoria County Joint Airport Zoning Board.

An update was provided by Lindsay Koskiniemi, Assistant Director of Development Services.

10. Discussion and possible action on an agreement with Sorrell Construction Equipment & Materials, LLC to demolish the municipal pool, pool house, pump house, all concrete paving, poles and perimeter fence and authorize the City Manager to execute the agreement upon final legal review.

Upon a motion by Mayor pro-tem Wright and seconded by Council Member Gongora, Council approved an agreement with Sorrell Construction Equipment & Materials, LLC in the amount of \$35,000 and authorized the City Manager to execute the agreement upon legal review. The motion passed on a 5-0 vote. Council Member Svoboda was absent.

11. Discussion and possible action on Lakeside Park bids and potential cuts.


