**REGULAR AGENDA**

1. Approve the minutes of the Senior Citizen Commission meeting of April 7, 2025.

Upon a motion by Member Phillips and seconded by Member McDaniel, the Commission approved the minutes from the April 7, 2025, meeting. The motion passed with a vote of 3-0.

2. Discussion on proposed amendments to Resolution 2007-R-3A - The Senior Citizen Commission.
  - Recreation Superintendent presented proposed updates to align with other City boards.
  - Topics included: board composition, appointment process, term lengths, term limits, attendance, vacancies, officer roles, and duties.
  - Member Shaw expressed concern about increasing membership to seven and quorum requirements.
  - Director explained quorum rules and term limit options (with or without a one-year break).

- Discussion included filling vacancies, attendance policies, and electing a chairperson annually in October.
  - Angleton residency requirements were clarified.
  - Staggered terms suggested to avoid full board turnover.
  - Member McDaniel commented on her tenure regarding term limits.
3. Discussion on the proposed Silver Hearts Senior Program General Rules & Code of Conduct.
- Recreation Superintendent presented proposed rules for program participants, including behavior expectations, trip procedures, disciplinary policies, and appeals.
  - Member Shaw suggested adding a rule requiring drinks on buses to have sealable lids.
  - Staff discussed participant identification via CivicRec and removing “Fourth Offense” language.
  - Acknowledgment process considered—annual or seasonal via CivicRec.
  - Member McDaniel supported the proposal as the program grows.

#### COMMUNICATION FROM COMMISSION

- Member Shaw requested an update on hiring a second driver for senior trips. Recreation Superintendent reported ongoing efforts, but no new CDL drivers added. Mentioned new 11-passenger van for staff use without CDL.
- Recreation Superintendent announced the Silver Hearts Kentucky Derby Party on August 20 at 11 AM and invited commission members.

**EXECUTIVE SUMMARY:**

At the August Senior Citizens Commission meeting, the commission was asked to provide feedback to revise Resolution 2007-R-3A, the Creation of the Senior Citizens Commission. Staff presented the commission with suggested revisions that aligned the structure and guidelines similar to other City of Angleton boards.

After discussion, staff are presenting today to the commission the revised document that includes staff suggestions as well as commission feedback.

**RECOMMENDATION:**

Staff recommends that the commission discuss the amended resolution of the Senior Citizens Commission.

**AMENDED RESOLUTION NO. 2007-R-3A****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ANGLETON AMENDING RESOLUTION NO. 2007-R-3A REGARDING THE SENIOR CITIZENS COMMISSION; PROVIDING UPDATED MEMBERSHIP REQUIREMENTS, TERM LIMITS, AND OPERATING GUIDELINES.**

**WHEREAS**, the City Council of the City of Angleton, Texas (the "City") desires to create a senior citizens commission to communicate the needs and issues of seniors living in Angleton, Texas to the Mayor and City Council. This shall be accomplished by educating, advising, and making recommendations in the areas of, including but not limited to, housing, transportation, health care, legislative, recreation, and other quality

**WHEREAS**, The City of Angleton has a growing population of senior citizens, and

**WHEREAS**, Citizens over the age of 55 account of 17.95 percent of the population of Angleton; and

**WHEREAS**, The City of Council of the City of Angleton recognizes the special needs of senior citizens; there for

**WHEREAS**, the City Council desires to revise and clarify certain provisions of Resolution No. 2007-R-3A to ensure effective operation of the Senior Citizens Commission;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANGLETON:**

**SECTION 1.** They shall approve the creation of a Senior Citizens Commission. **The Senior Citizens Commission shall consist of up to seven members appointed by the City Council. All members shall be residents of the City of Angleton and at least 55 years of age.**

**SECTION 2.** The Commission shall elect their own ~~officers and~~ chairperson.

**SECTION 3.** The Commission shall report to the City Council recommendations that are concern to Senior Citizens.

**SECTION 4.** The Commission shall hold public meetings. **Meetings shall be held at least quarterly.**

**SECTION 5.** The Commission shall advise the council on issues of housing, transportation, health care, legislative, recreation and other quality of life issues.

**SECTION 6.** **Commission members shall serve two-year terms. Appointments shall be staggered, with four members appointed in odd-numbered years and three members in even-numbered years. Commission members may serve no more than two consecutive terms, with a one-year break before reappointment, OR may serve unlimited terms if reappointed by Council.**

**SECTION 7.** **Any member who is absent from three consecutive regular meetings without good cause, as determined by the Commission, may be removed by the City Council. Vacancies shall be filled by City Council for the unexpired term.**



**SECTION 8.** All other provisions of Resolution No. 2007-R-3A remain unchanged and in full force and effect.

**SECTION 9.** All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of the conflict only.
