NOTICE IS HEREBY GIVEN PURSUANT TO V.T.C.A., GOVERNMENT CODE, CHAPTER 551, THAT THE ANIMAL SERVICES ADVISORY COMMITTEE FOR CITY OF ANGLETON WILL CONDUCT A MEETING, OPEN TO THE PUBLIC, ON MONDAY, MARCH 1, 2021, AT 5:30 P.M., AT THE CITY OF ANGLETON COUNCIL CHAMBERS LOCATED AT 120 S. In accordance with an Order of the Office of the Governor issued March 16, 2020, this meeting scheduled is in person and open to the public at The City of Angleton Council Chambers located at 120 S. Chenango Street Angleton, Texas 77515. In order to advance the public health goal of limiting face-to-face meetings (also called "social distancing") to slow the spread of the Coronavirus (COVID-19), seating will be limited to 50% Fire Code capacity or 24 people to allow for 6 feet of separation.

Citizens who wish to attend the Meeting in person must abide by the following requirements:

1. Do not enter the building if you are having symptoms. Go home.
2. Maintain a minimum distance of 6 feet from other citizens.
3. Families or persons traveling together may sit together but maintain social distancing from others.

ROLE OF THE CHAIRMAN

Chairman: is a person that is in charge of the meeting. This person has the ability to direct where and what is discussed in the meeting. Usually referred to as Mr. or Madam.

Some Responsibilities are

- Opens the session
- Calls members to order
- Announces the purpose and topic of the meetings which will be discussed for the day
- Recognizes members on the floor who are going to speak
- Announces results of the vote
- Protects the quorum from straying off topic
- Protects majority of members from disruptive/distracting actions.



Some Attributes of a Chairman

1. Chairperson is an elected person from the group
2. Has the ability to do interventions.
3. Whenever there is a vote from the group, the chairperson is then obligated to rule on a motion based on a majority vote.
