AN EXTENSION OF A DECLARATION OF LOCAL DISASTER NO. 24-004 HURRICANE BERYL PROCLAMATION OF THE MAYOR OF THE CITY OF ANGLETON, TEXAS

WHEREAS, On July 8, 2024, the City of Angleton, Brazoria County, Texas, received widespread and severe damage, injury, and loss of property resulting from Hurricane Beryl, severe weather from torrential rainfall, severe flooding, and damaging winds and other public calamity resulting there from, which requires emergency action; and

WHEREAS, On July 16, 2024 the City of Angleton city council held a special meeting and city council approved an extension of the Declaration of Local Disaster signed by the Mayor on July 13, 2024; and

WHEREAS, the Mayor of Angleton; John Wright, has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property, roads, and parks; and

WHEREAS, the City of Angleton Emergency Management Plan should be activated;

NOW, THEREFORE, BE IT PROCLAIMED BY THE MAYOR OF ANGLETON, BRAZORIA COUNTY, TEXAS:

SECTION 1. That a local state of disaster is hereby declared for the City of Angleton, Brazoria County, Texas pursuant to §418.108(a) of the Texas Government Code.

SECTION 2. The Mayor, as Director of Emergency Management, is hereby authorized to provide, or cause to be provided, all arrangements, provisions and means necessary and proper to effect coordination of relief, and property restoration for the protection, preservation, and improvement of life and property within the City during the State of Emergency.

SECTION 3. Pursuant to §418.108(b) of the Government Code, the state of disaster shall continue for a period of not more than seven days from the date of this declaration unless continued or renewed by the Mayor and City Council of Angleton, Texas.

SECTION 4. Pursuant to §418.108(c) of the Government Code, this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the City Secretary.

SECTION 5. Pursuant to §418.108(d) of the Government Code, this declaration of a local state of disaster activates the recovery and rehabilitation aspects of all applicable local or interjurisdictional emergency management plans and authorized the furnishing of all aid and assistance as deemed necessary or desirable by those administering such plans and activates the preparedness and response aspects of the City of Angleton emergency management plan, and any other such plans.

SECTION 6.	That this	s proclamation	shall	take	effect	immediately	from	and	after	its
