1. Approve the minutes from Regular Called meeting on August 22, 2022.

Upon a motion by Member Demopulos and seconded by Member Cooper, the board approved the minutes from the Keep Angleton Beautiful meeting that was held on August 22, 2022. The motion passed with a 5-0 vote.

2. Discussion on the 2022 Fall Sweep

Jason O'Mara, Assistant Director of Parks & Recreation provided an update on upcoming Fall Sweep event including current vendors for heavy trash, tire recycling, paper shredding and a new vendor for electronic recycling. Additional discussions included Trees for Houston participation and communication plan to promote the event. Member Cooper inquired about adding paint recycling to the event and Jason informed the board of a

potential partnership that staff are working towards which most likely won't happen until the Spring Cleanup.

3. Discussion on Keep Angleton Beautiful programs and services updates.

Jason O'Mara, Assistant Director of Parks & Recreation provided an update on various KAB events and initiatives including details on Texas Arbor Day Tree Planting Nov. 5th, staff working with TxDOT on the Green Ribbon project to incorporate medians on 288B/Loop 274 with current initiatives, current Green Gardening Series switching from monthly to quarterly, Keep America Beautiful membership status and staff creating a new digital form for completing the annual litter index, and updates to the KAB newsletter. Lastly, Jason provided details on the 77 percent increase from FY20-21 to FY 21-22 in KAB trash bags being bought at the Angleton Recreation Center and the recent price increase in restocking our bag inventory caused staff to increase the price per roll from \$7 to \$10. The board recommended finding alternate ways to promote trash bags sales at the Rec Center and to look at collaborating with other organizations throughout the city to increase awareness and participation.

EXECUTIVE SUMMARY:

Spring Cleanup

This year's Spring Cleanup is scheduled to take place on Saturday, April 22nd from 8 am – 12 pm at the Angleton Junior High School's parking lot. The event will continue to feature the following services.

- Heavy trash disposal by Waste Connections
- Tire recycling by Liberty Tire
- Electronic recycling by Raki Computer Recycling
- Paper shredding by Data Shredding Service

All vendors have been contacted and confirmed for onsite support. Each was present at the Fall Sweep, so they are familiar with our operations which helps ensure a smooth planning and execution process for the event.

In addition, staff are working to bring new offering through a partnership with Keep Pearland Beautiful to include services for accepting paint (oil, latex, aerosol) and household cleaning products. Staff are continuing to work on these details and update site plans to integrate the paint and household cleaner drop location.

Trees for Houston – Through continued partnership Trees for Houston will supply our event with a variety of native trees to distribute to participants and encourage planting and reforestation in the City of Angleton.

Communication Plans – Promotion went out in the recent water bill advertising the event. Staff have been fielding calls on specific items accepted and if assistance is available to unload items. Further promotion through flyers at the Angleton Recreation Center and deliver to local business is ongoing. Promotion on social media and ARC member emails are scheduled to occur weekly

starting March 27th and will continue until the event date as we plan to highlight each individual service and offering to encourage community participation.

Arbor Day Tree and Butterfly Seedball Giveaway

Keep Angleton Beautiful will be hosting its annual Arbor Day Tree and Butterfly Seedball giveaway on Friday, April 28th at 8 am at the Angleton Recreation Center. We've partnered with Trees for Houston to offer a variety of trees to distribute to community members for planting throughout the Angleton. Staff are engaged in discussions with a community volunteer group to make the butterfly seedballs as a service project for the organization. In addition, staff may be seeking support from our senior program participants to assist with making the seedballs depending on participation from the local volunteer group. Once final details are available, staff will notify the Keep Angleton Beautiful on specifics to assist in Butterfly Seedball creation the week of April 24th at the Angleton Recreation Center.

EXECUTIVE SUMMARY:

On December 20, staff advertised a Request for Proposal (RFP) for traffic signal controller cabinet wrap art for two new locations within Angleton including: Loop 274 and Locust, Business 288 and Cedar.

This is an opportunity to continue supporting the aesthetic improvement of the state highway system within Angleton city limits and, also, fulfills goal four, revitalize downtown, objective three, attract arts, entertainment, and specialty retail downtown, of the Strategic Plan adopted by City Council on June 26, 2018. KAB provided staff direction regarding a theme which included Texas Wildflowers, historical Texas heroes, coastal birds, and Texas butterflies, for the RFP. The RFP was advertised on December 20, 2022, and closed on January 31, 2023.

Staff received several submissions from three artists which were evaluated and ranked by KAB members. Based on their ranking the recommended submissions for wrap installation are Show Me a Sign by Joy Chandler and Texas Wildflowers by Heather Pizzitola.





EXECUTIVE SUMMARY:

Keep Texas Beautiful Annual Report: In early March staff submitted the annual report for Keep Texas Beautiful. On March 14, 2023, staff were notified that Keep Angleton Beautiful met all requirements to continue its good standing designation with the organization.

Green Ribbon Project/Loop 274/BUS288 Median Landscaping: Staff are continuing to work with staff from TxDOT's on the Green Ribbon Project and recently received 90% preliminary design plans for this project. Current plans include the requested medians along 288B to be included and TxDOT should be looking to let the project later this year.

City Water Bill Donations: In August 2022, staff recommended the board to approve an increase to the water bill donation from \$.50 to \$1.00 which was unanimously approved by KAB then presented to City Council who approved the increase as well. The approved increase took affect in Dec. 2022 and below provides a breakdown of current revenue collected in FY23, both prior to the increase and following the increase.
