1. Approve the minutes from Regular Called meeting on October 24, 2022

Upon a motion by Member Cooper and seconded by Member Scarborough, the board approved the minutes from the Keep Angleton Beautiful meeting that was held on October 24, 2022. The motion passed with a 5-0 vote.

2. Discussion on the 2023 Spring Events

Jason O'Mara, Assistant Director of Parks & Recreation provided an update on upcoming Spring Cleanup event including current vendors for heavy trash, tire recycling, paper shredding and a new vendor for electronic recycling. Additional update provided regarding ongoing discussions with Keep Pearland Beautiful as a partner and offer paint and household cleaning product recycling. Marketing

underway with water bill flyer and upcoming social media and onsite advertising. Arbor Day – Tree and Butterfly Seedball giveaway on schedule to take place at the end of April. Looking to partner with a volunteer group and senior programming to make seed balls the week of the event. Trees for Houston will continue to support both events by donating trees.

3. Discussion and possible action to recommend KAB approval of the top two TxDOT traffic controller cabinet art wrap submissions

Jason O'Mara, Assistant Director of Parks & Recreation requested approval of top two art wraps submissions. Member Scarborough started discussion on grading process and ways to enhance local artist involvement. Megan Mainer, Director of Parks & Recreation, spoke on current submissions and location of vendors providing submission per the RFQ standards. Motion made by Member Scarborough to submit the two box wraps that were local artists and seconded by Member Brewer. The motion passed with a 5-0 vote. Additional motion made by Member Dellinger for Parks & Recreation staff to select the specific locations for the art wraps seconded by Member Cooper. The motion passed with a 5-0 vote.

4. Discussion on Keep Angleton Beautiful programs and services

Jason O'Mara, Assistant Director of Parks & Recreation provided an update on various Keep Angleton Beautiful items including submission of Keep Texas Beautiful report to maintain affiliate level, green ribbon project being picked up by TxDOT which submitted 90% plans and anticipate fall let date, and reviewed increase KAB donations being received through the City water bill. Member Brewer asked about advertising opportunities and education around water usage. Chris Whittaker, City Manager, provided information on how the City educates the community on water usage and conservation.

### EXECUTIVE SUMMARY:

At the Keep Angleton Beautiful board meeting on March 20, 2023, staff presented information regarding the recent Request for Proposal (RFP) for traffic signal controller cabinet wrap art and requested approval from the Board to move forward with installation of approved artwork locations within Angleton including Loop 274 and Locust, Business 288 and Cedar. Following the discussion and conversations around where the artists reside the Board passed a motion to approve the two local artists. However, in preparing to notify the artists it was determined that all three artists meet the local criteria of a 70-mile radius, so information presented to the Keep Angleton Beautiful board was inaccurate.

In an effort to uphold the Boards previous recommendation staff have identified an additional TxDOT box location to accommodate three submissions. The list presented below provides the locations, artwork title (if applicable), and artists for your review.

- Cannan & Loop 274 – Show Me a Sign – Joy Chandler
- Cedar & Bus 288 – Melissa Jacobson
- Locust & Loop 274 – Texas Wildflowers – Heather Pizzitola

### RECOMMENDATION:

Staff recommends Keep Angleton Beautiful amend the previous approval and approve all three artists TxDOT traffic controller cabinet art wrap submissions.

A Study in Line, Space and Planes:

I see line

I see planes

I get lost and found in my paintings all at the same time. I push past the fear and make a dot...a mark. I push this dot as I see fit all around the paper. I trust my instincts as an Artist and create what wants to be created. When it feels done, I stop. The line comes from nothing and then becomes something I see and recognize. I see and experience the movement over and over. I can be thrilled and elated or extremely disappointed, but I press on knowing this is part of the process. I trust the process. Process in Art reveals ourselves in the raw. It creates a space of safety to grow and heal. So, I move on to the next step applying water, tissue paper, and watercolor. I allow it to flow and be fluid. I am reminded to go with the flow of life. Sometimes geometric shapes form and sometimes it becomes something more dimensional. The balance of light and dark must coincide to help us see the space...to see the dimensions...to see the planes. Once the painting is dry, I see the treasure or surprise. This part is like opening an unexpected gift from a beloved parent, friend, or lover. At this point in the process I get lost in the painting, it calls me, "COME HERE LOOK...What do you see?" I then add color pencil to create more contrast and bring out what I am discovering in it, yet I don't want to overpower the work. I want it to happen naturally, so I allow time to show me my next steps. I get lost again in the ebb and flow and it lulls me into a sense of peacefulness. I think about the beauty of the animal or subject and its place here on earth. I want to draw attention to this beauty to remind us to take care of and respect their space ...their place. After all, we ALL deserve our own space and place in this world.

I have enjoyed this Series on a Study in Line, Space and Planes. It is my hope that the viewer too will get lost and found in my Art. I hope they will come away with a tranquil feeling of wanting to be in that time and space and wanting to discover a little something of their own to take away with them.

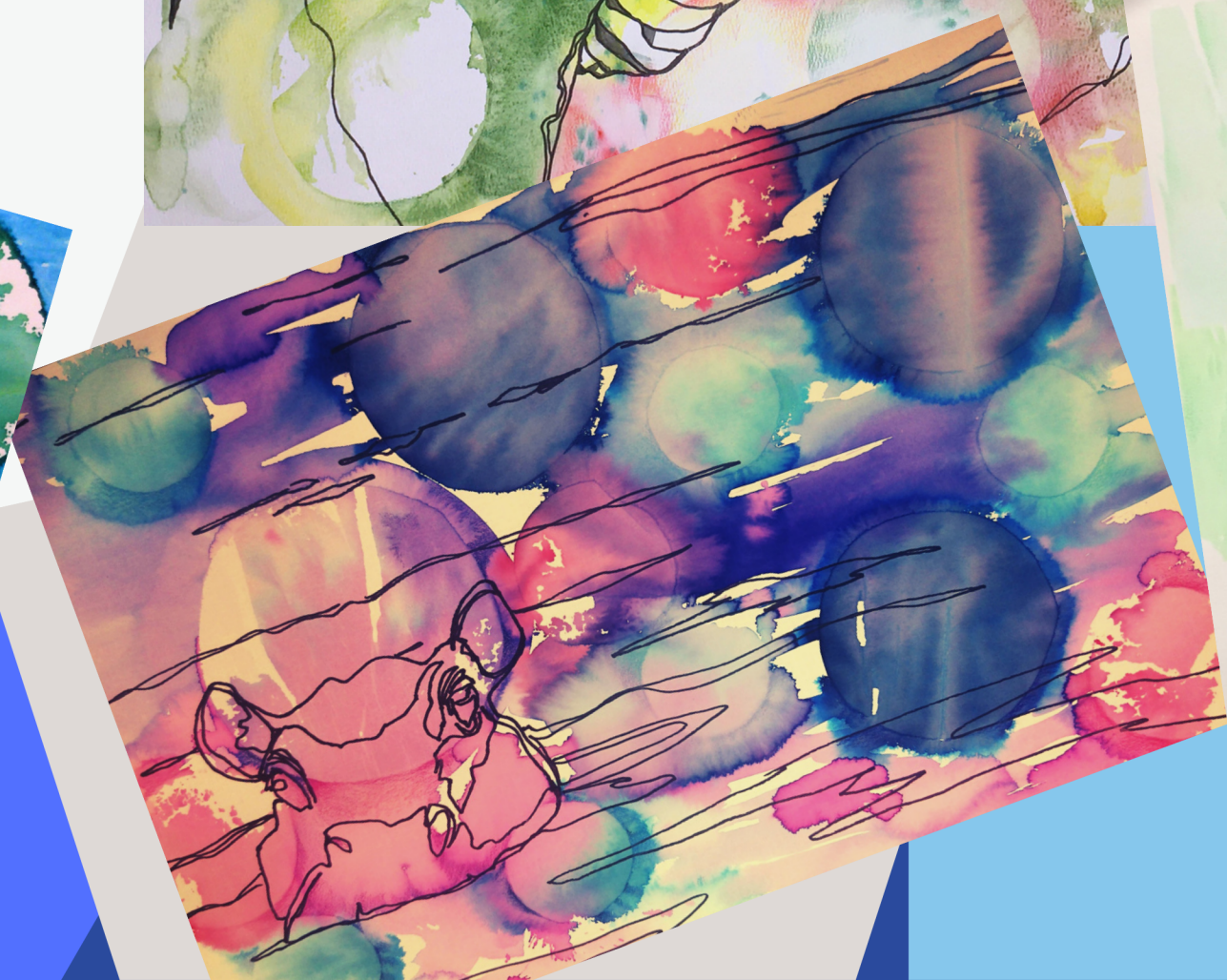
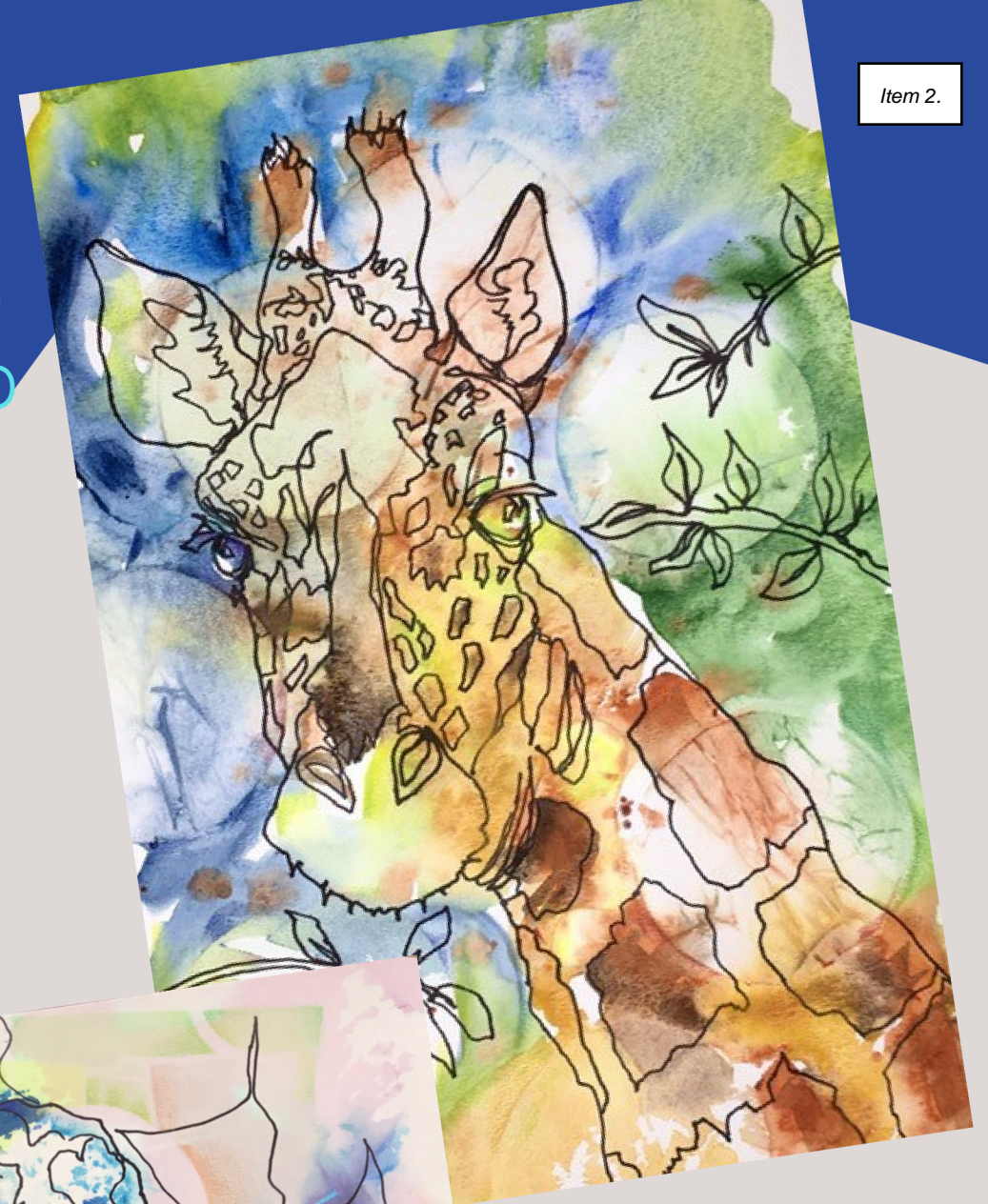

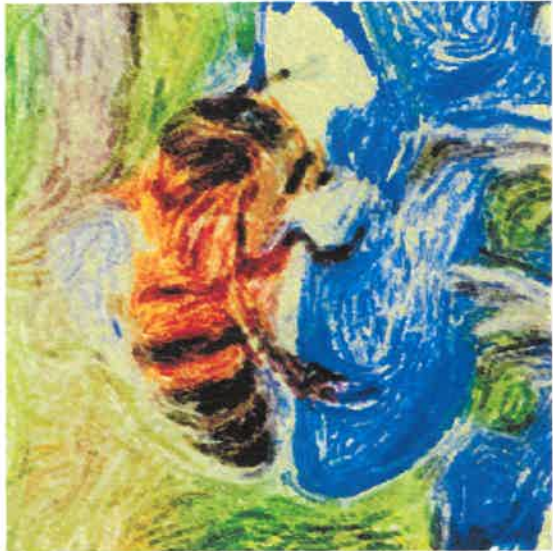

### EXECUTIVE SUMMARY:

Keep Brazoria County Beautiful Association is a non-profit that runs the Home Chemical Collection Site at the Seabreeze landfill. They concentrate on being able to safely dispose of Hazardous Household Waste (HHW) for county residents and the site is open the second Saturday of every month.

In order to maintain operations and to provide residents access to proper disposal of HHW free of charge, Keep Brazoria County Beautiful asks Brazoria County cities to support by paying a small annual fee based in the cities per capita. Cities have not been billed since the pandemic due to the site being closed however the collection site was able to reopen in March of 2021. Collected funds are used for supplies for the sorting and packaging of the HHW as well as paying workers with TCEQ certifications to handle the materials. Other than paying the workers for the one day per month the site is open, the site is entirely volunteer operated.

Keep Brazoria County Beautiful is requesting Keep Angleton Beautiful to renew the contrition by paying their 2022-2023 annual dues in the amount of \$1,268. Funding to support this initiative was not planned for in the current fiscal year but Keep Angleton Beautiful does has the ability to absorb the expense due to funding coverage by their H-GAC grant for cleanup events.

### RECOMMENDATION:

Staff recommend Keep Angleton Beautiful approve the expense to support Keep Brazoria County Beautiful and ensure free access to the Home Chemical Collection Site at Seabreeze landfill.
