### **EXECUTIVE SUMMARY:**

At the August 7, 2023, meeting, the Senior Citizen Commission approved the Jan 2024 – September 2024 Senior Lunch & Trip Plan, which included an overnight Casino trip to Louisiana scheduled for September 2024. Being an out of Texas trip, the Recreation Specialist of Senior Programs is unable to drive, and the scheduled contracted driver has backed out of the trip.

The Recreation Specialist has put together a recommendation for a replacement overnight trip to occur in September 2024 to Corpus Christi, Texas. The trip would be scheduled for September 25 – 26 and includes a tour of the botanical gardens, a visit to the historic Corpus Christi Harbor Bridge, a visit to the Texas State Aquarium, as well as two lunch and one dinner reservation. This trip would be available to reserve spots starting Thursday, May 2, at 5 AM.

### **RECOMMENDATION:**
