FOLLOWING THE PRESIDENT'S DECLARATION OF A NATIONAL DAY OF MOURNING FOR THE PASSING OF PRESIDENT JAMES EARL CARTER, JR.

RECOMMENDATION:

Consider declaring January 9, 2025, as a City Holiday and closure of City offices, following the President's declaration of a National Day of Mourning for the passing of President James Earl Carter, Jr.

BACKGROUND:

On December 30, 2024, President Biden issued an Executive Order closing all executive departments and agencies of the federal government and declaring January 9, 2025, as a National Day of Mourning for the passing of President James Earl Carter, Jr.

DISCUSSION:

Section 15 of the Angels Exempt Memorandum of Understanding and section 10 of the Angels Miscellaneous Memorandum of Understanding state in part, "... Any additional holidays recognized by the Federal Government shall be an additional holiday and not substituted for any existing holiday."

The Police and Fire Memorandums of Understanding handle holidays differently and do not contain language addressing "Additional" holidays declared by the Federal Government.

The Executive Order issued by President Biden ordered that all executive departments and agencies of the Federal Government shall be closed on January 9, 2025, as a mark of respect for James Earl Carter, Jr., the thirty-ninth President of the United States.

The City of Angels is not an executive department or agency of the federal government. A Day of Mourning with office closures may be different than a "Federal Holiday."

While the City of Angels is not a Federal agency and the President did not declare January 9, 2025, a "Holiday", the County of Calaveras, and the County of Tuolumne have or will declare January 9, 2025, as a holiday within their jurisdiction and will close their offices for the day.

DECEMBER 30, 2024

Executive Order Providing for the Closing of Executive Departments and Agencies of the Federal Government on January 9, 2025

By the authority vested in me as President by the Constitution and the laws of the United States of America, it is hereby ordered as follows:

Section 1. All executive departments and agencies of the Federal Government shall be closed on January 9, 2025, as a mark of respect for James Earl Carter, Jr., the thirty-ninth President of the United States.

- Sec. 2. The heads of executive departments and agencies may determine that certain offices and installations of their organizations, or parts thereof, must remain open and that certain employees must report for duty on January 9, 2025, for reasons of national security, defense, or other public need.
- Sec. 3. January 9, 2025, shall be considered as falling within the scope of Executive Order 11582 of February 11, 1971, and of 5 U.S.C. 5546 and 6103(b) and other similar statutes insofar as they relate to the pay and leave of employees of the United States.
- Sec. 4. The Director of the Office of Personnel Management shall take such actions as may be necessary to implement this order.
- Sec. 5. General Provisions. (a) Nothing in this order shall be construed to impair or otherwise affect:
- (i) the authority granted by law to an executive department or agency, or the head thereof; or
- (ii) the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.

(b) This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

Section 3, Item A.

(c) This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.
