

An Advisory Committee (hereinafter called the "Advisory Committee") shall recommend distributions and disbursements from the income from the Fund, monitor uses of such disbursements and recommend to the Board of Directors of the Community Foundation such other actions as it deems appropriate under such rules or procedures as the Advisory Committee may adopt. The Community Foundation may act, with respect to the income from these segregated funds, upon receiving the written recommendation of the Advisory Committee. Further, the Donor and the Community Foundation agree, for purposes of this provision and for purposes of construction of this Instrument of Transfer, that the Community

Foundation shall be in full compliance with this provision and Instrument, if, annually, and in no event less often than each three (3) years, the Community Foundation shall disburse substantially all of the net income accrued and then undistributed, to the Donor, for distribution by the Donor in a manner not inconsistent with the Last Will and Testament of Wayne F. Dennis, deceased.

The annual net income may be defined as interest and dividend income from the segregated fund. No administrative expense or charge shall be assessed against this separate, segregated fund nor reduce the income from the Fund subject to distribution on recommendation of the Advisory Committee.

The Advisory Committee shall consist of not more than ten (10) citizens of the City of Anthony, Kansas, such members to be designated by the Governing Body of the City of Anthony. It is understood that the Advisory Committee is accountable to both the City of Anthony, Kansas, and the Board of Directors of the Community Foundation to recommend distributions consistent with the purpose of the Fund and which distributions shall not be inconsistent with the provisions of the Last Will and Testament of Wayne F. Dennis, deceased. All Advisory Committee members must be approved by the Board of Directors of the Community Foundation. No member of the Advisory Committee shall serve for longer than a three (3) year term. Not less than one-third (1/3rd) of the initial members of the Advisory Committee shall be appointed to a one (1) year term. Not less than one-third (1/3rd) of the initial members shall be appointed to a two (2) year term, and the remaining initial members shall be appointed to a three (3) year term. Thereafter, each member designated and approved shall serve a three (3) year term. The initial Advisory Committee members are identified and the length of their initial terms are set forth on the attached Exhibit "A". Notwithstanding anything found elsewhere in this Instrument, this Instrument shall not be construed to provide that the composition of the Advisory Committee need necessarily be different or be comprised of persons other than those of the group formed under provisions of the Last Will and Testament of Wayne F. Dennis, deceased, nor shall this Instrument be construed to provide that the disbursements from the net income of this fund need necessarily be different or other than those suggested by the group formed under provisions of the Last Will and Testament of Wayne F. Dennis, deceased.

We are familiar with and accept the terms, definitions and procedures of Article VI, Sections 6.1 through 6.10, inclusive, By-Laws of the Anthony Community Foundation, such Article being

entitled "Gifts To The Foundation". We also understand that the Community Foundation, through its Board of Directors, reserves the right to make final decision regarding distributions from the income from the Fund, provided, however, that no use or distribution of said income from the Fund shall be inconsistent with the terms, conditions and restrictions contained in the Last Will and Testament of Wayne F. Dennis, deceased; and provided, further, that the Community Foundation shall, upon written direction from the Governing Body of the City of Anthony delivered to the Community Foundation, disburse the income from the Fund in the City of Anthony unless the Community Foundation, through its Board of Directors, finds the disbursement so directed to be in contravention of the charitable purposes of the Anthony Community Foundation, as set forth in its Charter and/or By-Laws. In that event, then, the Anthony Community Foundation may, nonetheless, disbursement of the entirety of such income, then held and undisbursed, to the City of Anthony, Kansas, as a governmental entity benefiting the Anthony Community. No transfer from the City to the Foundation, nor from the Foundation to the City, shall restrictions of the Last Will and Testament of Wayne F. Dennis, deceased, as construed by the District Court. All investment of Foundation in investments which are not inconsistent with the Last Will and Testament of Wayne F. Dennis, deceased, as construed by the District Court of Harper County, Kansas. In the event that the Board of Directors of the Community Foundation determines that the District Court of Harper County, Kansas. 8. Bid Opening Metal Building

9. Request to Burn Lake City Maintenance - Larry Berry

Larry is doing maintenance work along the shoreline and wants to burn the area.

10. Approval to Bid Out Rehabilitation Work on Power Plant Houses

I have mentioned in previous budget sessions that the power plant houses need work. We are the landlords to these rental properties, and they have not had any upgrades for many decades. I will bring photos to the meeting, but it is my recommendation that the city hire out a contractor to upgrade the kitchens, bathrooms, and other areas of aged rot and disrepair. I will explain at the meeting.

11. ID/Economic Development Board Public Survey - Curt Miller

Curt will be here to get your input on the survey which is attached in the packet for review. If you think anything should be removed or added please bring your thoughts to the meeting. He will also be seeking permission to put the survey in the utility bills. Not all utility customers are city customers therefore, if the commission wants it to go in the bills, then we need to either be ok with opinions from those who do not pay local taxes, or we can edit the survey to ask for Anthony residents only. You can discuss this with Curt at the meeting. They are looking for quidance.

12. Request to Waive Hall Rental Fees - Bomgaars Job Fair

Bomgaars will not be present. They asked to use the Hall to help promote the 13 jobs they plan to bring to the area by hosting a community job fair. As an economic development initiative the city could allow them to host at the Hall (since their facility is not suitable yet due to construction). They did not ask for the fees to be waived; we are discussing this as a way to support the economic endeavor. I do not have authorization to waive rental fees, so the request is in your court.

13. Wayne Dennis Fund Review

This was requested by the Commission. I sent the documents in a previous email but will attach them to the packet as well for easy access. I will have my list of review comments at the meeting.

Admin Report:

1. KCC-40101d Grant – As you are aware, President Trump has passed many Executive Orders affecting the vast amount of grant dollars and programs that have been available. We have received official "guidance" from KCC to "pause" at this time work on all IRA and IIJA projects, including the 40101(d) projects. They do not yet have specific written directions from their project officers at DOE, so they are unclear what this means long-term. We had a planning meeting scheduled with KMEA to conclude a few of the project determinations. We will keep this meeting and finalize our directive planning to be ready in the event we can continue work, but we will not

take any additional steps past that until we know the official directive from KCC once they have it.

- 2. Community Solar As mentioned above the President's Orders have also required a current "Stop" on the tax credit program. It is unclear whether that will permanently stop the program. A full repeal of all the IRA incentives seems unlikely because it would still have to go through Congress, and politicians from both sides of the aisle support numerous aspects of the existing policy. So, there are some that feel the solar tax credits will not be permanently stopped. We will, however, have to watch and see.
- 3. EPA Water Tech Assistance We had a planning meeting scheduled for January 28th but received word that EPA had cancelled all planning meetings pending further instruction, also due to the change in recent orders and budget directives at the federal level. More to come once they have direction as well but it does appear the engineering work we are doing to solve the water main break issue is on official pause.
- 4. IRA Tree Grant Bill received word that this grant is also officially on stop. We were waiting to cut the trees on the tree board list this year because of this grant. However, since we do not know the future of this funding opportunity, the street department will go ahead and proceed on tree trimming for this year and if we get the grant after all, we will claim reimbursement on the tree trimming for next year instead.
- 5. CDBG Grant We received notification from the Department of Commerce that the freezing of federal funds will also affect this grant. An immediate deadline for reimbursement requests was released January 28th and due the same day by 4:00 p.m. We have our requests for reimbursement submitted for work completed so far however, we are in the middle of construction at 311 S Lincoln. This was a large concern for a couple of days as we contemplated how we would pay the contractor and allow them to keep working because we were not going to stop work in the middle of a project with a person's house torn up. However, thankfully, within two additional days we received word the CDBG funds were being released, and we could continue construction. We are still a little nervous and hoping the contractor can finish quickly while we still have a window open to get reimbursements. Who knows how long things will last as we are in this period of freezing.
- 6. Grant Funds In the few days that has followed the executive orders, some things have been frozen, then unfrozen, then frozen again, there is even a lawsuit now against President Trump stating that some of these funding sources were not able to be frozen just by executive order alone. This reminds me of the early COVID days where things are changing every day and there is a lot of information being released to read and keep up on. In your packet is a memorandum for the Executive Office of the President for reference.
- 7. Lake Trail We met with the landowners on January 24th and then had a joint meeting with NRCS on February 3rd. We have started conversations with the NRCS office to coordinate the drainage correction needed for this farm ground in cooperation with the construction of the trail. What the landowner decides to do to correct the drainage at this location will impact portions of how we

construct the trail, so it is necessary to work together in this effort. These are some of the items we are currently working on as we prepare the draft of the engineered trail plan for the commission to review. Conversations and research will continue in the next few weeks with EBH, HP CO NRCS, Landowners, and city staff.

- 8. Sunrise 2nd I have had several communications with Klausmeyer Construction in the last two weeks as they prepare the preliminary lot agreements and layouts for the spec homes. I have put them in touch with local real estate agents to help gauge the market in determination of whether to construct slab on grade, basements, number of bedrooms etc.
- 9. Kayak Building Bids will be opened at this meeting. As you review these requests you may or may not get bids on different "types" of buildings as there is a difference between constructing a carport type structure with sides or constructing a small metal building. Carport type with sides is generally a cheaper option with lower strength materials and longevity. Small metal buildings will have stronger materials but will be priced higher. Randy and Jacquie had quoted more of the carport type structure with sides so, even the lower price option appears to be sufficient for their uses. We wanted to see how far off the difference in pricing was, so we did not specify the cheaper material type. It is left open so the Commission will have the ability to see what kind of bids we get, the pricing with each, and then we can weigh out if there is any reason to go with a little better building. Again, the cheaper type does appear to be a very viable option so if that is the more affordable priced bid when they are opened, it is a satisfactory route.
- 10. CCLIP Main & Anthony The documents are submitted to the state. I need to update my right of way certification as it is also required for this grant project. I will do that next week. After that, we will have all of our information submitted to KDOT.
- 11. ID/Eco Devo Board The board held a special meeting on January 27th to finalize the draft survey. Curt Miller will be at this meeting to present the draft to the Commission and gain input or edits to take back to the ID Board for their final approval at their February 11th meeting. A copy of the survey is attached to that agenda item in the packet.
- 12. EOY Financials Jamie and I have tried to start the end of year review. With limited time availability this will take a few weeks to complete but we have started. Once it is complete we will present the final 2024 Transfer List for approval. If there are no changes to this list and it only contains what was budgeted, I will put it on the consent agenda. If you would prefer I list it in regular business so it can be presented formally for discussion, please let me know.
- 13. Planning Commission The PC met on January 28th to discuss violations of the Unified Development Sign Code. They will review additional information for further discussion at their next meeting.
- 14. Street Department 2025 Capital Planning Bryan and I still plan to bring a recommendation back to the Commission for the 2025 plan however, our rescheduled meeting with Joel will not be until

later this week and we need that piece of information to compile the final report. Look for this to be presented at the February 18th Commission meeting.


- 15. Health Insurance Annual Renewal Jamie and I met with Blue Cross and HUB on January 30th for the presentation of the annual renewal of the current level funding insurance plan. We will have another meeting on February 7th for the presentation of a self-funded policy option. Historically we have ventured away from the risk level of self-funded policies. However, if we want to continue to provide 100% health coverage to employees, it is going to be important that we review all options. I do not want to spend a lot of time on self-funding options without the Commission's direction to do so. Therefore, I will sit in at this one meeting and then provide a summary of this option along with our regular renewal at the Commission at the next meeting. Then, if the Commission wants to pursue alternate options you can guide me to do so.
- 16. Water Violation Notice The City of Anthony has received a violation notice for failure to submit our Monthly Disinfection report. The report was due on a Friday, it was emailed on Monday, but KDHE still counted it late and is requiring a notice to be sent to all water customers. The notice is quite extreme, and I have a call into KDHE to discuss this as I believe this may be confusing to customers since it makes a statement that "we cannot be sure of the quality of our drinking water". This is a non-factual statement because we tested chlorine residuals daily and have those records. The water was completely safe, the report of the residuals was just late to the state. We will work this out, but it is my responsibility to let you know we have received a violation, and as of the date of this communication it will require a notice to customers.
- 17. Staffing Callie Carpenter is performing a 30-day trial in consideration of a transfer to the Administrative Assistant of Utilities vacancy. If all goes well, the city will be hiring a Utility Billing Clerk. We have had no applications for water or mechanic. We are running ads again and will run them in surrounding rural communities as well.
- 18. 2025 Legislative Session I attended the Capital Day on January 29th with KMU as they lined up meetings with with the Governor's Advisor on Water, the House Appropriations Chair, Speaker of the House, Senate President, Senate Majority Leader, Senate Utilities Chair, KCC Chair, Deputy Secretary of Commerce, and LKM representatives. The two drivers of legislation are budgets and taxes. The current budget projections have the state's budget in the red by 2029. Here are some highlight notes and a feel of the direction of the state focus:

The House is drafting a budget this year prior to the Governor presenting hers. They are, "taking back the budget" if you will. The focus is to attempt to return the budget to the way it was prior to COVID, prior to all of this money being released. They want to get the budget back into "normalcy". The Chair of the House Appropriations said that in their understanding entities have been using this excess money for operating capital. That tells him they have been giving too much money.

An interesting point to this conversation is the Build Kansas fund. Remember this is the fund that pays the match for BIL grants. When this fund was approved, the Governor had asked for \$400 million up front for that program. Legislation gave her only \$50 million per year. Two years in

and they are glad they limited how much they gave her because there is still \$67 million sitting in there unspent. So in 2026 they are proposing to not put more in. There is an apparatus to get more funds in 2026 if it actually gets spent and the program needs it, but for now, it's clear that there are not a lot of cities in Kansas that are tapping into these funds. The very interesting part of this is who used it. **Anthony is one of only seven cities in the entire state** that got money from Build Kansas for utility projects. That's great for us but also mind blowing that not more cities were utilizing the program. Here is a list of all seven cities and the projects/dollars awarded:



We knew our time at the "flowing grant fountain" would be short lived, no more than a five-year run. But based on the President's orders and the focus of the state's budget, that run may end sooner than that.

The Rep from Commerce shared the focus of bringing AI Data Centers to Kansas and the economic opportunities that could bring to cities. He encouraged cities to be ready to compete for the attraction of these businesses. When they get interested companies that want to locate in Kansas they move quickly. We have to be ready to show what we can offer. The focus should be on speed (the project must be able to move fast), quality of place (sell the human aspects of your community and appeal to the quality of living we can provide), and talent. These companies need reliable power. They need access. Some need water for cooling heat exchangers but technology is advancing where that is not as critical. I don't know about you but we have an airport for access and we have reliable power and water. We have a mid-west proud quality of living with many

recreational amenities. We could compete. And building an AI Data Center or Aerospace Innovation Center at the airport, well, if we had staff to dedicate to this, you just never know.

There were other bills of interest dealing with the proposed elimination of the 3-Mile Extraterritorial Jurisdiction for cities, PD Cameras on Poles, several electric issues including Transmission Lines siting and costs, Eminent Domain, Net Metering, Property Tax Valuation Caps, and more. LKM will keep us posted on the status of these bills and will provide a call for testimony if any are moving in the direction of negative impact for a city.

In conclusion, as you are aware from my text message, LKM did call for testimony for HB 2152 which would potentially impact the investment rate the local banks have to offer local governments for the investment of idle funds. I have enclosed a copy of the testimony we provided to the House Committee. And yes, I typed it quickly to submit by the deadline and there is one typo. The shame.
However, at least we tried to present testimony of local impact. If this bill would have passed last year, it would have cost the city between \$100,000 - \$200,000 dollars of revenue from a source other than direct impact to the tax and rate payer. The letter of testimony is in your packet.

Written Testimony in Opposition

Members of the Committee:

I am the City Administrator with the City of Anthony in Harper County, Kansas, and have been tasked with the management and investment of public moneys in such a way to maximize net earnings, consistent with the public responsibility to secure maximum, safe investment return possible from moneys assigned to its stewardship, to relieve demands on the property tax and to otherwise reduce the cost of public services. This is not a small responsibility and one that would be greatly impacted with the passing of HB 2152. Please allow me to explain why.

We are a small rural community, population 2,069. Anthony provides water, sewer, and electric utilities, as well as general public services such as fire, police, streets, airport, recreation, etc. When I began my role as an administrator, our water department fund was in the red and our wastewater fund was projected to be the same the following year. We had an aging infrastructure and by 2019 we had already increased utility rates three times within four years, with the last increase being over 35%. These increases are gravely impacting on a rural economy. Please take note also, these increases occurred prior to COVID, prior also

then to the extreme inflation we have all been tasked with managing financially which has created an even greater financial burden to maintain department operations.

In an effort to be good financial stewards during these times, I attended the Kansas Municipal Utilities training on Asset Management Planning. This program helps utilities develop infrastructure management plans by analyzing their current operations and future needs while also helping to define investment priorities to meet those needs. In just three years the City of Anthony completely changed our budget strategy and started planning and investing toward future operational demands. In this scenario we were able to put small amounts of funding into an investment for later replacement needs. The city transitioned from getting loans and paying interest to replace equipment, to investing in planned repairs and earning interest revenue that can be used toward the needed cost of the project, sometimes helping to cover the now increased costs of purchase. This is what we believe was being good stewards to the funds entrusted to us and finding positive ways to meet the ever-increasing cost of public services.

The new Asset Management Budgeting initiative was kicked off in 2022. At that time the city had a few current investments with our local lenders. Those investments were earning approximately .6% - 1.8% on average, and had been for many years, even though the current investment rate as defined by K.S.A. 12-1675(a) was much higher. The City of Anthony is a strong supporter of all things local. Shop local. Invest local. All of that plays into the sustainability of our local economic model. Therefore, we did not desire to move our investments elsewhere, we did, however, believe it was our responsibility to manage and invest public money in such a way to maximize net earnings at the same level as what is currently standard available rates. Therefore, the city sent notification to our local lenders providing advanced notification that the city would be seeking rates equal to those defined in said statute for the following year's renewals and any future investments. Magically, our rates went from .6% to over 4.0% and 5.0%. This made a large difference in the investment income which has helped significantly with the infrastructure project demands we are trying to fund.

Since 2022 none of our investments have left our city. On two occasions, the investment did shift from one local lender to another, but requiring our local lenders to at least meet the statutorily defined rate has only improved our investment relationships and benefits to our economy. At a time when there is so much attention on how to reduce the burden of the tax dollar, limiting a city's ability to participate equally in the benefit of an alternate revenue source gives cause to reach out and appeal to the Committee to consider opposition to such a decision.

We cannot speak with experience to scenarios of investing outside of the local governmental unit if the lenders will not meet the rate, since we have not had to do that yet. I understand that would be a touch decision as well. However, allowing local government to participate in the available rate without limitations provides the largest possible financial gain to that local budget. Infrastructure has to be replaced. The total burden of cost to do so will end up with the tax and rate payers if cities cannot fully utilize other possible revenue sources. Further financial burdens on tax and rate payers do not help the economy or the business of the local lenders. Therefore, all stand to lose if limitations are placed on the investment potential.

The City of Anthony does strongly oppose this bill because we believe the overall sustainability of the local economy hinges on the ability to fully participate in available revenue opportunities. In doing so, the sustainability of local economics will be a little healthier, which benefits citizens and local business, which then benefits local lenders. We believe and have directly experienced this current statutory model without amendments provides the greatest benefit to all involved.

Thank you for taking this information into consideration. We appreciate your thorough work on this issue.

MEMORANDUM FOR HEADS OF EXECUTIVE DEPARTMENTS AND AGENCIES

SUBJECT: Temporary Pause of Agency Grant, Loan, and Other Financial Assistance

Programs

The American people elected Donald J. Trump to be President of the United States and gave him a mandate to increase the impact of every federal taxpayer dollar. In Fiscal Year 2024, of the nearly \$10 trillion that the Federal Government spent, more than \$3 trillion was Federal financial assistance, such as grants and loans. Career and political appointees in the Executive Branch have a duty to align Federal spending and action with the will of the American people as expressed through Presidential priorities. Financial assistance should be dedicated to advancing Administration priorities, focusing taxpayer dollars to advance a stronger and safer America, eliminating the financial burden of inflation for citizens, unleashing American energy and manufacturing, ending "wokeness" and the weaponization of government, promoting efficiency in government, and Making America Healthy Again. The use of Federal resources to advance Marxist equity, transgenderism, and green new deal social engineering policies is a waste of taxpayer dollars that does not improve the day-to-day lives of those we serve.

This memorandum requires Federal agencies to identify and review all Federal financial assistance¹ programs and supporting activities consistent with the President's policies and requirements.² For example, during the initial days of his Administration, President Donald J. Trump issued a series of executive orders to protect the American people and safeguard valuable taxpayer resources, including *Protecting the American People Against Invasion* (Jan. 20, 2025), *Reevaluating and Realigning United States Foreign Aid* (Jan. 20, 2025), *Putting America First in International Environmental Agreements* (Jan. 20, 2025), *Unleashing American Energy* (Jan. 20, 2025), *Ending Radical and Wasteful Government DEI Programs and Preferencing* (Jan. 20,

¹ 2 CFR 200.1 defines Federal financial assistance to mean "[a]ssistance that recipients or subrecipients receive or administer" in various forms, but this term does not include assistance provided directly to individuals. For the purposes of this memorandum, Federal financial assistance includes: (i) all forms of assistance listed in paragraphs (1) and (2) of the definition of this term at 2 CFR 200.1; and (ii) assistance received or administered by recipients or subrecipients of any type except for assistance received directly by individuals.

2025), Defending Women from Gender Ideology Extremism and Restoring Biological Truth to the Federal Government (Jan. 20, 2025), and Enforcing the Hyde Amendment (Jan. 24, 2025). These executive orders ensure that Federal funds are used to support hardworking American families.

To implement these orders, each agency must complete a comprehensive analysis of all of their Federal financial assistance programs to identify programs, projects, and activities that may be implicated by any of the President's executive orders. In the interim, to the extent permissible under applicable law, Federal agencies **must temporarily pause** all activities related to obligation or disbursement of all Federal financial assistance, and other relevant agency activities that may be implicated by the executive orders, including, but not limited to, financial assistance for foreign aid, nongovernmental organizations, DEI, woke gender ideology, and the green new deal.

This temporary pause will provide the Administration time to review agency programs and determine the best uses of the funding for those programs consistent with the law and the President's priorities. The temporary pause will become effective on January 28, 2025, at 5:00 PM. Even before completing their comprehensive analysis, Federal agencies must immediately identify any legally mandated actions or deadlines for assistance programs arising while the pause remains in effect. Federal agencies must report this information to OMB along with an analysis of the requirement. OMB also directs Federal agencies to pause all activities associated with open NOFOs, such as conducting merit review panels.

No later than February 10, 2025, agencies shall submit to OMB detailed information on any programs, projects or activities subject to this pause. Each agency must pause: (i) issuance of new awards; (ii) disbursement of Federal funds under all open awards; and (iii) other relevant agency actions that may be implicated by the executive orders, to the extent permissible by law, until OMB has reviewed and provided guidance to your agency with respect to the information submitted.

OMB may grant exceptions allowing Federal agencies to issue new awards or take other actions on a case-by-case basis. To the extent required by law, Federal agencies may continue taking certain administrative actions, such as closeout of Federal awards (2 CFR 200.344), or recording obligations expressly required by law.

Additionally, agencies must, for each Federal financial assistance program: (i) assign responsibility and oversight to a senior political appointee to ensure Federal financial assistance conforms to Administration priorities; (ii) review currently pending Federal financial assistance announcements to ensure Administration priorities are addressed, and, subject to program statutory authority, modify unpublished Federal financial assistance announcements, withdraw any announcements already published, and, to the extent permissible by law, cancel awards already awarded that are in conflict with Administration priorities, and; (iii) ensure adequate oversight of Federal financial assistance programs and initiate investigations when warranted to identify underperforming recipients, and address identified issues up to and including cancellation of awards.
