A request was presented by the ELC asking for \$32,000 in funding to expedite the completion of the Aslan Castle ELC project.

Melissa Smith from Paint Me Pretty requested funding to expand her current business to include a gym and dance studio. The EDA requested that she come back with more information including a breakdown of the costs for the expansion.

### **Unfinished Business:**

Centra has met with the County EDA to discuss a potential incentive for a walk-in/same day medical facility. The County EDA would like to discuss with the Town to determine what the Town EDA is prepared to offer. Dr. Garrett will reach out to Garett Bossiger with the County EDA.

Katrina Slagle with Aspire Mental Health and Wellness was presented with the offer that the attorney drafted and the EDA approved; however, as of today, Mrs. Slagle has not accepted. Mrs. Torrence suggested that the EDA place a deadline on acceptance of offers.
