A meeting of the Economic Development Authority of the Town of Appomattox was held on Tuesday, April 8, 2025 at 6:00 p.m. at the Appomattox Municipal Building, 210 Linden Street, Appomattox, Virginia.

Dr. Garrett called the meeting to order.

Christy Torrence, Office Manager, advised that Mr. Jim Boyce was sworn in for term ending December 31, 2028 and received his Oath of Office Certificate prior to the start of the meeting.

#### Approval of the Agenda
