AN ORDINANCE TO AMEND Section 32 of the Code of the Town of Appomattox to add, Chapter 32, Article III, Division 1, Section 32-104, entitled "Adoption by reference of State motor vehicle and traffic laws" which adds and incorporates certain sections of Titles 46.2 and 18.2 of the Code of Virginia that are related to streets, highways and other public ways and thoroughfares through the Town.

Be it ordained by the Council of the Town of Appomattox as follows:

§ 32-104. Adoption by reference of State motor vehicle and traffic laws.

Pursuant to the authority of \$46.2-1313, Code of Virginia, as amended, all of the provisions and requirements of the laws of the State contained in Title 46.2 and Article 2 of Chapter 7 of Title 18.2 of the Code of Virginia, as in force on July 1, 1977, and as amended in the future, except those provisions and requirements the violation of which constitutes a felony and except those provisions and requirement which by their very nature can have no application to or within the Town, are hereby adopted and incorporated in this chapter by reference and made applicable within the Town. References to "highways of the state" contained in such provisions and requirements hereby adopted shall be deemed to refer to the streets, highways and other public ways within the Town. Such provisions and requirements are hereby adopted, mutatis mutandis, and made a part of this chapter as fully as though set forth at length herein, and it shall be unlawful for any person within the Town to violate or to fail, neglect, or refuse to comply with any provision of Title 46.2 or Article 2 of Chapter 7 of Title 18.2 of the Code of Virginia which is adopted by this section, provided that in no event shall the penalty imposed for the violation of any provision or requirement hereby adopted exceed the penalty imposed for a similar offense under Title 46.2 or Article 2 of Chapter 7 of Title 18.2 of the Code of Virginia.
