Unfinished Business:

A discussion was held on the available rental spaces in the Town of Appomattox that could potentially house an urgent care facility. Mr. Gobble has reached out to the management companies for the available spaces and it appears that the rent will be between \$10,000 and \$15,000 per month. The Town of Appomattox EDA would like to offer an incentive of 20% per month for 5 years which would be 10% paid by the Town EDA and 10% paid by the County EDA. Mr. Garrett will reach out to Gary Bosiger with the County EDA.
