1. Beginning Organizational Meeting

Mayor asked Dale Harris to comment on Public Works Director, Roads and drainage into working manner. Drainage working used prisoners' as workers.

Mt Zion Dr needs dropbox, dropbox is essentially a box for water to fall into and let drain.

What is flooding everything is flowing into the ditches.

Program for roads at different intervals, would like to suggest dump truck and drag that was purchased isn't helpful for our roads. Would suggest looking into water tender.

Wells Project-Building and water, asked several times for a bond and is not getting any response and if doesn't have a bond by the end of the day they are shutting the project down. This was asked 2 weeks ago.

Farrar project first hydraulic modeling only had residential indoor use. No secondary water. He has talked with Farrar and until he has a source. They needs meters for plumbers he will .

When the State doesn't approve something they don't have authority to shut them down but we do have the authority to shut them down. Subdivision over there without a source.

CP down to 35 gallons a minute on one source and will not last through summer. Fire protection is paramount. We don't have that fire protection. Would like to see securing money for USDA heard of contract that Beddo was involved, Houses in water in Canaan springs we cannot supply water to homes.

Min should be 146 gallons per min. Will we get through the summer if we stop building and stop bulk water use. Developers need to

recommended CP to secure more water from the source. CP is is direr straights.

For the record Keven Sair and Frank Lindhardt have joined the meeting.

Mayor asked for a budget about using the prisoners to help with clean with ditches and use fill dirt. He said he would estimate about \$3500-\$4000 once a year for maintenance.

Mayor asks about residents being responsible for their storm drainage doe not work because everyone sense of the ditches is different.

Keven Sair makes comment about Fire Protection.

-Clean up sage brush possibly using equipment (Dale Harris says he can used backhoe)

Jr made comment about MOU requirements about any clean up needs to documented.

Frank asked about storage tank on Canaan.

Frank asked Dale Harris about Wells Estates and water study. Has anyone asked with legal council about fire protection safety.

David Zolg, Jr makes comment this is a serious issue. Storage= pressure.

Dale Harris makes comment on the water and the other comments from other engineers is almost used to keep everyone in confusion.

Mayor makes comment about dealing with the same issue with water in Hilldale. People are passing information in the community. Any information dealing with water needs to be dealt with by Dale Harris and Frank Lindhardt as well. In order to squash these rumors is having definite numbers to support what is actually going on in Apple Valley.

Frank Lindhart makes comment that is very helpful to know what is going on.

Dale Harris make comment about the connections and will serve letters and the requirement of giving a acre foot of water rights and possibly looking into a surge or throttling back the overuse of water.

Andy makes comment about storage.

Frank makes comment about making policy for developers in regards to the standards of the tanks. Policy is written.

Mayor makes comment about possibly having more than one tank .

Dale Harris makes comment would like to see packet when someone comes in for development.

Frank Lindhardt makes comment that all this needs to be documented upfront.

David Zolg, Jr recommends adopting WUI (Wildland Urban Interface) for our Town. Also allows to get into grants, etc. It is going to protect the homeowner. Agrees that we need a book for developers.

Dale Harris makes comment creating avenues that keep in place. Preparing for the long-haul.

Design Standards is online.

Dale Harris makes comment about AG variance. Getting a handle on that.

Fire Dept makes comment that not accepting any roads with cinders. Not sure about Cinder/clay adhesion.

Mayor asked what are other things that can help mitigate any fires from getting out of control.

Fire Dept recommends not opening burn season possibly. Adjusting burn season. Fire Dept can regulate with minimum standards. Kevin as Liaison is working with Fire Dept re: equipment. Road standards 26 feet wide, comment about no dead end turn arounds, hydrants 400 feet from home, comment about road base.

Mayor asks about community burn but was closed due to not being able to control what items people bring.

-Dale Harris suggests selling dump truck for water tender.- Dale Harris to take these items.

-Wells Estates- Dale Harris for written letter. Verbal communication/written communication with certified mail and then red tag.

Richard Fischer project does not have bond. Desert Star Financial Owner--project

Farrar project-family subdivision needs information. Coyote rd which is a dedicated public road and is re-routed the road onto private property which is illegal. Frank Lindhardt makes comment that there is procedure.

Frank makes comment that we have Master Road Plan, after reviewing with no right/left turn lanes. Proposed to put on Planning Commission meeting to update map.

Ditches cleaned

Adopt WUI fire codes for the Town.

next water bill for notice to clean ditches and open burn season for people to burn as of March 1st when the clean there debris.

Fire Dept makes comment about roads having secondary access. Grave concern with secondary accesses. Mayor comments with General Plan having secondary access.

-Clean up Sage Brush- organize volunteer day

-Site Lines- Safety issues address ASAP

-Road Standards will not approve cinders.

Franks comments about longevity of developments.

Zoning/Prelim Plat if they do not approved forward in one year then it automatically expires unless the apply for one year extension.

Development Agreements and Planned development is not the case. That stays with the property. We can change but usually not done by the town changing the zoning.

Final Plat sunset date is 2 years if not recorded.

Comment about community education about water. Re-educate people about the water source.

Letter to community re: surcharge for over usage and meeting re: information on water.

Frank has discussion about Planning Commission meeting and the agenda items.
