During the planning commission meeting, discussion and possible action was opened regarding the recommendation of approval to amend title 10.10.060 single-family residential zone. The proposal aimed to remove the half-acre single-family zone from the zoning regulations. Concerns were raised about the potential increase in costs for residents with children who wish to stay in the area. Chairman Farrar discussed that the Mayor expressed a desire to explore options to make it easier for residents to accommodate their children on their existing land.

7. Recommendation of Approval to Amend Title 10.10.110 Cabins Or Tiny Home Parks Zone, Ordinance-O-2024-03.

Chairman Farrar discussed the proposed changes included increasing the minimum zone size from 5 to 15 acres and adjusting the density from six units to four units per acre. These adjustments aimed to reduce density. No comments or concerns from the commission.

MOTION: Chairman Farrar motioned that we recommend approval to amend Title 10.10.110 Cabins Or Tiny Home Parks Zone with the addition of under item E, number 1, we make the correction from "5 acres" up to "15 acres."

Chairman Farrar discussed the proposed changes mirrored previous adjustments, focusing on height regulations, density, and minimum zone size. The minimum zone size for recreational vehicle parks was increased from 10 to 20 acres due to the need for larger lots in these areas.

MOTION: Chairman Farrar motioned that we recommend approval to amend Title 10.10.100 Recreational Vehicle Park Zone with the addition that under item E, number 1, we change the minimum size from "10" to "20" acres.
