1. September 5, 2023 Primary Election Canvass.

Council Member Sair commented he is going to turn the time over to the council members on where we stand in the community and where we hope to be in the future.

Council Member Zaharias commented that he was under the impression that the county didn't want to give us a certification. He continued; it has to do with the system. We decided to push back for election

integrity. It was our duty to certify. Verifying with the county made a difference so that they could perform their duty and certify the results.

Council Member Whitmore commented on background information. She continued, when we stated we wanted to do our Elections earlier in the year, we met with Lt Gov and her assistant Shelly Jackson. Our issue has always been that we didn't feel comfortable certifying something we couldn't verify. We talked to her about that and she told us that we could not look at the ballots and I said well I can't certify if I can't look at them. It always bothered us on what she told us but because she is head of elections of the state, we trusted that. She presented Jenna (Town Clerk/Recorder) who is our election officer with a book and stated State code hasn't really caught up with us. That bothered us. We've just gone under the assumption that we were going to have to figure out something without being able to look at the ballots. On Saturday after researching through state code, the council is the board of canvassers and it states in state code that we have the right to inspect the ballot and counts. On Monday Frank (Mayor Lindhardt) had Jenna (Town Clerk/Recorder) contact them and they called their lawyer, and their lawyer called our lawyer. Our lawyer called us and said ok yes you can look at the ballots but they may require a resolution from the town council to grant the request. Frank (Mayor Lindhardt) went down to the county yesterday and spoke with them and reviewed the state code regarding inspecting the ballots. We are getting pushed back on this request even though it is state law. They also said it's according to our contract and not the state code. Frank (Mayor Lindhardt) pointed out to them this was a special election and they changed the dates and rules. The state changed so that every county had to run the election and our town did not have a choice so that would nullify our contract. The lawyer from the county said something to the effect "That ok we'll make an exception for you and you can come tomorrow at 8:30 in the morning. Frank (Mayor Lindhardt), and the three of us (Council Member Whitmore, Sair and Zaharias) went down this morning to the county office. They wouldn't let us touch the ballots because of chain of custody but that's not really inspecting the ballots. We were able to watch them go through and count. We stood right behind them and we watched the whole process. They looked legit yet still we couldn't verify that every one of those ballots was a registered voter and a valid vote. The system needs reforming. The person who granted the opportunity to watch said they are afraid that more and more cites are going to be doing what we are doing. We should be doing our own elections and verifying that everyone is registered that is voting. This is the biggest issue of our time because people are losing faith in our election system and we want to restore that faith.

Council Member Sair commented on voter integrity and the problems they are having. The mail-in ballots are a big problem. The county can't prove that they are legit and registered voters. This council is dedicated to making elections transparent. This is at ground level in Apple Valley and will blossom as it grows. The validation of the mail in ballots is the concern.

Council Member Whitmore reviewed the Canvass Report for the Municipal Primary Election on September 5, 2023. (Attachment A, 2 pages)

The council thanked each candidate for running.

Town Attorney Shawn Guzman commented because David Lane has formally withdrawn on September 18th, in the motion you would name the 5th seat for Town Council as the 4th. It was confirmed that if
