DISCUSSION AND POSSIBLE ACTION ITEMS

9. Preliminary Plat Extension Request - Crimson Peaks subdivision.

*Tabled from September 4, 2024.

Chairman Farrar initiated the discussion and action items by introducing item number nine and ten, which concerned a preliminary extension request for the Crimson Peak and West Temple subdivisions. Mayor Farrar addressed the planning commission, stating that he had been working closely with the applicants and requested a one-year extension for both items nine and ten. He highlighted the applicants' cooperation, mentioning that they had been resolving issues collaboratively without much legal intervention. The mayor requested the maximum extension period to allow for the completion of construction drawings and final plats.

Chairman Farrar then opened the floor for comments. Commissioners agreed with the mayor's request, acknowledging the points made and expressing support for the extension.

MOTION: Chairman Farrar motioned that we approve the Preliminary Plat Extension Request - Crimson Peaks subdivision for one year.

10. Preliminary Plat Extension Request - West Temple subdivision.

*Tabled from September 4, 2024.

Chairman Farrar introduced item number ten, which involved a preliminary extension request for the West Temple subdivision. Chairman Farrar expressed support for the extension, noting that if the mayor was actively involved in the project, granting the extension would be reasonable. Other commissioners agreed, indicating their support for the request.

MOTION: Chairman Farrar motioned that we approve the Preliminary Plat Extension Request - West Temple subdivision for one year.

Item number eleven was removed from the agenda and was not discussed during the meeting.

12. Zone Change Application from Open Space Transition to A-X Agricultural Zone for parcel: AV-1354-NP-2-A. Applicant: The Little Creek Living Trust Dated April 28, 2024.

Chairman Farrar presented item 12, a zone change application from OST to A-X for a five-acre parcel by Little Creek Living Trust. Chairman Farrar mentioned the parcel is used for agriculture, surrounded by similar properties, and meets standards, seeing no issues. Chairman Farrar then invited comments and called for a motion.

MOTION: Commissioner Wood motioned to approve Zone Change Application from Open Space Transition to A-X Agricultural Zone for parcel: AV-1354-NP-2-A. Applicant: The Little Creek Living Trust.

13. Zone Change Application from Open Space Transition to A-X Agricultural Zone for parcels: AV-1350-A, AV-1344, AV-1351-A-1. Applicant: Sup I, II, III, LLC.

Chairman Farrar introduced item 13, a zone change application from OST to A-X for 1,500 acres across several parcels. The land is used for agriculture and aligns with the general plan. Chairman Farrar noted its location on the north side of Main Street and expressed support before calling for a motion. Commissioners agreed with the proposal.

MOTION: Commissioner Wood motioned to approve Zone Change Application from Open Space Transition to A-X Agricultural Zone for parcels: AV-1350-A, AV-1344, AV-1351-A-1. Applicant: Sup I, II, III, LLC.

Chairman Farrar presented item 14, a zone change application from Planned Development to A-X Agricultural for a five-acre parcel. The parcel is located in the Gooseberry area with surrounding properties zoned as OST, Planned Development, and Agricultural. Chairman Farrar noted that the area is mixed but highlighted the agricultural zoning to the north and southeast. Chairman Farrar then asked for a motion.

MOTION: Commissioner Fralish motioned that approve Zone Change from Planned Development to A-X Agricultural Zone for parcel: AV-JHLS-1. Applicant: Darcy Anne Pauken.

Chairman Farrar noted that the property to the north is zoned agricultural, and the property to the east, also on the agenda for a similar change, was recently changed to agricultural. Chairman Farrar mentioned the location near Highway 59.

MOTION: Commissioner Wood motioned to approve Zone Change Application from Rural Estates 20 Acres to A-X Agricultural Zone for parcel: AV-1376-F. Applicant: Barbara and Steven Hayden TRS.

Chairman Farrar presented item 16, a zone change application from RE-20 to A-X. Chairman Farrar mentioned the parcel already has a home and is used for agriculture. It is located just south of the previously approved parcel, aligning with agricultural zoning. Chairman Farrar then called for a motion.

Chairman Farrar introduced item 18, a zone change application from OST to A-X for a 22.5-acre parcel. Chairman Farrar noted the location near Coyote Desert Drive, with the property east already approved for agricultural use and the property to the north zoned OST. Chairman Farrar mentioned that the general plan designates the area for agriculture and expressed no concerns with the application.
