Motion made by Commissioner Spielman, Seconded by Commissioner Stover to approve the consent agenda as written.

Voice Voting Yea: Commissioner Beeson, Commissioner Spielman, Commissioner Stover, Commissioner Tweedy, and Mayor Warren. Mayor Warren declared the motion approved, given Resolution No. 2024-09-3642.

Public Hearings

Mayor Warren made an announcement clarifying that this Public Hearing is specifically for the grant aimed at the splash pad addition and replacement of existing playground equipment at Wilson Park, not about potential housing development. Those who were in the audience wishing to speak about potential housing at Wilson Park were urged to sign up under the **Comments from the Audience for Items not on the Agenda**.

1. Hold a public hearing to receive public comment relating to the Revenue Neutral Rate.

Finance Director/Treasurer Waggoner gave a brief description of the Revenue Neutral Rate that has been in review by the City and Commissioners since May, and purpose of the public hearing. The RNR is a value issued to the City, measured in Mills by the County Clerk established though Senate Bill 13 in 2021 by the Kansas State Legislature as a means to create transparency regarding the amount of property tax levied. The rate given as expressed in mills and would generate the same property tax revenue in dollars as levied in the 2023 tax year using the City's 2024 assessed valuation. The City's valuation increased from \$77,705,705 to \$85,175,755 or 10%. Per the RNR, the mill levy was set to decrease from 63.074 to 57.544 mills if we had not informed the County Clerk of our intention to exceed this RNR rate by July 20th. Two budget work sessions have been held with the City Commission and all department heads. All sessions were open to the public. A Resolution of our Intent to Exceed the RNR was passed on July 16, 2024, and the Cowley County Clerk was subsequently notified on July 17, 2024. We publicized the notification of a public hearing for exceeding the RNR on August 24, 2024, in the *Courier Traveler*, as well as on the City's website. Many factors are considered in the proposed budget.

Motion made by Mayor Warren, Seconded by Commissioner Tweedy to hold a public hearing to receive public comment relating to the Revenue Neutral Rate.

Voice Voting Yea: Commissioner Beeson, Commissioner Spielman, Commissioner Stover, Commissioner Tweedy, and Mayor Warren. Mayor Warren declared the motion approved.

Mayor Warren opened the floor for public comment.

With no wishing to speak, Mayor Warren closed the floor for public comment.

Motion made by Mayor Warren, Seconded by Commissioner Tweedy to close the public hearing on comments related to the Revenue Neutral Rate.

Voice Voting Yea: Commissioner Beeson, Commissioner Spielman, Commissioner Stover, Commissioner Tweedy, and Mayor Warren. Mayor Warren declared the motion approved.

1. a. Consider a Resolution to exceed the Revenue Neutral Rate.

Staff recommends a budget with a projected mill levy of 62.693, which is lower than originally predected and published at 64.99 Mills.

Motion made by Commissioner Warren, Seconded by Commissioner Stover to approve the item as written.

Roll Call Voting Yea: Commissioner Beeson, Commissioner Spielman, Commissioner Stover, Commissioner Tweedy, and Mayor Warren. Mayor Warren declared the motion approved, given Resolution No. 2024-09-3643.

2. Hold a public hearing to receive public comment regarding the proposed 2025 budget.

The final two steps of the budget process is to hold the public hearing and adopt the budget. Finance Director/Treasurer Waggoner explained that September 20th is the final date to hold the public hearing and the budget must be adopted and certified to the County Clerk on or before October 1st. Two budget work sessions have been held with the City Commission and all department heads. All sessions were open to the public. Staff is requesting approval of a budget that decreases our current mill levy, from 63.074 to a projected 62.693, which will bring an estimated increase of \$433,439 in property tax revenue. Kansas State Statute requires a public hearing be held at least 10 days after the publication of Notice of Hearing is published in the official City paper. The Notice of Hearing for the 2025 budget was published in the *Courier Traveler* on August 24, 2024, and subsequently placed on the City's website. The public hearing is held to allow taxpayers an opportunity to be heard regarding the proposed budget.

Mayor Warren moved, seconded by Commissioner Stover, to hold a public hearing regarding the proposed 2025 budget.

Voting Yea: Commissioner Beeson, Commissioner Spielman, Commissioner Stover, Commissioner Tweedy, and Mayor Warren. Mayor Warren declared the motion approved.

Mayor Warren opened the floor for public comment.

- Vicki Jackson 1310 N 3rd, questioned who to speak with for clarification and understating of the State Budget forms drafts she asked for and received last Friday during work session. City Manager Frazer offered for Jackson to speak with himself or Finance Director/Treasurer Waggoner.
- Elton Gove 2935 Valley View Dr., raised infrastructure concerns in terms of water, and possible liquidation of the Hogan and the Northwest Community Center, further inquiring about overtime for Fire/EMS & Police Departments.
- Steve Young 1118 N 10th, spoke of a \$40 million dollar budget misprint in the *CourierTraveler* newspaper, also raising questions about the RNR Rate.

With no further comments, Mayor Warren closed the floor for public comment.

Mayor Warren moved, seconded by Commissioner Spielman, closed the public hearing for the 2025 budget.

Voting Yea: Commissioner Beeson, Commissioner Spielman, Commissioner Stover, Commissioner Tweedy, and Mayor Warren. Mayor Warren declared the motion approved.

2 a. Consider first reading of an Ordinance adopting the 2025 Budget for the City of Arkansas City.

Motion made by Mayor Warren, Seconded by Commissioner Beeson to approve the item as written.

Roll Call Voting Yea: Commissioner Beeson, Commissioner Spielman, Commissioner Stover, Commissioner Tweedy, and Mayor Warren. Mayor Warren declared the motion approved, given **Ordinance No. 2024-09-4616**.

New Business

City Clerk Parsons offered the following items for consideration:

City Manager Department

1. A Resolution authorizing the City of Arkansas City to apply for the Kansas Department of Wildlife & Parks (KDWP) Land and Water Conservation Fund Grant Program (LWCF), to renovate the Wilson Park tennis courts into pickleball courts.

Municipal Project Manager Rizzio explained that grant applications are due September 13, 2024. The program provides 50 percent reimbursement to selected outdoor recreation projects sponsored by political subdivisions and other appropriate public agencies. The local pickleball group has been raising funds for the past year to convert the Wilson Park tennis courts into four pickleball courts. They plan to raise a total of \$115,840.00 with a 1:1 reimbursement from LWCF for a total project cost being \$231,680.00.

Members of the audience asked to speak on the topic as granted by Mayor Warren.

- Vicki Jackson 1310 N 3rd, questioned the need to convert pickleball courts into tennis courts and apply for the grant.
- Elton Gove 2935 Valley View Drive, inquired if the total amount of money was raised. Project Manager Rizzio mentioned that the group is currently working on that.

John Farrar with the pickleball group was asked to provide an update that the total cost for the courts came up to \$231,000.00. In just five short months fundraising team have \$34,000 in the bank, a \$50,000 pledge from a doner that wants that amount matched. John confirmed the group is confident that they will get the match, and this grant will only help tremendously with funding. The group is looking at working with the same developer who constructed the courts in Winfield, that are being used daily. Current citizens in Arkansas City are playing inside at the Recreation center daily and commute to Winfield to play outdoors due to the poor condition of available tennis courts in Arkansas City.

■ John Sybrant 1005 N 1st, spoke of the Wilson Park Master Plan, voicing concerns for the final plans in opposition of the pickleball courts.

Motion made by Commissioner Beeson, Seconded by Commissioner Tweedy to approve the item as written.

Voice Voting Yea: Commissioner Beeson, Commissioner Spielman, Commissioner Stover, Commissioner Tweedy, and Mayor Warren. Mayor Warren declared the motion approved; given Resolution No. 2024-09-3644.

2. An Ordinance exempting the application of K.S.A. 41-719(d) to allow the sale and consumption of alcoholic liquor at a designated area of SCK Health during the Fall on the Lawn Special Event on October 5, 2024.

City Clerk Parsons spoke that VISIT Ark City, who holds a State of Kansas ABC Division Temporary Alcoholic Liquor License, has requested the city commission allow them to sponsor a beer garden to sell and serve beer and seltzers during the annual SCK Health Foundation Fall on the Lawn Community Event, with proceeds going towards the community July 4th fireworks display in Arkansas City. VISIT Ark City Jill Hunter spoke that she was approached by program founder Pam Crain and asked to serve at the event again this year. The event is put on as a thank you to the factory employees who server our community.

Motion made by Mayor Warren, Seconded by Commissioner Stover to approve the item as written.

Roll Call Voting Yea: Commissioner Beeson, Commissioner Spielman, Commissioner Stover, Commissioner Tweedy, and Mayor Warren. Mayor Warren declared the motion approved; given **Ordinance No. 2024-09-4617**.

City Manager Updates & Reminders

City Manager Frazer provided reminders and updates before the commission.

Consent Agenda Item: Approve adoption of Resolution No. 24-297 adopted by the City Council of the City of Wichita, Kansas, on September 3, 2024, regarding the issuance of its Health Care Facilities Revenue Bonds (Presbyterian Manors, Inc.).

Background: On Tuesday, September 3, 2024, the City Council of the City of Wichita adopted Resolution No. 24-297 declaring an intent to issue its Health Care Facilities Revenue Bonds (Presbyterian Manors, Inc.), in an aggregate principal amount of not to exceed \$90,000,000 pursuant to K.S.A. 12-1740 *et seq.* and K.S.A. 10-116a to provide funds to: (a) refund all or a portion of the City of Wichita, Kansas Health Care Facilities Revenue Bonds (Presbyterian Manors, Inc.), Series IV-A, 2013 and Series IV-A, 2014; and (b) to finance the acquisition, construction and equipping of improvements to senior living and health care facilities located within the State of Kansas operated by Presbyterian Manors, Inc..

One of the facilities financed by the Refunded Bonds and potentially constituting a portion of the Project is located within the City of Arkansas City. The Resolution adopted by the City of Wichita is provided pursuant to a portion of the Act (K.S.A. 12-1741a) for consideration and approval by the City Commission. Approval may be affirmatively made by action of the City Commission or will be deemed made if the City Commission fails to disapprove the issuance of the Bonds within seven business days after its next regular meeting following receipt of this request.

The Bonds are special obligations of the City of Wichita payable only from rental payments to be made by Presbyterian Manors, Inc. and shall not be an obligation payable in any manner of the City of Arkansas City or the City of Wichita.

RESOLUTION NO. 24-297

A RESOLUTION OF THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS DETERMINING THE ADVISABILITY OF ISSUING HEALTH CARE FACILITIES REVENUE BONDS FOR THE PURPOSE OF FINANCING OR REFINANCING THE ACQUISITION, CONSTRUCTION, IMPROVEMENT AND EQUIPPING OF SENIOR LIVING AND HEALTH CARE RELATED FACILITIES; AND AUTHORIZING EXECUTION OF RELATED DOCUMENTS

WHEREAS, the City of Wichita, Kansas (the "City") is a municipal corporation, duly created, organized and existing under the Constitution and laws of the State of Kansas (the "State"); and

WHEREAS, the City Council (the "Governing Body") of the City desires to promote, stimulate and develop the general economic welfare and prosperity of the City, and thereby to further promote, stimulate and develop the general economic welfare and prosperity of the State; and

WHEREAS, pursuant to the provisions of the Kansas Economic Development Revenue Bond Act, as amended and codified in K.S.A. 12-1740 *et seq.* and K.S.A. 10-116a (collectively, the "Act"), the City is authorized to issue revenue bonds for such purposes and to issue revenue bonds for the purpose of refunding such bonds; and

WHEREAS, pursuant to the provisions of the Act, the City has heretofore issued multiple series of health care facilities revenue bonds for the purpose of financing or refinancing the acquisition, construction, renovation and equipping of a senior living and health care facility and corporate office facility (collectively, the "Wichita Facilities") located within the corporate limits of the City for the benefit of Presbyterian Manors, Inc., a Kansas not for profit corporation (the "Corporation"); and

WHEREAS, the City has, pursuant to K.S.A. 12-2901 *et seq.*, as amended (the "Interlocal Cooperation Act"), previously entered into interlocal cooperation agreements with the cities of Arkansas City, Clay Center, Dodge City, Emporia, Ft. Scott, Lawrence, Newton, Parsons, Salina, and Topeka, Kansas (the "Participants") for the purpose of acting as issuer of health care facilities revenue bonds for the purpose of financing or refinancing the acquisition, construction, renovation and equipping of senior living and health care facilities located within the city limits of the Participants (collectively, the "Participant Facilities"); and

WHEREAS, the City has heretofore issued its Health Care Facilities Revenue Bonds (Presbyterian Manors, Inc.), Series IV-A, 2013 and Series IV-B, 2013 (collectively, the "Series 2013 Bonds"), the proceeds of which were used to: (a) acquire, construct, improve, equip, reimburse or refinance the costs of improvements to the Wichita Facilities and certain of the Participant Facilities; and (b) refund certain of the City's then outstanding revenue bonds previously issued for the benefit of the Corporation; and

WHEREAS, the City has heretofore issued its Health Care Facilities Revenue Bonds (Presbyterian Manors, Inc.), Series IV-A, 2014 (the "Series 2014 Bonds"), which were issued to acquire, construct, improve, equip, reimburse or refinance the costs of improvements to the Wichita Facilities; and

WHEREAS, the City has heretofore issued its Health Care Facilities Revenue Bonds (Presbyterian Manors, Inc.), Series I, 2018 (the "Series 2018 Bonds"), the proceeds of which were used to: (a) acquire existing senior living and health care facilities located in the City of Olathe, Kansas (the "Olathe Facility"); (b) refund and refinance revenue bonds issued by the City of Olathe, Kansas for the Olathe Facility; and (c) construct, improve, equip, reimburse or refinance the costs of improvements to the Olathe Facility, the Wichita Facilities and certain of the Participant Facilities; and

WHEREAS, the City has heretofore issued its Health Care Facilities Revenue Bonds (Presbyterian Manors, Inc.), Series III, 2019 (the "Series 2019 Bonds"), the proceeds of which were used to: (a) refund a portion of the Series 2013 Bonds and Series 2014 Bonds; and (b) construct, improve, equip, reimburse or refinance the costs of improvements to the Wichita Facilities, the Olathe Facility and certain of the Participant Facilities; and

WHEREAS, the Wichita Facilities, the Participant Facilities and the Olathe Facility (collectively, the "Facilities") are leased by the City to the Corporation; and

WHEREAS, the Governing Body determines it to be advisable and in the interest and for the welfare of the City and its inhabitants that revenue bonds of the City be authorized and issued, in one or more series, for the purpose of providing funds to: (a) refund all or a portion of the Series 2013 Bonds and Series 2014 Bonds (collectively, the "Refunded Bonds"); and (b) to finance all or a portion of the acquisition, construction and equipping of improvements to the Facilities (collectively, the "Project").

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

Section 1. Public Purpose. The Governing Body hereby finds and determines that the Project and the refinancing of the debt represented by the Refunded Bonds will promote, stimulate and develop the general economic welfare and prosperity of the City, and thereby further promote, stimulate and develop the general economic welfare and prosperity of the State.

Section 2. Authorization to Acquire Project; Intent to Issue Bonds. The City is hereby authorized to proceed with the Project and the refinancing of the Refunded Bonds and to issue its revenue bonds, in one or more series, in an aggregate principal amount not to exceed \$90,000,000 (collectively, the "Bonds") to pay the costs thereof, subject to satisfaction of the conditions of issuance set forth herein.

Section 3. Conditions to Issuance of Bonds. The issuance of the Bonds is subject to: (a) the Corporation's written acceptance of a Letter of Intent containing the City's conditions to the issuance of the Bonds (the "Letter of Intent") in accordance with the City of Wichita/Sedgwick County Economic Development Guidelines (the "Guidelines"); (b) the successful negotiation and sale of the Bonds to a purchaser or purchasers to be determined by the Corporation and acceptable to the City (the "Purchaser"), which sale shall be the responsibility of the Corporation and not the City; (c) the receipt of the approving legal opinion of Gilmore & Bell, P.C. ("Bond Counsel") in form acceptable to the City, the Corporation and the Purchaser; (d) the obtaining of all necessary governmental approvals to the issuance of the Bonds; and (e) the commitment to and payment by the Corporation or Purchaser of all expenses relating to the issuance of the Bonds, including, but not limited to: (i) expenses of the City and the City Attorney; (ii) any underwriting or placement fees and expenses; (iii) all legal fees and expenses of Bond Counsel; and (iv) all recording and filing fees, including fees of the Kansas Board of Tax Appeals.

Section 4. Sales Tax Exemption. The Governing Body hereby determines that pursuant to the provisions of K.S.A. 79-3601 *et seq*. (the "Sales Tax Act"), particularly K.S.A. 79-3606(b) and (d) and other applicable laws, sales of tangible personal property or services purchased in connection with construction of the Project and financed with proceeds of the Bonds are entitled to exemption from the tax imposed by the Sales Tax Act; provided proper application is made therefore and compliance with State Department of Revenue procedures and guidelines. In the event that the Bonds are not issued for any reason, the Corporation will not be entitled to a sales tax exemption under the terms of the Sales Tax Act and will remit to the State Department of Revenue all sales taxes that were not paid due to reliance on the sales tax exemption certificate granted hereunder.

Section 5. Reliance by Corporation; Limited Liability of City. It is contemplated that in order to expedite acquisition of the Project and realization of the benefits to be derived thereby, the Corporation may incur temporary indebtedness or expend its own funds to pay costs of the Project prior to the issuance of the Bonds; provided that such expenditures incurred prior to the issuance of the Bonds are at the risk of the Corporation that the Bonds will actually be issued. Proceeds of Bonds may be used to reimburse the Corporation for such expenditures made not more than 60 days prior to the date this Resolution is adopted, and as provided by §1.150-2 of the U.S. Treasury Regulations. The Bonds herein authorized and all interest thereon shall be paid solely from the revenues to be received by the City from the Corporation's operation of the Facilities and not from any other fund or source. The City shall not be obligated on such Bonds in any way, except as herein set out. In the event that the Bonds are not issued, the City shall have no liability to the Corporation.

Section 6. Execution and Delivery of Documents. The Mayor is hereby authorized to execute the Letter of Intent, and the City Clerk is authorized to deliver executed copies of this Resolution and the Letter of Intent to the Corporation. After compliance with the provisions of the Letter of Intent by the Corporation has been demonstrated, the Mayor and City Clerk are authorized to execute a bond purchase agreement with the Purchaser and the Corporation for the sale of the Bonds in a form satisfactory to the City Attorney and Bond Counsel.

Section 7. Further Action. The Mayor, City Clerk and other officials, employees and agents of the City, including the City Attorney and Bond Counsel, are hereby further authorized and directed to take such other actions as may be appropriate or desirable to accomplish the purposes of this Resolution, including, but not limited to: (a) execution on behalf of the City of the information statement regarding the proposed issuance of the Bonds to be filed with the State Board of Tax Appeals pursuant to the Act; (b) cooperate with the Corporation in filing an application for a sales tax exemption certificate with the Kansas Department of Revenue with respect to Bond-financed property; (c) providing for timely notification to the Trustee for the Refunded Bonds to call such bonds for redemption on such permitted redemption date as the Corporation shall request in writing; (d) cooperate with the Corporation to maintain any *ad valorem* property tax exemption for the Facilities which is consistent with the Corporation's charitable purposes, and execute such documents in connection therewith as are approved by the City Attorney; and (e) dissemination of this Resolution or other notices as may be required by the Act.

Section 8. Effective Date. This resolution shall become effective upon adoption by the Governing Body and shall remain in effect until December 31, 2025, unless extended by affirmative vote of a majority of the Governing Body.

AN ORDINANCE LEVYING SPECIAL ASSESSMENTS INCURRED BY THE CITY OF ARKANSAS CITY IN REMOVING NOXIOUS WEEDS ON PROPERTY HEREINAFTER LEGALLY DESCRIBED AND LOCATED WITHIN THE CITY LIMITS OF THE CITY OF ARKANSAS CITY, KANSAS, PURSUANT TO THE 2015 INTERNATIONAL PROPERTY MAINTENANCE CODE CHAPTER 3, SECTION 302.4.

WHEREAS, notice was given to the owners of real property hereinafter legally described as provided by the 2015 IPMC Chapter 1, Part 2, Section 107.2 as amended by Arkansas City Municipal Code Section 14-46, by the Neighborhood Services Office notifying said owners of the existence of noxious weeds growing on their property, determining that said weeds are a nuisance, and giving them due notice and reasonable time to abate such nuisance(s).

Such record of the costs are on file in the City Clerk's Office, and said owners have been notified as to the costs incurred and have failed to pay the same within thirty (30) days after receipt of said notice:

<u>Purpose:</u> A Resolution authorizing the City of Arkansas City to apply for the Fall 2024 Kansas Department

of Transportation (KDOT) Cost Share Program Grant for the Summit Street reconstruction

project from Skyline Road to Radio Lane. (Voice Vote)

Background:

This project is an immediate opportunity as Creekstone Farms, Skyline Homes, Kan Pak, and the other businesses all currently use Summit Street as a major thoroughfare. Creekstone, Skyline, and Kan Pak make up a very large population of employees and are the highest paying jobs for Arkansas City and therefore are essential to the growth of Arkansas City. This project is proposing to resurface Summit Street from Radio to Skyline and replacing the south leg of the intersection of Summit and Skyline (200' south of the existing concrete line) with full-depth concrete including curb and gutter. The resurfacing will provide a better driving experience for the user and help with the wear and tear on the semis, buses, and cars that utilize this road on a daily basis: providing savings to both businesses and consumers. The intersection of Summit and Skyline is the most heavily utilized intersection by semi-traffic and therefore has resulted in an accelerated deterioration of the road surface time and time again. Concrete roads excel in longevity and robustness, boasting a serviceable life of 20-40 years, which can outlast asphalt roads by up to double their lifespan. The extended durability means less frequent need for replacement. The resilience of concrete makes it better suited for areas with heavy truck traffic because it doesn't easily sink or develop ruts, especially in locations with a lot of start-stop actions. The total cost of the mill and overlay is \$1,233,424.16. The Cost Share Program is an 85:15 reimbursement ratio for construction costs only that will cover \$822,282.78. The required local match of 15% for construction costs and 100% for design and construction engineering in the amount of \$411,141.38.






SUMMIT STREET SKYLINE ROAD to RADIO LANE ARKANSAS CITY, KANSAS

Kansas Department of Transportation COST SHARE PROGRAM – Fall 2024



	Department of Transportation
BACKGROUND	The Kansas Joint Legislative Transportation Vision Task Force recommended the Kansas Department of Transportation look at ways to leverage state funding with local and private funding for projects related to job growth and retention.
OBJECTIVE	The Cost Share Program provides financial assistance to local entities for construction projects that improve safety, leverage state funds to increase total transportation investment and help both rural and urban areas of the state improve the transportation system.
	Up to \$6 million is available during the Fall 2024 round.
AVAILABLE FUNDING	Requested funds must be no larger than \$1,000,000 (max).
TONDING	This is a construction reimbursement grant and only construction costs are eligible.
ELIGIBLE PROJECTS	Construction projects addressing important transportation needs such as promoting safety, improving access or mobility and improving condition or relieving congestion.
	All transportation projects are eligible, including roadway (on and off the state system), rail, airport, bicycle/pedestrian and public transit.
ELIGIBLE APPLICANTS	Projects typically will be administered by a local unit of government. Non-governmental applications also will be considered.
LOCAL MATCH	A minimum of 15% non-state cash match is required. Additional consideration will be given to project applications that commit more than the minimum required match amount. Funds are awarded as reimbursement at the rate of the local match (i.e. The community provided a 15% match. KDOT would reimburse at 85% until the max amount awarded is met).
REQUIREMENTS	Candidate projects should include investments providing transportation benefits and are not eligible for other KDOT programs. Candidate projects may receive additional consideration if they support economic growth or aid in the retention or recruitment of business.
SELECTION PROCESS	Applications will be accepted on an ongoing basis beginning August 12, 2024 . General selection criteria includes: economic development, local contribution, safety, regional priority, and letting within the fiscal year it is awarded. Geographic distribution will also be considered during project selection.
	The Cost Share Program application will be available only on the KDOT website, beginning August 12, 2024.
HOW TO APPLY	All 2024 KDOT Cost Share Program applications must be completed through the online application available at http://www.ksdot.org/CostShare/CostShareProgram.asp by end of day September 19,2024.

FREQUENTLY ASKED QUESTIONS

Cost Share Program Fall 2024



Q. When can I apply for the Cost Share Program?

A. Cost Share has rounds open twice per year, in the Spring and Fall and applications are typically accepted for around one month. Exact dates for each round are announced in advance.

Q. What kinds of costs apply under Cost Share?

A. This is a **construction-only reimbursement grant** so the funds awarded can only be used for construction costs. Preliminary engineering, utility costs, etc. will not be funded.

Q. Is the match amount negotiable? Are we able to use work in kind or materials as our match?

A. To be eligible for the Fall 2024 round, the 15% local match is non-negotiable. Matching funds must be a hard cash match.

Q. If we are awarded, can these state funds be used as part of our match for a federal grant or other state grant?

A. No, Cost Share is a construction reimbursement grant so it cannot be considered match for anything else.

Q. We will be ready to bid and let as soon as we are awarded. Can we begin construction immediately?

- A. KDOT will not reimburse any costs incurred before there is a signed agreement between KDOT and the city/county and you have been sent a formal Notice to Proceed. This process takes at least 3 6 months after the date of the announcement.
- A. After the Notice to Proceed has been issued, KDOT will not process reimbursement until the final design plans and bid tabs have been submitted.

Q. If awarded, when will we receive the funding?

A. This is a construction reimbursement grant and funding is based off of the community match submitted in your application. Once construction has started on your project, you may submit a reimbursement request form along with supporting invoices and other documents. Once reviewed and approved, your city/county will receive a direct deposit of the funds. You do not have to wait until the project is complete to request reimbursement. But reimbursements will not be paid until final design plans and bid tabs have been submitted to the Cost Share team.

Q. We applied last round and weren't selected. Do we have to re-submit our application this time?

A. Yes. Applications do not roll over from previous rounds.

Q. We have a small project and want to do the work ourselves. What kind of standards will be required?

A. Plans **must be signed off on by a licensed engineer** before beginning construction. Throughout the process, the project must adhere to all city/county standards unless it is on a KDOT route – then state standards and permits must be applied.

Q. What happens if the cost of the project exceeds the estimated cost?

A. KDOT will reimburse to the agreed percentage reimbursement – up to a maximum amount specified in the award and agreement. We will not contribute any additional funding to the project above the maximum amount, but we can work with you to ensure the project is successful.

Q. I've started my application online - can I come back and finish it later?

A. If you are using the same browser on the same computer, your work will save, and you can continue. You cannot work on multiple applications at one time.
