Purpose: A Resolution authorizing and directing the redemption of Public Building Commission Refunding

Revenue Bonds of the City of Arkansas City, Kansas Public Building Commission. (Voice Vote)

Background:

The Public Building Commission (PBC) has issued its Public Building Commission Refunding Revenue Bonds, Series 2019 (the "Series 2019 Bonds") to refinance the construction of the facility known as the South Central Kansas Medical Center. Pursuance of the provisions of the Trust Indenture, dated as of July 23, 2019 (the "Indenture") prescribing the form and details of the Series 2019 Bonds, at the option of the PBC, the Series 2019 Bond maturing in the years 2035 and thereafter may be called for redemption from Security Bank of Kansas (the "Trustee") and payment on September 1, 2024, subject to the availability of funds therefor, and thereafter.

Bonds may be called for redemption and payment in such principal amount may be determined by the Chairman, in consultation with the City and the City's Financial Advisor. The Chairman is authorized to complete and execute the attached Call for Redemption and Notice of Redemption in substantially the form presented, the Chairman's execution of the Notice to constitute conclusive evidence of the PBC's approval of the redemption of the Series 2019 Bonds in such stated amount.

A RESOLUTION AUTHORIZING AND DIRECTING THE REDEMPTION OF PUBLIC BUILDING COMMISSION REFUNDING REVENUE BONDS OF THE ARKANSAS CITY, KANSAS PUBLIC BUILDING COMMISSION.

WHEREAS, the City of Arkansas City, Kansas (the "City") has heretofore created the Arkansas City, Kansas Public Building Commission (the "PBC"), a municipal corporation of the State of Kansas under the authority of K.S.A. 12-1757 *et seq.*, as amended by Charter Ordinance No. 18 and Ordinance Nos. 1657 and 1807 the City; and

WHEREAS, the PBC has issued its Public Building Commission Refunding Revenue Bonds, Series 2019 (the "Series 2019 Bonds") to refinance the construction of the facility known as the South Central Kansas Medical Center; and

WHEREAS, pursuant to the provisions of the Indenture prescribing the form and details of the Series 2019 Bonds, at the option of the PBC, the Series 2019 Bonds maturing in the years 2035 and thereafter may be called for redemption and payment on September 1, 2024 and thereafter; and

WHEREAS, the PBC hereby finds it necessary and advisable to provide for the redemption of the Series 2019 Bonds as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE ARKANSAS CITY, KANSAS PUBLIC BUILDING COMMISSION:

Section 1. The Series 2019 Bonds maturing in the years 2035 and thereafter may be called for redemption and payment in such principal amount may be determined by the Chairman, in consultation with the City and the City's Financial Advisor. The Chairman is authorized to complete and execute the attached Call for Redemption and Notice of Redemption in substantially the form presented, the Chairman's execution of the Notice to constitute conclusive evidence of the PBC's approval of the redemption of the Series 2019 Bonds in such stated amount.

Section 2. The Chairman, Secretary and the other officers and representatives of the PBC and the City are hereby authorized and directed to take such other action as may be necessary to carry out the redemption and payment of the Series 2019 Bonds.

Section 3. This Resolution shall be effective from and after its adoption.
