  - The Wastewater Treatment Plant project still making progress with competition possible by mid-July.
  - The original quote has gone up to clean out both digesters as they ran into a lot of issues while cleaning them out.
  - The bridge is still waiting on materials.
  - Water well No. 3 had be shut down and repaired recently by staff and there are a few other wells that need cleaning
  - Public Wi-Fi will still be a future conversation with the commission.
  - Wastewater Fund will look low as we have been pending reimbursement form the Wastewater Treatment Loan and has been turned into CDBG.

The City of Arkansas City will hold a public hearing at 5:30 p.m. Thursday, April 6, 2023, in the Commission Room at City Hall, located at 118 W. Central Ave., Arkansas City, KS, 67005, for the purpose of considering an application to be submitted to the Kansas Department of Commerce for Small Cities Community Development Block Grant (CDBG) funds under the Community Facilities category Sidewalks and Trails. A specific project application to be discussed is the construction of extending the existing central trail system utilizing the abandoned St. Louis & San Francisco railroad line and existing 6<sup>th</sup> Street right-of-way and City owned property. The project description is as follows: from the south terminus (Chestnut Avenue) to Walnut Avenue on the east side of 6<sup>th</sup> Street; from Walnut Avenue to Maple Avenue would run in the central median of 6<sup>th</sup> Street; from Maple Avenue to Birch Avenue on the east side of 6<sup>th</sup> Street to the Norwest Community Center.

The work will consist of 1 LS right-of-way clear and restore, 2,320 LF 10' wide trail (6' concrete pavement), 2,578 SY aggregate base (5"), 1 LS grading, 11 EA sidewalk ramps, 30 EA signage, 2 EA collapsible bollards, 8 EA permanent bollards and 1 LS traffic control.

The \$338,924 project will be funded through local funds with the assistance of a \$254,193 CDBG grant request. Other project proposals introduced at the hearing also will be considered. Oral and written comments will be recorded and become a part of the City of Arkansas City's CDBG Citizen Participation Plan.

#### ORDINANCE NO. 2023-04-

# AN ORDINANCE FIXING THE COMPENSATION OF EMPLOYEES OF THE CITY OF ARKANSAS CITY, KANSAS, PURSUANT TO THE PROVISION OF K.S.A. 14-1501 *ET SEQ.*, AND REPEALING ORDINANCE NO. 2023-02-4573.

#### BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ARKANSAS, KANSAS, AS FOLLOWS:

**SECTION ONE:** The Governing Body of the City of Arkansas City, Kansas, hereby adopts the City Master Wage Plan, attached hereto, and incorporated by reference as if fully set forth herein. All such officers and employees of said City shall be paid respectively the amount set opposite the range set forth, in accordance with the City Budget for such purposes. All officers and employees shall be compensated from the several funds appropriated therefore, and shall be paid at such time and for such periods as the City Manager may direct, and further approval by the Governing Body for the payment of salaries and wages as authorized is not deemed necessary provided that pay period and time for payment of appropriate salaries shall be on a biweekly basis.

**SECTION TWO:** Overtime rate, longevity pay, and other pay incentives for employees shall be determined and specified in accordance with personnel policies in effect, and herein adopted by reference and incorporated as fully set forth herein. All compensation provided for in the City of Arkansas City Master Wage Plan shall be paid on warrants duly drawn according to law.

**SECTION THREE:** The Governing Body of the City of Arkansas City, Kansas, hereby repeals all provisions of Ordinance No. 2023-02-4573.

**SECTION FOUR:** The City Clerk of the City of Arkansas City, Kansas, shall cause this Ordinance, or a summary thereof, to be published one time in the official City newspaper and said Ordinance shall be in effect April 8, 2023.
