Item: Recognize and Honor Outstanding Student Award Winners

Purpose:

Recognize and congratulate Gabriella Herrera and Trevor McDowell, Arkansas City's Outstanding Student Award scholarship recipients for 2019-2020.

Recognize and congratulate Audrianna Bruce, Eleana Messenger and Dawson O'Donnell, Arkansas City's Outstanding Student Award scholarship recipients for 2020-2021.

Background:

The Outstanding Student Award program was started in 1984. The City Commission implemented the program to recognize students who are outstanding examples of academic and civic excellence in our community. Each year, staff asks teachers, staff, and administrators at Arkansas City Middle School, Arkansas City High School and Cowley College to nominate students they think are qualified for this honor.

Each year, the Outstanding Student Award Committee, appointed by the Mayor and City Commission, receives all nominations from the three schools. Short, informal interviews are conducted with each nominee, and the committee then chooses three finalists from each school to represent the nominees.

From the nine (9) finalists, a top student is chosen for each school. One (1) of them is chosen to represent the City of Arkansas City as the Outstanding Student for that year and to receive a \$1,000 scholarship. The first runner-up now receives a \$500 scholarship and the second runner-up receives a \$250 scholarship.

Last year's overall Outstanding Student (awarded retroactively) is Cowley College student **Trevor McDowell** and the first runner-up is Arkansas City High School senior **Gabriella Herrera**. (NOTE: There were no Arkansas City Middle School nominees interviewed for the 2019-2020 school year.)

This year's overall Outstanding Student for Arkansas City is Cowley College student **Audrianna Bruce**. The first runner-up is Arkansas City High School senior **Eleana Messenger**, while the second runner-up is Arkansas City Middle School eighth-grader **Dawson O'Donnell**.

The Arkansas City Board of City Commissioners met in regular session at **5:30 p.m. Tuesday, April 6, 2021**, in the Commission Room at City Hall, located at 118 W. Central Ave. in Ark City.

Mayor **Scott Rogers** called the meeting to order. Commissioners also present at roll call were Commissioners **Kanyon Gingher**, **Duane L. Oestmann**, **Jay Warren** and **Karen Welch**.

City employees present at the meeting were City Manager Randy Frazer, City Attorney Larry Schwartz, City Clerk Lesley Shook, Deputy City Clerk Amanda Evinger, Public Information Officer Andrew Lawson, Management Assistant Mike Crandall and Building Official Mike Bellis.

Arkansas City Police Department personnel in attendance were Interim Police Chief **Eric Burr**, Master Police Officer **Kelsey Horinek**, Police Officers **Rick Bennett** and **Jeff Wilson**, Public Service Officer **Eric Gross**, and Administrative Assistant **Jeni McGee**.

Citizens in attendance or observing via GoToMeeting were **Paisley Howerton**, **Diane Sparks**, **Roger Sparks**, **Harrison Taylor** and Cowley CourierTraveler reporter **John Shelman**.

Commissioner Warren offered the opening prayer. Mayor Rogers led the Pledge of Allegiance.

Agenda Approval

At City Manager Frazer's request, Commissioner Welch made a motion to amend the agenda by adding the swearing in two new police officers as **Item 1** under **Recognition of Visitors** and a resolution scheduling a special study session on **April 23** as **Item 2** under **Other Business**.

Commissioner Oestmann seconded the motion. A voice vote was unanimous in favor of the motion. Mayor Rogers declared the agenda **amended** as requested. Commissioner Oestmann then made a motion to approve the agenda as amended. Commissioner Welch seconded the motion. A voice vote was **unanimous** in favor. Mayor Rogers declared the agenda **approved** as amended.

Recognition of Visitors

Police Chief Burr introduced the newest members of the Arkansas City Police Department, **Rick Bennett** and **Jeff Wilson**, who then were administered their Oaths of Office by City Clerk Shook.

Awards and Proclamations

Mayor Rogers issued a proclamation that April 6, 2021 is Mayor's Monarch Pledge Day and April 5-9, 2021, is National Wildlife Week in Arkansas City. Paisley Howerton (participating remotely) received a copy of the proclamation on behalf of the Beautification and Tree Advisory Board.

Consent Agenda

Commissioner Oestmann made a motion to approve the consent agenda, consisting of:

- 1. Approving the **March 16, 2021**, regular meeting minutes as amended.
- 2. Approving **Resolution No. 2021-04-3394**, relocating a public meeting of the Governing Body at **noon Friday, April 16, 2021**, from the city manager's office at City Hall, 118 W. Central Ave., to the conference room at the Water Treatment Facility, 400 W. Madison Ave.

Commissioner Warren seconded the motion. A voice vote was unanimous in favor of the motion.

Mayor Rogers declared the consent agenda **approved** as presented.

New Business

City Insurance Renewal

Deputy City Clerk Evinger presented for discussion renewal of City insurance coverage for property, liability, vehicles, and equipment with EMC Insurance Companies and United Agency, Inc., for a total amount not to exceed \$288,387.00.

The City received a quote for comprehensive insurance coverage — excluding workers compensation insurance, which is provided by Kansas Municipal Insurance Trust — for the period of **April 1, 2021**, through **March 31, 2022**.

City Manager Frazer said the cost is up a little due mainly to some lawsuits that are being handled.

Commissioner Oestmann made a motion to approve EMC's proposed insurance coverage renewal.

Commissioner Welch seconded the motion. A voice vote was unanimous in favor of the motion.

Mayor Rogers declared the motion approved.

<u>Tennis Interlocal Ordinance</u> Ordinance No. 2021-04-4530

Deputy City Clerk Evinger presented for discussion the first reading of an ordinance authorizing the City — in conjunction with **USD 470**, **Cowley County Community College**, the **Arkansas City Recreation Commission** and the **Arkansas City Tennis Association** — to enter into an Interlocal Cooperation Agreement for the use and maintenance of **tennis courts** throughout Arkansas City.

City Manager Frazer said all of the other parties already have approved and signed the agreement.

He said the City owns the Agri-Business Building and two outdoor tennis courts, while USD 470 owns 10 outdoor tennis courts. The agreement creates a formal structure for the use of the indoor tennis courts, as well as funds the regular maintenance and renovation of both the indoor tennis courts and all outdoor tennis courts. Frazer gave an overview of how the maintenance fund works.

Mayor Rogers made a motion to approve the ordinance as presented. Commissioner Gingher seconded the motion. A roll call vote was **unanimous** in favor of the motion. Mayor Rogers declared the ordinance **approved** and given **Ordinance No. 2021-04-4530**.

Wilson Park Farm/Art Market Resolution No. 2021-04-3395

Deputy City Clerk Evinger presented for discussion a resolution authorizing the City to accept a proposal from Recreation Resource, Inc., of Overland Park, to purchase a Poligon multi-rib pavilion for the **Arkansas City Farm and Art Market** as part of the Wilson Park Phase 1 Upgrades Project, for an amount not to exceed **\$169,470.00**.

City Manager Frazer said the City received a quote on **February 9** for a Poligon multi-rib pavilion that would be shipped in pieces and assembled on site by a contractor to form the new Arkansas City Farm and Art Market structure, south of the Wilson Park rotunda in the new parking lot.

Staff explored possible cost-cutting options, including shortening the building by 20 feet and adding guttering, but due to rapidly rising steel prices, these actually *increased* the building's cost. Thus, staff recommends accepting the original quote of **\$169,470.00**, which will expire on **April 10**.

The plans for the pavilion, parking lot and electrical improvements have been presented to the Cowley County Farm and Art Market board, which offered its enthusiastic support of this project.

Public Information Officer Lawson said the Arkansas City Farm and Art Market plans to begin its 2021 season in the park on **June 1**. Staff hopes for substantial completion by that date. Following the purchase of the pavilion, the City's next step will be to advertise a bid package for construction.

Commissioner Oestmann made a motion to approve the resolution as presented. Commissioner Warren seconded the motion. A voice vote was **unanimous** in favor of the motion. Mayor Rogers declared the resolution **approved** and given **Resolution No. 2021-04-3395**.

Budgeted Pay Plan for 2021 Ordinance No. 2021-04-4531

Deputy City Clerk Evinger presented for discussion a first reading of an ordinance adopting the budgeted pay plan for **2021** and repealing **Ordinance No. 2020-10-4519**.

City Manager Frazer explained that, due to the recent restructuring of the Human Resources Division, the pay ordinance needs to be amended to add a "Human Resource Analyst" to Range 31.

Commissioner Warren made a motion to approve the ordinance as presented. Commissioner Oestmann seconded the motion. A roll call vote was **unanimous** in favor of the motion. Mayor Rogers declared the ordinance **approved** and given **Ordinance No. 2021-04-4531**.

Strother Field Grant Authority Resolution No. 2021-04-3396

Deputy City Clerk Evinger presented for discussion a resolution authorizing and directing the Manager of Strother Field Airport/Industrial Park to execute Airport Improvement Plan grant documents and other instruments thereto on behalf of the City of Arkansas City and the City of Winfield, as the participants in an interlocal agreement for the management and operation of the Strother Field Airport/Industrial Park, by the power vested in it by Article 12, Section 5 of the Constitution of the State of Kansas.

Commissioner Warren made a motion to approve the resolution as presented. Commissioner Gingher seconded the motion. A voice vote was **unanimous** in favor of the motion. Mayor Rogers declared the resolution **approved** and given **Resolution No. 2021-04-3396**.

City Manager Updates

City Manager Frazer provided the commissioners with the following reminders and updates:

- Copies of the **Police Department's annual report** were passed out to all commissioners.
- The next quarterly Traffic Safety Committee meeting is at **10 a.m. April 9** at the Water Treatment Facility, located at 400 W. Madison Ave. Face coverings will be required.
- City Manager Frazer and City staff will give a presentation about housing and the Housing Assessment Tool (HAT) at the Arkansas City Rotary Club meeting at **noon April 12**.
- The next RISE Cowley health coalition meeting will be at **10 a.m. April 13** via Zoom. (This is a quarterly coalition meeting that is open to all Pathways to a Healthy Kansas partners.)
- The Cowley County Legislative Committee will sponsor a legislative forum with legislators at **6 p.m. April 13** at the Baden Square Community Center, 700 Gary St., in Winfield.
- The next City Commission study session will be the budget retreat from **noon to 2 p.m. April**16 in the conference room at the Water Treatment Facility, 400 W. Madison Ave. Topics of discussion include the 2022 budget and 2022-2031 Capital Improvement Plan (CIP).
- Registration for the first-ever SCKMC Healing Hands Golf Tournament will begin at **8 a.m. April 17** at Great Life Golf & Fitness, located east of Arkansas City at 8731 U.S. 166.
- The annual Cowley County Bridal Fair will return from 10 a.m. to 2 p.m. April 18 at its new location at Burford Theatre Arts, located at 118 S. Summit St. in downtown Arkansas City.

Frazer said construction has begun on the **Hillside Addition** piece of the water line replacement project. He also provided updates on the **downtown alley project** and **Paris Park Pool evaluation**.

Mayor Rogers presented for discussion a resolution scheduling a public meeting of the Governing Body at **noon Friday, April 23, 2021**, in the city manager's office at City Hall, 118 W. Central Ave., Arkansas City, Kansas, for a special study session to discuss fleet management services.

Mayor Rogers made a motion to approve the resolution as presented. Commissioner Gingher seconded the motion. A voice vote was **unanimous** in favor of the motion. Mayor Rogers declared the resolution **approved** and given **Resolution No. 2021-04-3397**.

Comments from the Audience

Roger Sparks, 6679 Harding Ave., addressed the commissioners regarding his concerns about the appearance of downtown Arkansas City, street sweeping and the repair of trash receptacles. He also thanked the commissioners for staying on top of the downtown alley project's progress.

A RESOLUTION RELOCATING A PUBLIC MEETING OF THE GOVERNING BODY AT NOON FRIDAY, APRIL 30, 2021, FROM THE CITY MANAGER'S OFFICE AT CITY HALL, LOCATED AT 118 W. CENTRAL AVE., TO THE CONFERENCE ROOM AT THE WATER TREATMENT FACILITY, LOCATED AT 400 W. MADISON AVE., ARKANSAS CITY, KANSAS.

WHEREAS, the Governing Body of the City of Arkansas City, Kansas, on May 3, 2011, approved Resolution No. 2011-05-2701, scheduling regular study sessions at noon on the Fridays immediately preceding its regular meetings; and

WHEREAS, the Governing Body of the City of Arkansas City, Kansas, on January 15, 2019, approved Resolution No. 2019-01-3231, resuming the practice of having regular study sessions at noon on Fridays preceding its regular meetings; and

Purpose:

Consideration for the City of Arkansas City to purchase a 5-ton, 6x6 military vehicle, a water tank, paint, and miscellaneous equipment needed to transform the vehicle so that it can be used to fight grass fires. This vehicle would replace a 2019 Ford E450 that we have had several issues with. Some of these issues include, problems navigating in fields when conditions are even slightly wet and the front end has had a shimmy in it ever since it was new. We replaced the tires with a mud grip, higher grade tire, hoping to eliminate both of these problems. After making these changes, we have noticed some improvements but the front end is still presenting with a shimmy. Last year we had to replace the front end. Due to the modifications previously made on the front end, the front end replacement was not under warranty. The repairs mentioned above have cost the Department a total of \$7,630. 89.

Background:

We are currently looking for a vehicle that matches the description above. The closest location we have found, that has this type of vehicle, is at Midwest Military Equipment in Washington, Missouri. We have found that once they get this particular vehicle in stock it sells rather quickly. Therefore, we would like approval to proceed with the purchase of said vehicle when one becomes available. After receiving approval we will inspect the vehicle before the purchase is finalized. Other locations that we have found similar vehicles include, Oshkosh, Wisconsin; Owatonna, Minnesota; and Ogden, Utah.

City Manager's Report on Upcoming Activities

Background:

- 1. The monthly **Cowley Indoor Market** will move to its new location at the Burford Theatre for its first event of 2021 from **5 to 8 p.m. Wednesday, April 21**. These events generally will be held on the third Wednesday of each month at Burford Theatre Arts, located at **118** S. Summit St. in downtown Ark City.
- 2. On Earth Day, the City will have an "early Arbor Day" **tree planting** at **4 p.m. Thursday, April 22** in Lovie Watson Park, located at 614 W. Birch Ave., prior to the regular Beautification and Tree Advisory Board meeting. Commissioners are invited to come for a photo opportunity!
- 3. The next **City Commission** study session will be at **noon Friday**, **April 23** here at City Hall. Topics of discussion will include fleet management. There also will be a study session at **noon Friday**, **April 30** at the Water Treatment Facility, 400 W. Madison Ave., to discuss the Housing Assessment Tool (HAT).
- 4. **Spring Cleanup Day** is from **8 a.m. to noon Saturday, April 24**, weather permitting. Volunteer groups will register with the City and be assigned to locations. **31**st **Century Techsupport** will offer e-waste recycling services (*again, weather permitting*) from **8 a.m. to noon** that day at Wilson Park.
- 5. The **Arkansas City Train Show** will return to the Agri-Business Building from **9 a.m. to 4 p.m. Saturday, April 24**. This tourism-boosting event was not able to be held in 2020 due to the COVID-19 pandemic.
- 6. Citywide Pickup Week is scheduled for April 26-30, coinciding with your regular trash pickup day.
- 7. The City is scheduled to launch its **new Municode-based website** on or about **April 27-28**. A specially designed **Police Department** subsection and a new website for **Visit Ark City** will follow later in **May**.
- 8. The Cowley County Health & Safety Fair returns to Arkansas City from 9 a.m. to noon Saturday, May 1 at the Agri-Business Building. This event also had to be canceled in 2020 due to the COVID-19 pandemic.

Arkansas City Traffic Safety Committee 1/8/21 Minutes

A regular meeting was held Friday, January 8, 2021, via GoToMeeting due to a pandemic. The meeting was called to order at 10 a.m.

Others in attendance were Ken Harader, David Kerwood, Tyrone Sharp, Harrison Taylor and Commissioner Duane Oestmann.

1. Approve October Meeting Minutes:

Karen made a motion to approve the minutes of the October 9, 2020, regular meeting. Rags seconded the motion, which was approved 10-0 on a voice vote. (NOTE: Tony joined the meeting in progress at 10:04 a.m. and Jeri joined it at 10:06 a.m.)

2. ACPD Quarterly Traffic Safety Report:

Dan said there was a sustained 9-percent decrease in non-injury accidents in the fourth quarter of 2020, still somewhat attributable to the ongoing coronavirus (COVID-19) pandemic, while injury accidents stayed low at about two per month.

There were 23 non-injury accidents and eight injury accidents just in September, the highest month of the year in both areas, but this decreased in subsequent months just as Capt. Eric Burr had predicted during the October meeting that it would.

Dan noted that the cancellations of both Arkalalah and the Last Run Car Show probably a large impact on crash reduction.

He said a "hot spot" migrated back south to the downtown area, with smaller ones on East Kansas and north of Radio Lane.

In 2020, the prime time for accidents was from 3 to 6 p.m. on Wednesdays and Thursdays, and on afternoons more generally.

3. Four-Way Stops on Numbered Streets:

Fourth Street residents Tyrone Sharp and David Kerwood spoke up about their concerns with vehicle traffic on that street.

Harrison Taylor, 525 N. Fourth St., also reiterated his concerns about traffic and speeding on Fourth Street and side roads.

Mr. Sharp said people are running stop signs at Cedar and Vine avenues where they cross Fourth Street. Dan said he will check into that, but due to the pandemic, the police department has not been able to complete its planned traffic studies there.

Andrew said citizen engagement is needed in the development of the Master Transportation Plan. Mike said the Kansas Department of Transportation recommended that the Kansas Legislature reduce residential speed limits from 30 to 20 mph.

He suggested staff could compile a map showing the current stop sign locations and seeing if they line up with yield patterns.

Mike and Dan discussed a couple of possible solutions involving various traffic calming devices they've seen in other cities.

Mike asked Dennis if the college could teach students about residential speed limits during orientation. He said they could.

4. Eighth Street / Truck Route Signage:

Mike reviewed the new "Thru Truck Route" signs the Public Services Department created. Dan said there still are problems, but the police department is also running at minimum staffing, which is reducing its ability to focus on traffic enforcement. He said he will try to gather some more data related to this prior to the next quarterly Traffic Safety Committee meeting.

5. Goff Industrial Park Parking:

Mike asked Josh if there are any updates on the new Creekstone parking lots. He still hasn't heard anything still working on construction. ACPD still hasn't received any new parking complaints, so the new signs might be working.

6. Street Projects (N. Summit / S. Summit / W. Madison):

Mike said the City applied for \$455,000 in Community Development Block Grant funding for the North Summit Street resurfacing project and should hear about that later in **January**. However, the City did not receive Cost Share funding. This work includes new concrete intersection approaches and filling in existing gaps in the east-side sidewalk by early 2022.

Andrew said there will be another opportunity to apply for Cost Share in the spring and the top feedback item the City received from the Kansas Department of Transportation is to gather letters of support, so he asked for partners' help on this.

Mike said the City also received a CCLIP grant to mill and overlay West Madison Avenue/U.S. 166 from Eighth Street to Summit Street later this year. That program was used recently to resurface South Summit Street from Madison to U.S. 77.

7. Trails (Hike-Bike Phase 2 / Central Trail / Poplar Trail):

Mike said KDOT will let the Phase 2 contract in August. The Hike-Bike Trail (Phase 2) Extension Project will be designed with a Fifth Avenue crossing that could be removed later, as well as crossings on Washington, Madison and South Summit.

Andrew said TA funding is unknown for the Central Trail project and a Recreational Trails presentation will be in **February**.

He said installation of the 25 StoryWalk signs and 12 light poles at the Poplar Walking Trail should be done in a month or so.

8. Transportation Master Plan RFP:

Andrew said the City received no responses to the RFP, either because firms are too busy, lost personnel or didn't have time.

Blue Cross Blue Shield said the City could extend its deadline by six months and the City Commission passed a resolution to do so. The consultant now has to be hired by **June 15**. Andrew said he hopes to have it started in the next couple of months.

He showed the committee members the original RFP in the packet and asked for any comments on it to be sent to him ASAP.

9. Other Miscellaneous Items:

Mike gave an overview of street sign replacements by the Public Services Department in the fourth quarter of 2020. School zone signs were repaired in the 1300 block of North D Street and at the intersection of B Street and Washington Avenue, as well as at Chestnut Avenue's intersections with A, C and D streets. A 35 mph sign was repaired on Kansas Avenue, as were stop signs at Eastridge and Centennial and at Jackson and Summit, plus a "School Crossing Ahead" sign on Radio Lane.

Mike said the City received a grant through the Local Bridge Improvement Program to replace the North 15th Street Bridge.

Andrew said RISE Cowley can bring another \$400,000 into Cowley County over the next four years through Phase 2 of the Pathways to a Healthy Kansas grant program. He has been replaced on the steering committee by ACRC's Debbi Davidson.

Dan said the City's highest non-injury accident rate on record was 20.56 crashes per 1,000, but this has been reduced over the past seven years to just 14.96 per 1,000 in 2020, which is a **27-percent reduction** in non-injury accidents. For injury accidents, it is down from a high of 5.56 per 1,000 to 3.36 per 1,000, which is a **39.5-percent reduction** in injury accidents.

Dennis left the meeting in progress at 10:53 a.m.

Andrew made a motion to adjourn the meeting. Dan seconded the motion to adjourn. The motion was approved 11-0 on a voice vote. The meeting was adjourned at 11:04 a.m. The next meeting of the Traffic Safety Committee will be at 10 a.m. Friday, April 9, 2021.

<u>Liz Shepard</u> called the meeting to order. Arty Hicks later joined the meeting in progress.

Minutes from January 14 Meeting

Minutes of the previous meeting were reviewed. Dena Ward moved to accept the minutes. It was seconded by Carlla Pike. A unanimous voice vote declared the **minutes accepted**.

Treasurer's Report

Pam Crain presented the financials and monthly expenses. Pam reported normal operating expenses. The transient guest tax from the City should arrive in the next few days. The amount is around \$19,000. Carlla Pike moved to accept the report as presented. Shawn Silliman seconded, and a unanimous voice vote declared the **motion approved**.

Old Business

Quail Valley Farms Funding Request

Pam Crain reported the Quail Valley Farms Disc Golf Tournament will not take place in Arkansas City due to a lack of sponsors. The \$1,000.00 sponsorship from VAC will be returned. Pam requested the refunded money from Quail Valley be used to support the Burford Theatre. Carlla Pike moved that the \$1,000 sponsorship for Quail Valley Farms be reallocated to the Burford. Julianna Barrigan seconded, and a unanimous voice vote declared the **motion approved**.

Awning Update

Pam Crain reported when the Chamber of Commerce awning collapsed, damage to the building occurred and it required some brick repair. Once the repairs are complete and the temperatures warm up, the new awning will be installed.

New Business

Board Position Open

Dena Ward will resign from the VAC Board on March 1. Shannon Martin will fill the position.

Last Run Car Show Support

Pam Crain reported the Mid-America Dragway is planning to hold a car show on the same day as the Tumbleweeds. The Tumbleweeds have requested an additional \$500.00 of support for 2021, for a total of \$1,000.00. The VAC Board discussed the proposal. It was determined that Pam Crain will contact both the Tumbleweeds and Mid-America Dragway, and report back to the VAC Board. The request was tabled until the next meeting (*no March meeting due to no quorum*).

Burford Theatre

Pam Crain mentioned volunteer opportunities in the "Green Room" of the Burford Theatre.

She noted that with housing, you need to focus on needs not wants and not to just use programs as a wish list. Housing studies can tell you exactly what you need. Frazer noted that we were working on the Housing Assessment Tool as part of our application for CDBG Housing funding. After discussion wrapped on housing, White shifted the focus to Economic Development. He did a brief overview on economic development efforts in the City. Falletti also briefly talked about the state of economic development and helped to answer questions. He also talked about income and poverty and how that can affect the workforce. Wood talked about some of the work done on homelessness and dealing with poverty in the county. Jennings noted an organization he works with had served the homeless during the recent cold by provided 80 hotel room nights. Planning Commissioners were surprised to learn how many people were experiencing homelessness. Planning Commissioners had general discussion of economic development. He stated that the next meeting would focus on past surveys and possible goals.

4. Other Items:

Lawson and White discussed the recent FlashVote results regarding Quality of Life in the Community. Planning Commissioners discussed the results. Howerton noted that it seems interesting that people want more businesses but don't always seem to want to support the local businesses. Staff said we could fold that topic into a future survey.
