

TOWN OF ASHLAND CITY Regularly Scheduled City Council Meeting October 14, 2025, 6:00 PM Minutes

CALL TO ORDER

PLEDGE AND PRAYER

Prayer was delivered by Pastor James Walsh from Hope Worship Center
Mayor Greer added that Pastor Walsh also serves with the Cheatham County Sherriff's
Department as a Deputy.

PUBLIC HEARING

2. ORDINANCE 634: 111 Boyd Street

Mayor Greer announced that this item was being pulled from the agenda per the developer's request. There were people that wanted to speak during the public hearing and filled out the public speaking form.

Cory Hastings – Neighbors near 111 Boyd Street are concerned about how the development process has been handled. We're not opposed to building on the property, but we were only notified of the city council meeting and first reading on the afternoon of the vote.

I live on Fairview Circle, within 1,000 feet of the site, and received no notice from the developer. The property also served as a seasonal resting area for federally protected black vultures, which was not considered before the developer cleared nearly all the trees—despite approval to remove only some.

Amanda Stanley – I live across from the 111 Boyd Street property and ask the city council to vote no on the rezone. I was never notified by the developer about plans to build additional homes; a sign only appeared just before the first council meeting.

Since the trees were cleared, 20–30 black vultures have lost their habitat and are now causing problems in our neighborhood.

Please vote no on the rezone.

Tom Morris – 103 Boyd Street homeowner. The erosion control measures at the 111 Boyd Street development site have deteriorated and are no longer effective. I respectfully request that the Codes Department require the developer to reinstall and maintain proper erosion control fencing to prevent further sediment runoff into the creek.

Nancy Charlie Springer – I am strongly opposed to this zoning change. Our neighborhood already faces heavy traffic, with vehicles frequently speeding through the area. Most homes have at least two vehicles, and adding more houses will only worsen congestion and parking issues—turning our streets into a parking lot. There are also fewer homes with yards where children can play safely. I'm deeply concerned that it will take a serious accident or tragedy before the traffic problem is truly addressed.

Kara Hastings – I took the initiative to send out 54 letters to nearby residents because the developer never notified us about the plans for 111 Boyd Street. I also brought a map of the property to show the steep grade of the land, especially toward the creek at the back of the lot. This property cannot be fairly compared to other sites that have been zoned R-4 PUD because of its significant slope. Nearly half of the 2.4-acre parcel is too steep to build on effectively. This is a clear example of why each development request should be evaluated on its own merits—approving one project in the past should not automatically justify approval of another when the conditions are so different.

Jerry Sharp – Traffic at Boyd and Main Streets around 3 p.m. already makes it difficult for us to leave the neighborhood, and speeding is a constant issue. Adding more homes will only increase traffic and make the area less safe for children.

Lisa Sharp – I have lived on Fairview Circle for 45 years, and it has become increasingly dangerous. Drivers regularly exceed the speed limit, and many treat stop signs as yield signs. Children walking to Ashland City Elementary or catching the bus to Cheatham Middle School face serious safety risks crossing the street. We depend on the city council to make responsible decisions

Alyssa Bebe— I've lived in Ashland City for 2½ years. We chose this area to be close to the city but still enjoy a country feel. I have two small children and two more on the way and speeding on Boyd Street is already a major concern. This development would only make things worse, so I'm glad it was pulled.

Mr. Nicholson noted that a budget amendment in the amount of \$80,000 (eighty thousand dollars), as previously discussed by Kellie Reed, will be necessary to proceed.

- 20. CONTRACT QUOTE John's Park The Council previously allocated \$200,000 for upgrades to the existing parks. This project includes a drainage analysis, site survey, and sidewalk design to ensure ADA compliance. The current item pertains to the engineering portion of the project. CLARIFICATION: Councilman Young inquired about the possibility of constructing a senior center at that location and asked if a construction date had been established. Mayor responded that discussion regarding a senior center cannot take place until the ballpark project is fully completed and operational. The mayor further noted that the development of the sports park and senior center is expected to occur several years in the future, as the City must first achieve improved financial stability before pursuing those projects.

22. Financial Report – Will Duffel, Finance Director:

Mr. Duffel reported that the City has entered property tax season, with tax bills mailed earlier this month. Property taxes will be due in February. He noted that revenue is currently light but is expected to increase in the coming months. Mr. Duffel reviewed the current revenue figures and advised that a few departments are over budget in certain line items, which may be due to a combination of factors or possible miscoding of expenses.
