A motion was made by Councilman Smith, Seconded by Councilman Thompson, to open the floor. **Motion Passes.**

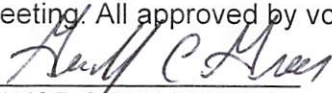

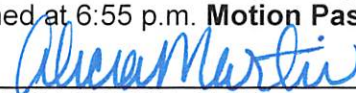
A motion was made by Councilman Thompson, Seconded by Councilwoman Binkley, to close the floor. **Motion Passes.**
