Call to Order	Michael Smith called the meeting to order at 6:01 pm

Approval of agenda	Matt Waldron made a motion to approve, Brandy King seconded motion, approved by all
Approval of minutes	Sammy Naquin made a motion to approve, Brandy King seconded motion, approved by all

Caldwell Park	Michael Smith reported he would like the board to get a plan started on getting Caldwell Park setup with water, electricity and paved parking. He said he would look into seeing how Private Foundations can partner with the city so we can get funding for the park.
