Barney Arntz – I am here to speak about speed bumps. I have lived on Stratton Blvd for 40 years now and have seen it change quite a bit. It seems that 30 MPH has now turned into a Highway speed than a residential speed. People are using it as a cross-through for instances like Skyview. They are going from Highway 12 midtown to Highway 49 or through the fairgrounds to beat the traffic. Stratton Blvd has a lot of children on this street particularly coming out of the white apartments. They walk to the bus in the morning, and they must walk in the street or someone's yard to get to the bus. Then in the afternoon they walk home. Some people using Stratton are respectful and slow down, but others do not. The Police Department has attempted to try to slow them down. The problem is they cannot be there 100% of the time. The next best thing I have seen them work in Nashville is speed bumps. They will launch you and will destroy a car if you hit them too fast. What I request is that you take a hard look at Stratton and see if we can do something about it.
