A motion was made by Councilman Greer, seconded by Councilman Kerrigan, to approve the agenda. All approved by voice vote.

 A motion was made by Councilman Kerrigan, seconded by Councilman Adkins, to approve the

PUBLIC FORUM

Mr. Kevin Thompson & Mrs. Andi Thompson - Mr. Thompson stated that he lived at 279 Frey Street and he was there to speak on behalf of the zoning violation they received. He stated that they went and got a permit and they were told there was nothing else they needed to do. Mr. Thompson presented a packet to the council with a petition and stated that they pay their taxes. Ms. Noe recommended that they go to the Planning Commission and appeal. A motion was made by Councilman Adkins, seconded by Councilman Greer, to pass this to the Planning Commission. All approved by voice vote.

Ms. Jane Crisp - Ms. Crisp stated that she was there to speak about the proposal for Caldwell Park. She stated that she lived at the Braxton and owns commercial property on Main Street. She presented the council with a copy of the proposal and stated that Mr. Josh Wright is in attendance to answer questions.

Councilman Jackson came in at this time.

Mr. Roger Marriott - Mr. Marriott stated that he was there to speak about Caldwell Park. He stated that he has lived here for 8 years and moved here from Williamson County. He stated that he was in support of Ms. Crisps' proposal.

Ms. Della Smith - Ms. Smith state that she was there to speak about Caldwell Park. She stated that she was in support of Ms. Crisps' proposal. Ms. Smith asked what the City planned to do with the park if they did not accept it. She stated that she hoped they would make it safe and keep it wild.

Mr. Jeremy Lecich - Mr. Lecich stated that if they did not vote to accept the proposal, that they provide an explanation and good reason as to why not. He stated that they have spent a lot of time on this and they did not want to spend more time if it was not going to pass.

Mike Russell - Mr. Russell stated that he was the Solid Waste Director and he was there to ask if the City could post about the free dump day on the website. He stated that there would be a day for each part of the county to come and dump for free. He stated they would also have a day to dump chemicals, gas, etc. for free. Mayor Allen asked him to see Ms. Bowman after the meeting. **REPORTS**

Ms. Jennifer Noe stated that everything she had to report was already on the agenda.

OLD BUSINESS

- 3. Comprehensive Plan with Josh Wright
 - Mr. Josh Wright stated that the first meeting of the Comprehensive Plan was the next evening and that they would meet there at the Senior Center to kick off the tour. Mayor Allen stated that with that, there needed to be a decision made on Caldwell Park. He stated that no matter what, the City was keeping the park and had the money to make the improvements as part of the Comprehensive Plan. Councilman Greer stated that the time had come to take the money in exchange for naming the park after Ms. Crisps' late husband. He thanks everyone for their time and efforts. Councilman Jackson stated that he did not agree with the statue. Councilman Adkins stated that he had concerns regarding the conservation easement. Ms. Bowman stated that we are a financially stable city and we do not need to take the money to make improvements to the park. Ms. Noe stated that there needed to be a clear time period on the conservation easement when the motion was made. Ms. Crisp stated she would like ninetynine (99) years. A motion was made by Councilman Greer, Seconded by Councilman Smith, to accept the proposal in its entirety with a guaranteed length of ninety-nine (99) years. Voting Yea: Councilman Greer. Voting Nay: Councilman Adkins, Councilman Jackson, Councilman Kerrigan, Councilman Smith. Voting Abstaining: Mayor Allen. Mayor Allen stated that it failed. Councilman Adkins asked if it would still be part of the comprehensive plan. Mayor Allen stated that it would. Councilman Greer asked if we would continue with the pavilion. Mr. Wright stated that we would.
- 4. Ordinance: Amending Ord #551 (2018 Standard Codes)
 AN ORDINANCE BY THE TOWN OF ASHLAND CITY, TENNESSEE AMENDING
 ORDINANCE #551 TITLE 12, CHAPTER 1, SECTION 12-101. Mayor Allen stated this was the second and final reading. A motion was made by Councilman Jackson, seconded by Councilman Greer, to approve the amendment. Voting Yea: Mayor Allen, Councilman Adkins, Councilman Greer, Councilman Jackson, Councilman Kerrigan, Councilman Smith.
- 5. Ordinance Franchise Agreement: CEMC
 AN ORDINANCE GRANTING TO GRANTEE, THE NON-EXCLUSIVE RIGHT TO ERECT,
 MAINTAIN AND OPERATE IN, UNDER, OVER, ALONG, ACROSS THE STREETS, LANES,
 AVENUES, SIDEWALKS, ALLEYS, BRIDGES, HIGHWAYS, AND EASEMENTS DEDICATED
 FOR COMPATIBLE USES AND OTHER PUBLIC PLACES IN THE TOWN OF ASHLAND
 CITY, TENNESSEE, AND THE SUBSEQUENT ADDITIONS THERETO, TOWERS, FIBERS,
 CABLES AND ANCILLARY FACILITIES FOR THE PURPOSE OF CONSTRUCTING,
 OPERATING, MAINTAINING AND REPAIRING A CABLE SYSTEM, AS DEFINED HEREIN,
 FOR A PERIOD OF TEN (10) YEARS, REGULATING THE SAME AND PROVIDING
 COMPENSATION TO THE CITY. Mayor Allen stated this was the second and final reading. A
 motion was made by Councilman Kerrigan, seconded by Councilman Jackson to approve the
 Ordinance. Voting Yea: Mayor Allen, Councilman Adkins, Councilman Greer, Councilman
 Kerrigan, Councilman Smith. Voting Nay: Councilman Jackson.

NEW BUSINESS

- 6. New FT Fire Position
 A motion was made by Councilman Jackson, seconded by Councilman Greer, to approve a new
 FT fire position. All approved by voice vote.
- 7. City Recorder Discussion/Interview

Mayor Allen asked to defer this to the September meeting. A motion was made by Councilman Kerrigan, seconded by Councilman Smith, to defer. All approved by voice vote.

- 8. Gun Restrictions for City Owned Public Property
 - Ms. Noe stated that the laws have changed and the department heads were trying to decide on how to handle them. She asked for the council's input. She stated that you cannot carry in the PD and all government offices are by permit only. Ms. Noe asked if we would like to do the same for the parks and the senior center or if we wanted to just let the department heads decide. Councilman Kerrigan and Councilman Jackson stated that they would like to allow by permit only.
