PARTNER REPORTS

Mr. Waldron with Ashland City Softball stated Spring season sign-ups will be held in December of this year. He stated the softball league fully intends on having a fall season.

PARKS REPORTS

Mr. Scott Sampson stated the Blue Cross Blue Shield grant for the playground is still pending. He stated he will be applying for a T-Mobile grant next quarter.
