- 2. Triathlon Special Event Beer Permit- Riverbluff Park
- Brad Maxwell stepped forward and stated he represents the Friends of the Trail. He further stated the Friends of the Trail has been filing the application for the few years for the event. The participants are given one cup of beer at the end of the race. Mayor verified the permit is in order. A motion was made by Committee Member Anderson, seconded by Committee Member Kerrigan, to approve the Triathlon Special Event Beer Permit. - 3. Tri Star Energy, LLC D.B.A. Sudden Service #12- 209 North Main Street Mr. William Ball stepped forward and stated he is here to ask the board for the approval of a beer permit for Sudden Service. Committee Member Jackson questioned if this is the Shell Station on Main Street. Mr. Ball responded yes, Tri Star Energy is acquiring a number of stores and the closing is set for April 6, 2020 but have not obtained business licenses at this point. He further stated they emphasize the responsible vendor program and every employee are trained in the program. Committee Member Jackson questioned if it is legal to approve the permit without having ownership at this point. City Attorney Jennifer Noe stated yes, the board can approve the permit contingent upon obtaining ownership and providing a business licence once

the transfer is complete. Mr. Ball stated he would also like to request the title on the permit read Sudden Service #0012. A motion was made by Committee Member Anderson, seconded by Committee Member Jackson, to approve the beer permit for Tri Star Energy contingent upon them obtaining the property and providing a business license.
