2. Marrowbone Creek Brewing Co., 240 South Main Street- New Business Permit Request: Manufacturing & Sale- On and Off-site

Mayor stated this is a request for a manufacturing and sell beer permit for on and off site sale for Marrowbone Brewing Company at 240 South Main Street. Mr. Christopher Morris stated he, his wife Julie Morris, and business partner Ryan Jensen are online tonight. They are requesting approval of a beer permit and would like to have beer only. He stated this will give people a reason to stay here and keep people from driving into Nashville. He stated they will also have an event space. Committee Member Adkins questioned when they are looking at opening. Mr. Morris responded they have a two (2) phase approach and the front part of the space will be sales and a tap room with maybe some outdoor seating hopefully opening in the November/December time frame. The second phase will be the back half of the building and will open a few months later. Committee Member Greer questioned if there will be a stage for

live entertainment. Mr. Morris stated it will have a stage, but will focus on lighter acoustic music as this will not be a club atmosphere. A motion made by Committee Member Greer, seconded by Committee Member Kerrigan, to approve the beer permit for Marrowbone Brewing Company. Voting Yea: Chairman Mayor Allen, Committee Member Adkins, Committee Member Greer, Committee Member Jackson, Committee Member Kerrigan, Committee Member Walker. Mayor congratulated them and reminded them of the laws of sale and service.

PIERCE, TONY

On December 12, 2020, Deputies from the Cheatham County Sheriffs Office along with 3 underage confidential informant's made visits to all stores in Cheatham County that sell alcohol by the container (not to be consumed on premise).

During this operation CI were successful in purchasing alcoholic beverages at the following locations (not listed in any specific order)

1. Food Lion 316 Frey Street, Ashland City TN 37015 Clerk: [REDACTED] Beer Permit # 2020-008, Issued by the Town of Ashland City
2. Mac's Convenience Store, D.B.A. Kangaroo Market, 545 S. Main St. Ashland City TN 37015. Clerk [REDACTED]. Beer Permit # 2020-004 issued by the Town Of Ashland City
3. Sudden Service #4 2000 Hwy 49E, Pleasant View TN 37146 Clerk: [REDACTED] Beer Permit #023, Issued by the Town of Pleasant View.

43 additional locations were checked and were compliant with TCA 57-4-203, and refused to sell alcoholic beverages to the underage informants. A copy of the complete list of stores visited will be attached as media to this report.

At the conclusion of this operation, Myself, Chief Binkley, and Lt. Bamman returned to the non-compliant stores and spoke with managers for each location and advised them of the result of the operation and their store's failure to comply. Citations were also issued to [REDACTED] at that time, Citation is pending for [REDACTED] at the time of this report due to her not being present when we arrived at the store.

The results of this operation will be forwarded to the respective beer boards for further review by them as well.

HUTCHENS, SCOTTY

On Friday and Saturday nights between the dates of 11/20/2020, 2200 hrs, and 12/27/2020, 0300 hrs, a total of thirty-eight (38) charges have been filed against nineteen (19) persons, all of whom have stated they were either going to or coming from the Midnight Lounge, 307 N Main St. The majority of arrests have occurred on Saturday nights and when the business had an event, which was often advertised on social media. The following is a break-down of the charges:

LONG, JEREMY

On Sunday December 20th, 2020 at approximately 0309 hours, I observed a vehicle traveling South on Highway 12 South in Ashland City, TN and I could see that the vehicle had windows that appeared to be tinted too dark. I stopped the vehicle to conduct a window tint inspection, which the driver's window tested at 14% with a window tint meter. I identified the driver, [REDACTED] and the passenger, [REDACTED]. While I was speaking with the occupants I could also smell the odor of an alcoholic beverage emanating from inside of the vehicle.

I asked if either of them had been drinking, [REDACTED] 19 years of age D.O.B. 03/27/2001, admitted that he had been drinking at the Midnight Lounge, where he was served 2 drinks by a female bar tender and was not asked for his identification at the time of serves.

I issued [REDACTED] a misdemeanor citation for Violation 18-21 Responsibility Act. I also advised [REDACTED] that he had 10 days to turn himself in to the Cheatham County Jail to be booked for his Violation 18-21 Responsibility Act charge and that he would be given a court date at that time.
