Mayor Allen called the meeting to order at 6:00 p.m. stating, "I am Steven Allen, Mayor for the Town of Ashland City, and I hereby call to order the March 9, 2021 Beer Board Meeting of the Town of Ashland City. #### **NEW BUSINESS**

2. Beer Permit Request: On & Off-site Sales- Kings Lounge
Ms. Reed stated the application has been received as well as the certified background check
from the TBI and the application fee has been paid. Mayor asked if anyone has any
questions. Councilman Jackson questioned if this is the same people that were running the bar
before when we were having trouble. Mr. Mario Nagy and Remon Gerges responded they are
different owners. Councilman Adkins questioned if they can assure there will not be issues as
there were before. Mr. Remon responded he has experience through previous employment in
management of restaurants and a bar. He further stated this is the first they have heard this
was an issue previously. In addition he stated they understand their success depends on them
being good stewards. City Attorney Jennifer Noe confirmed this will be only for on-site
consumption. Ms. Noe further stated she checked with ABC and stated they have not applied
for a liquor license. Both Mr. Remon and Mr. Mario confirmed they will be seeking a liquor
license. Ms. Noe informed them they will need to seek a separate license for
liquor. Councilman Smith questioned if they will have a way to track the number of customers
so they will not be over capacity. Councilman Adkins requested them to tell everyone what f

will be doing to ensure there will not be issues like there were before with the previous owners. Mr. Nagy and Mr. Gerges informed the committee this will be a local establishment and they will not be having parties for out of town people. They will have a live band sometimes for people to relax and enjoy their time. They further stated they will have a host at the door and two (2) servers and as management they will be there when open as well. They stated they have cameras there and will be monitoring things closely. A motion was made by Committee Member Anderson, seconded by Committee Member Kerrigan, to approve the beer permit. Voting Yea: Chairman Mayor Allen, Committee Member Adkins, Committee Member Anderson, Committee Member Greer, Committee Member Jackson, Committee Member Kerrigan, Committee Member Smith. Mayor informed Mr. Nagy and Mr. Gerges their permit has been approved and the committee expects them to be kind and courteous neighbors, but if there is a problem to please let us know and inform the police department if they need help.


