2. Off-premises sales beer permit request: Family Dollar

Ms. Kellie Reed stated the Ashland City Free Will Baptist Church is approximately 400 feet from the entrance of the store and the code requires the distance to be 100 feet or more. Committee Member Jackson stated the name of the church is incorrect on the application and needs to be changed. He further made a motion, seconded by Committee Member Binkley, to amend the application to reflect the correct church. All approved by voice vote. Mr. Randy Williams stepped forward and stated he is the district manager for the store. Mayor questioned how many stores Mr. Williams manages. Mr. Williams stated he manages eleven stores. Committee Member Jackson asked how the employees are trained. Mr. Williams stated they do not hire employees under the age of eighteen and they are required to take computer based training courses prior to beginning working in the store. Mayor questioned if all the paperwork is in order and if the background check is ok. Deputy Chief Matlock responded yes it is. A motion was made by Committee Member Kerrigan, seconded by Committee Member Binkley to approve the beer permit for Family Dollar.
