2. Special Event Permit: Ashland City Half Marathon sponsored by Nashville Track Club

Mr. Milner stated he has a brewery that wants to sponsor the event and they will limit access by use of wrist band. In order to obtain the wrist band the person must be twenty-one years old and have a negative COVID test. He questioned if there will be any additional requirements. City Attorney Jennifer Noe responded Mr. Milner will be responsible for the event and he will have to follow all requirements set forth in the Town's Municipal Code. She further stated she would be happy to discuss this in detail after the meeting. A motion was made by Vice Mayor Anderson, seconded by Committee Member Jackson, to approve the Special Event Beer Permit. 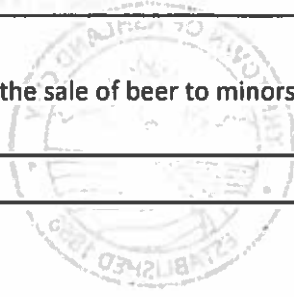
