The nonpartisan qualifying period for State Court Judge, Mayor and Augusta Commission and the partisan qualifying period for the Chief Judge of the Civil and Magistrate Court will open on Monday, March 2, 2026 at 9:00 AM and will close on Friday, March 6, 2026 at 12:00 Noon.

The nonpartisan qualifying period for Board of Education will open on Monday, August 17, 2026 at 9:00 AM and will close on Friday, August 21, 2026 at 12:00 Noon. The location for all nonpartisan qualifying will be the Board of Elections Office located at 535 Telfair Street, Suite 500, Augusta, Georgia. The location for partisan qualifying will be at a location determined by the leadership of the respective local political party.
