BACKGROUND: The Barton Chapel project (Project) is traffic flow operational efficiency at Gordon Hwy intersections and listed in the Augusta Metropolitan Planning Organization (MPO) TIP. Project funding is 80/20 federal funded cost sharing project. The purpose of this project is gaining operation efficiency by widening of the intersections to allow for left turn lane. Project is ready for construction letting. However, the Project final design yielded unavoidable impact to adjacent wetlands & stream and purchase of wetland and Stream mitigation credits from USACE designated mitigation bank is prerequisite of GDOT issuing letting notice. Project has federal funds and accordingly GDOT has project oversight and letting approval decision. The mitigation credits will be purchased from Yam Grandy Wetland & Stream Mitigation Bank at a cost of \$76,000 per wetland credit and \$85 per stream credit.

ANALYSIS: Project has federal funds and accordingly GDOT has project oversight and letting approval decision. GDOT is requiring purchase of required Mitigation Credit by April 28, 2023 to issue Project Construction Letting

Notice to Augusta Engineering. Meeting this deadline is critical to keep project Construction letting in FY2023. Failure to meet deadline will result in losing Federal funds allocated to this Project (80% construction cost federal share).

FINANCIAL IMPACT: Funds in the amount of \$104,738.00 are available in Engineering SPLOST 8 -Traffic Operation Improvements.

ALTERNATIVES: Do not approve and cancel the project.
