C. 2026 Cobb Marietta Water Authority Water Fee Increase

The City and Cobb County-Marietta Authority adopted a 5% cost increase in water and wastewater, as part of the Metropolitan North Georgia Water Planning District's Water Supply and Water Conservation Plans, a three-tiered rate structure effective 2026 through 2029, which goes into effect January 1 of each year. The increase covers the cost associated with administration, water treatment chemicals, and the preventative maintenance of treatment facilities.




Calls by Month




Calls by Apparatus




Calls by Type



The Public Works Departmental Monthly Report is an essential document that serves multiple important functions for the city.

1. Transparency:

Public Trust: It shows citizens how public funds and resources are being used by the different Division within the department (Streets, Stormwater and Water/Sewer Divisions).

Government Oversight: Helps our elected officials, and the mayor to monitor the performance of the Public Works Department.

This report ensures that the infrastructure and services provided by the Public Works Department are maintained and developed in a way that supports the community's needs now and in the future.

Streets Division

The Streets Division of the Public Works Department plays a critical role in the functionality, safety, and efficiency of the city's infrastructure. Below is a recap of the Streets Division performance from November 25, 2025, through December 14, 2025.
