C. Cobb County Next Generation 911 Transition (Information Only)

A transformational milestone has been accomplished as Cobb County 911 has officially completed their full transition to Next Generation 911 (NG911). This achievement marks a significant leap forward in how they serve and protect our community and firmly places Cobb County at the forefront of emergency communications innovation in Georgia.

Key highlights of this transition include:

- **Faster call connectivity**—calls now reach us approximately <u>eight seconds quicker</u>, a critical improvement in life-threatening situations
- Enhanced wireless location accuracy, allowing us to pinpoint callers more effectively
- Real-time video to 911, giving call-takers immediate visual context during emergencies
- Live translation and transcription, helping to overcome language barriers and ensure clarity
- A responder video wall in our Real Time Crime Center (RTCC), offering first responders a real-time view of unfolding events for faster, smarter response.
