B. Austell Water System Model

The City of Austell's water distribution system is essential to providing safe, reliable drinking water to residents and businesses. As the city grows, ensuring a resilient, efficient, and compliant system is critical.

To support this goal, a comprehensive water system model will digitally simulate the city's network of pipes and valves, enabling performance evaluation under various operating conditions.

Under the city's General Consulting Service agreement, Keck & Wood, Inc. will complete the model for a total cost of \$36,200:

Task 1: Data Gathering - \$18,200

Task 2: System Modeling - \$18,000

It is the recommendation of the Public Works Department to accept and approve the Austell Water System Model prepared by Keck & Wood, Inc., for the total amount of \$36,200.00. Funding will be allocated from 2022 SPLOST account number 345-4400-54-1410. Motion to approve.

C. Georgia Power Streetlight Upgrade

This project will reduce energy consumption, lower maintenance expenses, enhance public safety, and modernize the city's lighting infrastructure.
