A. Jefferson Street Park (Information Only)

Parks Staff along with Building Maintenance, and Public Works are ready to begin the first phase of the Jefferson Street redevelopment plan. With the help of award-winning Architect Ron Huffman, the new park will transform the old parking lot into a multi-use space for our residents and visitors. This space will bring an inviting element to our downtown area and allow everyone to enjoy a beautiful gathering space that can be used for small events such as seasonal markets, music and entertainment. In addition, the city-owned gravel lot on Love St. will be paved for overflow parking, while consolidating the commercial trash dumpsters into a cleaner more attractive trash compactor. The project will be funded through CDBG, SPLOST, and Grants. Our goal is to have this project completed by the fall (November 2025).
