The Austell Police Department received a request for surplus vehicles to be donated. On May 15, 2025, the city shop inspected a 2008 white Ford F-150. The inspection revealed that the truck has a transmission pan leak, an oil leak, and requires some preventative maintenance repairs. However, it is otherwise in acceptable condition as long as it is not driven outside the Austell city limits. Given the vehicle's high mileage, restricted usage, and the cost of repairs, it is recommended that the police department donate the truck to Mayor-elect General Vann of the Town of Tchula, Mississippi. The Ford F-150 was originally donated to the police department by the Austell Gas Company.
