**DECLARATION OF LOCAL EMERGENCY
BY THE BALDWIN COUNTY BOARD OF COMMISSIONERS TO PROVIDE FOR
THE HEALTH, SAFETY, AND WELFARE OF THE GENERAL PUBLIC**

WHEREAS, Baldwin County, Georgia is expected to experience an event of critical significance as a result of winter weather beginning January 21, 2025; and

WHEREAS, the Governor has declared a state of emergency for the State of Georgia; and

WHEREAS, the duly elected governing authority of Baldwin County, Georgia is the Baldwin County Board of Commissioners; and

WHEREAS, the governing authority is empowered to provide for the health, safety, and welfare of the residents, employees, businesses, and visitors within the County; and

WHEREAS, the governing authority is authorized to provide Emergency Declarations under State Law and Local Ordinance; and

WHEREAS, the Chair of the Baldwin County Board of Commissioners is authorized by the local Emergency Management Ordinance to issue and declare a local state of emergency; and

WHEREAS, in the judgment of the Chairman of the Baldwin County Board of Commissioners, with advice from the Baldwin County Emergency Management Agency, there exist emergency circumstances located in Baldwin County requiring extraordinary and immediate corrective actions for the protection of the health, safety, and welfare of the citizens of Baldwin County, Georgia; and

WHEREAS, to prevent or minimize injury to people and damage to property resulting from this event, certain actions are required;

THEREFORE, BE IT HEREBY DECLARED that:

The Baldwin County Board of Commissioners, by and through its Chairman, declares and orders that a local state of emergency exists and shall continue until the conditions requiring this declaration are abated.

IT IS ORDERED, that the Baldwin County Emergency Management Agency activate the County Emergency Operations Plan, under the direction and control of the Emergency Management Director and further ordered that the emergency management ordinances adopted by the Baldwin County Board of Commissioners be operative.


Unless otherwise stated herein, this Emergency Declaration shall take effect immediately and shall continue until the conditions requiring this declaration are abated.


