1. Call to order.

2. Invocation and Pledge.

All stood for the pledge and Mayor Gibson offered the invocation.

3. Visitors to be heard (shall not exceed 30 minutes total).

Citizens wishing to be heard may do so on all matters except personnel matters, matters listed on the agenda as a public hearing, and matters under litigation. Each person addressing the council must provide his/her legal name and current address for city records and meeting minute preparation. Each person will only be allowed to speak on matters on the agenda during citizen's forum/public comment. No rebuttals will be permitted. Each person addressing the governing body shall not exceed three (3) minutes. Section 551.042, Government Code, V.T.C.A. (i.e. Texas Open Meetings Act) permits a member of the public or a member of the governmental body to raise a subject that has not been included in the notice for the meeting, but any discussion of the subject must be limited to a proposal to place the subject on the agenda for a future meeting. All remarks shall be addressed to the council as a body, and not to any individual member thereof. Any person making personal, impertinent, or slanderous remarks while addressing the council may be requested to leave the meeting.

Mayor Gibson read the Proclamation for Public Works Appreciation week and thanked them for all their hard work. Public works Director Lance Roy and Public Works Employee Brian Gillaspy were present.

B. Discussion and possible action on Resolution 2022-029 authorizing the closing of accounts at Bandera Bank – Wright

C. Discussion and possible action on an Ordinance 419 amending the City of Bandera Code of Ordinances, Chapter 3 Building Regulations, Article 3.09 Signs. Palmer/Russe

There was much discussion on amending the sign Ordinance to repeal sections regarding enforcement.

Motion made by Councilmember Palmer to approve Ordinance 419, Seconded by Mayor Pro Tem Russe.

D. Discussion and possible action on Ordinance 420 to abate enforcement of City of Bandera Code of Ordinances Chapter 3.08 Outdoor Lighting, Section 3.08.015 Enforcement.

There was much discussion on an Ordinance 420 regarding outdoor lighting and how it affects home owners as well as business's. The Ordinance would temporarily suspend enforcement of certain sections of the code.
