#### 1. Call to order.

Alan Arterbury called the meeting to order at 6:02 pm. Christine Morse, Toni Kunz and Donna Ross were present. Jerad Wilcox, Lauren Ojeda and Laura Devenport were absent.

#### 2. Pledge of Allegiance.

All stood for the pledge.

#### 3. Announcements.

There were no announcements.

#### 6. Discussion and possible action on the following items:

#### 1. Amending promotional funding budget.

Motion to amend the fiscal year 2021-2022 budget for promotions by \$3,023.19, by Toni Kunz, seconded by seconded by Christine Morse. All in favor, none opposed. Motion passed.

Toni Kunz recalled last motion and requested to table this item, seconded by Christine Morse. All in favor, none opposed. Motion passed.

#### 2. Promotional funding application a. Christmas lights / Jane Pratt

This item was moved to the top of the regular agenda.

Jane Pratt presented the new information to the board and the request for \$1,000.00

Jack Mosley presented the Bandera Community Action Group taking over the lights because the BEDC didn't have enough funds a few years ago. BCAG took over and has been receiving grants. He also gave an update on the current year's set up and donations. There was discussion about the promotional funding adjustment amount.

Motion to approve the \$1,000 requested provided it is available in the account, seconded by Christine Morse. All in favor, none opposed. Motion passed.

#### **3.** Update on amending the tax statement.

This item was tabled.

#### 4. Update on block project partnership for back-in angle parking.

Toni Kunz commented she wasn't getting any positive feedback. No action on this item.

#### 5. Update on forming a committee for wayfining signs.

Laura Devenport was not at this meeting so there was no update. No action.

#### 6. Presentation by Donna Ross on the sale of a 21.3 acre riverfront property to the EDC.

There was discussion about getting an opinion from the lawyer about Donna Ross being on the board. Motion to table made by Toni Kunz, seconded by Christine Morse. All in favor, none opposed. Motion passed.

Jack Mosley and Patricia Moore commented about the items that aren't being used and what needs to be redone in for future years. They proposed that BCAG have access to the lights and decorations to help figure out what all needs to be eliminated or salvaged.

It was clarified that the EDC gives the authority to the BCAG come up with a plan on how to go through the items and come up with an inventory.
