3. DISCUSSION:

a. County Code Amendment Recommendations

Class I Subdivisions

After some discussion, the following amendment recommendations were made:

- 3 lots maximum on splits or based on number of children
- Splits only allowed every 3 years from the date of record on all classes
- 3 month limit for recording of plat
- 2 lot maximum per easement

The amendments will be considered in a future meeting.

Code Enforcement - Outside Government Service Area within County - Grease Traps
 & Sewer Violations

Recommendation:

Any business in the county which is provided public utility services by a source other than Banks County must maintain compliance with the provider's regulations. Failure to remain in compliance with these regulations could result in enforcement action from Banks County and\or discontinued service of utilities from the provider.

Officer Cash stated this would authorize him to issue tickets for utility code violations in relation to grease traps and sewer in service delivery areas of other jurisdictions within Banks County. Banks County would receive the fine but the other jurisdiction would have to pursue restitution. He stated that Public Utilities Director Horace Gee had also agreed and would be recommending code amendment to allow this for County utilities as well once the new wastewater treatment facility is complete. This will also be considered in a future meeting.
