3. WORKSESSION DISCUSSION

a. Amend Permit Fees

Ms. Fincannon introduced a revised list of fees. The current construction permits are based on cents per square foot. The new fees would have a base fee for groups of square footage. There is a new fee for residential solar, permit renewal after 1 year and a cell tower type. The majority of increase will be large commercial projects. There is no increase for agricultural permits and a very small increase for subs (electrical, mechanical, plumbing).

b. Noise Ordinance

The 2 attached proposals were introduced. There is a concern to not have complete free reign but enforcing this kind of ordinance would be difficult. The major things to be looked at in implementing a noise ordinance are exemptions, times of day, enforcement, zoning and special event permits.

Jen Poole spoke regarding about how the lack of a noise ordinance is negatively impacting her family. She states she has spoken to lots of people who agree we need some kind of noise ordinance. She states her neighborhood has an HOA but they will not help in this situation.

If we try to use the decibel meter we also have to have the analyzer to go with it. If the ordinance we put in place bases the enforcement on decibel level, that is the only thing we can use.

Chairman Griffith stated we should further discuss this at the next meeting with the additional information presented.
