Genee Moore, a current STR owner speaks on behalf of the code. She asks about the maximum occupancy and speculates that it might be better to base the number on square footage of the home rather than number of bedrooms.

Discussion:

Mr. O'Kelley and Ms. Parks express concerns about fire safety. Mr. O'Kelley states that he wants clarification in item number 7 that fire safety be held to the state standard after being addressed with inspectors at Bureau Veritas and the State Fire Marshal. Mr. O'Kelley says he believes this will answer the question of maximum occupancy as well.

The following clarification is offered:

7. All residences structures built for the purpose of short-term rental shall be built to the same standards as single-family residences according to current international, state, and county residential property codes for building, zoning, fire prevention, and health and sanitation and shall be required to be permitted and inspected as such. An operable interconnected, hard-wired smoke detection system, with battery backup, is required outside each bedroom. (In the case of registered nonconforming uses, an operable battery-operated smoke detector outside of each bedroom will be accepted.) Any units with LP or natural gas must have a carbon monoxide detection system as well.

Mr. Hensley and Mr. Griffith express their dislike of the limitations set in the ARR and CAD zones. Ms. Parks states she is hesitant to remove them as the case may vary from one situation to the next. Mr. Hensley and Mr. Griffith remain rigid in their stance. Their proposal is the following:

In R1 zones, accessory buildings and structures shall be located only in the side or rear yards. In ARR and CAD zones, accessory structures on less than 5 acres shall be located only in the side or rear yards. Accessory structures located in ARR or CAD zones on greater than 5 acres may be located to the front of a dwelling but no closer than 100' from the road right-of-way.
