May 2, 2024

The Bastrop Parks and Public Tree Advisory Board met in a Regular Meeting on Thursday, May 2, 2024, at 5:30 p.m. at City Hall. 3D. Director's Meeting Update

- Pickleball is painted and striped with one rolling net at Fisherman's.
- One rolling net is also at Bob Bryant, will be painted soon.
- New chairs at the Rodeo Arena and new dirt.
- Tree Folks – trees can't go in Pecan Park because it is a floodway, not a flood plain. On hold.
- Tree migration playscape design is in discussion.
- Park maintenance team is full and we have an irrigation specialist hired.
- May 8th meeting with engineers to discuss erosion at Ferry Park and a few other locations.
- Working to make the city eligible for TPWD park grants – we took 1.34 acres to build water plant in Bob Bryant in 2009. Applied in 2018 for grant and they told us no due to the take of park land. We can use the appraised value of the land at the 2009 rate. Next step is to get it appraised so the City knows how much new park land needs to be designated. Additionally, the new Park Master Plan needs to be loaded onto the TPWD Grant website by the end of May. Applications for grants open in August.
- May 18, 9:45am-noon – Delgado Park celebration and mural unveiling.
