WHEREAS, during the spring, Monarch butterflies can travel over 2,500 miles from their over-wintering site in Mexico to summer breeding grounds from northern United States into southern Canada; and

WHEREAS, in late summer, Monarchs born up north return to Mexico, to the same mountainous region and same trees where their ancestors congregated the winter before; and

WHEREAS, Central Texas is part of the "funnel" that Monarchs pass through during both trips; and

WHEREAS, in the spring, Monarchs from Mexico look for milkweeds to lay eggs on, creating the next generation that will travel north; and

WHEREAS, in the fall, Monarchs look for flower nectar to refuel on their way to Mexico; and

WHEREAS, due to the use of herbicides and pesticides, habitat conversion, and adverse land management, Monarch populations have declined about 80% in recent decades; and

WHEREAS, The City of Bastrop is within this funnel, perfectly located to assist this annual Monarch migration and to help reverse this trend.





BACKGROUND/HISTORY:

The Chief Financial Officer, or appointed staff, provides the City Council a monthly financial report overview for all funds to include detailed analysis for General Fund, Development Services Fund, Water-Wastewater Fund, Bastrop Power & Light and the HOT Tax Fund.

REVENUE

General Fund exceeded the forecast by 4.6%

• Property Tax is 7% below forecast.

Impact Fee Fund is now running 22.5% below forecast due to delays in receiving anticipated fees.

Debt Service Funds are performing slightly lower than forecast due to timing of revenues.

All other funds are positive to forecast.

EXPENDITURES

All funds are positive to forecast amounts.

This reporting requirement is set forth by the City of Bastrop Financial Management Policies, Chapter IV. Operating Budget, Section D. Reporting, as adopted by Resolution R-2023-123 on August 22, 2023.

HOTEL OCCUPANCY TAX EXPENDITURES BY DIVISION







(a) The governing body of a municipality wishing to exercise the authority relating to zoning regulations and zoning district boundaries shall establish procedures for adopting and enforcing the regulations and boundaries. A regulation or boundary is not effective until after a public hearing on the matter at which parties in interest and citizens have an opportunity to be heard. Before the 15th day before the date of the hearing, notice of the time and place of the hearing must be published in an official newspaper or a newspaper of general circulation in the municipality.

Zoning Change signs were visibly placed in the front of the property and notice was sent to property owners within 200 feet of the property boundary.

(b) In addition to the notice required by Subsection (a), a general-law municipality that does not have a zoning commission shall give notice of a proposed change in a zoning classification to each property owner who would be entitled to notice under Section 211.007(c) if the municipality had a zoning commission. That notice must be given in the same manner as required for notice to property owners under Section 211.007(c). The governing body may not adopt the proposed change until after the 30th day after the date the notice required by this subsection is given.

N/A. Bastrop is not a general-law municipality.

(c) If the governing body of a home-rule municipality conducts a hearing under Subsection (a), the governing body may, by a two-thirds vote, prescribe the type of notice to be given of the time and place of the public hearing. Notice requirements prescribed under this subsection are in addition to the publication of notice required by Subsection (a).

Notice of the meeting was posted at least 72 hours in advance.

(d) If a proposed change to a regulation or boundary is protested in accordance with this subsection, the proposed change must receive, in order to take effect, the affirmative vote of at least three-fourths of all members of the governing body. The protest must be written and signed by the owners of at least 20 percent of either:

(1) the area of the lots or land covered by the proposed change; or

(2) the area of the lots or land immediately adjoining the area covered by the proposed change and extending 200 feet from that area.

(e) In computing the percentage of land area under Subsection (d), the area of streets and alleys shall be included.

At the time of this report, no protest has been received.

(f) The governing body by ordinance may provide that the affirmative vote of at least three-fourths of all its members is required to overrule a recommendation of the municipality's zoning commission that a proposed change to a regulation or boundary be denied.

If the Planning & Zoning Commission recommends denial of the zoning request, the City Council must have a minimum vote of 4 out of 5 members to approve the zoning request.

At least 5 members of the Planning & Zoning Commission must vote to make an official recommendation to the City Council. Failure to reach five votes means no official recommendation can be forwarded, but this does not impact the City Council's vote requirement to approve or deny the request.

Compliance with 2036 Comprehensive Plan:

The Transitional Residential character area is for lands to be developed with higher densities and a variety of housing types. The character area supports high density single-family detached, single-family attached (duplexes, triplexes, townhouses) and multifamily (apartments), and institutional residential uses such as nursing homes and assisted living facilities. Variation in form, scale, and density is allowed but appropriate transitions must be provided between land uses. In some cases, Transitional Residential uses may be included as part of a larger planned development within areas otherwise designated as Neighborhood Residential. Like, Transitional Residential character areas may also include associated amenities such as parks, trails, open spaces, and public uses such as schools, fire stations, and more.

Representative land uses are appropriate per the Future Land Use Map.

RECOMMENDATION:

Hold public hearing and consider action on a recommendation for the 1207B & 1305 State Highway 95 Zoning Concept Scheme, changing the zoning of 0.711 and 0.367, respectively, totaling 1.078 acres out of the Farm Lot 67 E M Street survey, within the City of Bastrop from P5 Core and P4 - Mix to Civic Space, as shown on Attachment 2.

ORDINANCE 2024-01

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS, APPROVING THE ZONING CHANGE FOR 1.08 +/- ACRES OUT OF FARM LOT 67, EAST OF MAIN STREET, LOCATED AT THE NORTHEAST CORNER OF STATE HIGHWAY 95 AND FARM STREET, WITHIN THE CITY LIMITS OF BASTROP, TEXAS, FROM P4 MIX TO P-CS CIVIC SPACE; PROVIDING FOR FINDINGS OF FACT; PROVIDING FOR REPEALER; PROVIDING FOR SEVERABILITY; PROVIDING FOR ENFORCEMENT; PROVIDING FOR PROPER NOTICE AND MEETING; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City of Bastrop, Texas (City) is a Home-Rule City acting under its Charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Texas Local Government Code; and

WHEREAS, on or about November 6, 2023, the City of Bastrop (hereinafter referred to as "Property Owner") submitted a request for zoning modifications; and,

WHEREAS, City Council has reviewed the request for zoning modifications, and finds the request to be reasonable and proper under the circumstances; and

WHEREAS, the City Staff has reviewed the request for zoning modifications, and finds it to be justifiable based upon the Future Land Use Designation for this Property is Parks and Open Space, which allows for public use; and

WHEREAS, in accordance with Texas Local Government Code Chapter 211, public notice was given, and a public hearing was held before the City of Bastrop Planning and Zoning Commission (P&Z) on December 21, 2023, and made the recommendation for approving of the rezoning request by a vote of 6-0; and

WHEREAS, in accordance with Texas Local Government Code, Chapter 211, a threefourths vote of City Council is required to approve a zoning request when the Planning & Zoning Commission has recommended denial; and

WHEREAS, in accordance with Texas Local Government Code Chapter 211, public notice was given, and a public hearing was held before the City Council regarding the requested zoning modification; and

WHEREAS, Texas Local Government Code Section 51.001 provides the City general authority to adopt an Ordinance or police regulations that are for good government, peace or order of the City and is necessary or proper for carrying out a power granted by law to the City; and

WHEREAS, after consideration of public input received at the hearing, the information provided by the Applicants, and all other information presented, City Council finds that it is necessary and proper to enact this Ordinance.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS THAT:

Section 1: The Property, 1.08 +/- acres out of land out of the Farm Lot, Block 67, east of Main, is rezoned from P4 Mix to P-CS Civic Space, and a Zoning Concept Scheme is established 1.08 +/- acres, located at the Northeast Corner of State Highway 95 and Farm street, within the City Limits of Bastrop, Texas as more particularly shown on Exhibit A.

Section 2: The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein.

Section 3: All ordinances, resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.

Section 4: If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, that invalidity or the unenforceability will not affect any other provisions or applications of this Ordinance that can be given effect without the invalid provision.

Section 5: The City shall have the power to administer and enforce the provisions of this ordinance as may be required by governing law. Any person violating any provision of this ordinance is subject to suit for injunctive relief as well as prosecution for criminal violations, and such violation is hereby declared to be a nuisance. Nothing in this ordinance shall be construed as a waiver of the City's right to bring a civil action to enforce the provisions of this ordinance and to seek remedies as allowed by law and/or equity.

Section 6: It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551.

Section 7: This Ordinance shall be effective immediately upon passage and publication.










Cemetery Re-Zoning





BACKGROUND/HISTORY:

At the January 23, 2024, Council meeting an item to accept \$1,200 from St David's Hospital to the City of Bastrop for the creation of a mural in Delgado Park honoring Minerva Delgado was approved.

Councilmember Lee was honored as a "Network Weaver" by St. David's foundation and awarded \$1,200 to put towards a civic project in Bastrop. Councilmember Lee chose Delgado Park as her project and began collaborating with the Parks Board and the Cultural Arts Commission to create a mural in Delgado Park that would honor the life of Minerva Delgado.

In 1948, with the support of LULAC and the legal assistance of Gus Garcia, Minerva Delgado and 20 other parents of Mexican American children filed suit in U.S. District Court for the Western District of Texas challenging the segregation of their children in five Texas public school districts. Thus began the case of **Delgado, et. al. v. Bastrop Independent School District, et. al.** In their complaint for the Mexican American parents, the attorneys argued that the school districts had "prohibited, barred, and excluded" Mexican American children from attending public school with "other white school children" in violation of the equal protection of the laws guaranteed by the U.S. Constitution's Fourteenth Amendment.

BACKGROUND/HISTORY:

This is a request for the Council to authorize the City Manager to execute an Interlocal Agreement between the City of Bastrop, Bastrop County, and West Bastrop Village Municipal Utility District (MUD) for road maintenance inside the Adelton district. The District lies within the extraterritorial jurisdiction of the City of Bastrop, an unincorporated area of Bastrop County, Texas. The District will contain a residential subdivision that is subject to the City's subdivision platting authority, as set forth in that certain January 10, 2006 Interlocal Agreement between the City and the County; and the City has exclusive jurisdiction to regulate all subdivision plats, construction plans, and related permits, for development within the District.

The County requirements and standards for roads can be found in the Bastrop County Subdivision Regulations, as amended April 24, 2017. The plans for the residential subdivisions in the District are subject to the City's subdivision regulations and may not meet the requirements in the County Regulations. The Planned Development Agreement between the City and West Bastrop Village, Ltd., effective August 22, 2006, provides, among other terms, that all streets shall be dedicated to public use and maintained by Bastrop County; however, the County was not a party to the Development Agreement, and the County will not maintain roads within the District that do not meet the requirements set forth in the County Regulations and will not accept such roads into the Bastrop County road maintenance system. To resolve the conflict, the County, City, and District desire to enter into an interlocal agreement providing for the maintenance of the public roads lying within the District (the "Adelton ILA").

FISCAL IMPACT:

The West Bastrop Village MUD will be responsible for all costs of maintenance of the Public Roads and pay such maintenance costs through any legally available revenues. The MUD will provide the maintenance of the Public Roads or a portion of the Public Roads until said Public Roads or a portion of the Public Roads have been annexed into the corporate limits of the City.

RECOMMENDATION:

Authorize the City Manager to execute an Interlocal Agreement with Bastrop County and West Bastrop Village Municipal District.

WHEREAS, the County, City, and the District desire to enter into an interlocal

agreement providing for the maintenance of the public roads lying within the District (the "Adelton ILA"); and

WHEREAS, City Council finds that it is necessary and proper to enact this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS:

- **Section 1.** Findings of Fact: The foregoing recitals are incorporated into this Resolution by reference as findings of fact as if expressly set forth herein.
- **Section 2.** Authorization: The City Manager shall execute the Interlocal Agreement to support road maintenance for a certain development of property commonly known as Adelton and more accurately described in the Adelton ILA which is attached and incorporated herein as Exhibit A.
- **Section 3. Repealer:** To the extent reasonably possible, resolutions are to be read together in harmony. However, all resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters regulated.
- **Section 4.** Severability: Should any of the clauses, sentences, paragraphs, sections, or parts of this Resolution be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Resolution.
- **Section 5.** Effective Date: This Resolution shall take effect upon the date of final passage noted below, or when all applicable publication requirements, if any, are satisfied in accordance with the City's Charter, Code of Ordinances, and the laws of the State of Texas.
- **Section 6. Proper Notice & Meeting:** It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public, and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.

THIS INTERLOCAL AGREEMENT FOR ROAD MAINTENANCE (the "<u>Agreement</u>") is made and entered into by and between THE CITY OF BASTROP, a political subdivision of the State of Texas (the "<u>City</u>"), BASTROP COUNTY, a political subdivision of the State of Texas (the "<u>County</u>"), and WEST BASTROP VILLAGE MUNICIPAL UTILITY DISTRICT OF BASTROP COUNTY, a political subdivision of the State of Texas a municipal utility district (the "<u>District</u>"). The City, County and the District may hereinafter collectively be referred to as the Parties.

RECITALS

WHEREAS, the District lies within the extraterritorial jurisdiction of the City of Bastrop, an unincorporated area of Bastrop County, Texas;

WHEREAS, the District will contain a residential subdivision that is subject to the City's subdivision platting authority, as set forth in that certain January 10, 2006 Interlocal Agreement between the City and the County;

WHEREAS, the City has exclusive jurisdiction to regulate all subdivision plats, construction plans, and related permits, for development within the District;

WHEREAS, the County requirements and standards for roads can be found in the Bastrop County Subdivision Regulations, as amended April 24, 2017 (the "County Regulations");

WHEREAS, the plans for the residential subdivisions in the District (the "Plans") are subject to the City's subdivision regulations and may not meet the requirements in the County Regulations;

WHEREAS, that certain Planned Development Agreement between the City and West Bastrop Village, Ltd., effective August 22, 2006 (the "Development Agreement"), provides, among other terms, that all streets shall be dedicated to public use and maintained by Bastrop County; however, the County was not a party to the Development Agreement and the County will not maintain roads within the District that do not meet the requirements set forth in the County Regulations and will not accept such roads into the Bastrop County road maintenance system; WHEREAS, the County, City, and the District desire to enter into an interlocal agreement providing for the maintenance of the public roads lying within the District (the "<u>Public Roads</u>").

AGREEMENT

NOW THEREFORE, in consideration of the foregoing premises and mutual covenants and agreements expressed herein, the parties hereby agree as follows:

ARTICLE ONE MAINTENANCE OF THE ROADS

- 1.1. <u>Public Roads</u>. The Public Roads will be dedicated to the public, and the general public will have the same access as other public roadways.
- 1.2. <u>Maintenance</u>. The Parties agree that the District shall perform all necessary maintenance (the "<u>Maintenance</u>") on the Public Roads until said Public Roads or portion of the Public Roads have been annexed into the corporate limits of the City or until such time another governmental entity agrees to maintain the Public Roads or portions thereof.
- 1.3. <u>Payment of Maintenance Costs</u>. The District will be responsible for all costs of Maintenance of the Public Roads and pay such Maintenance costs through any legally available revenues.

ARTICLE TWO COUNTY AND CITY AGREEMENT

2.1. The City and County agree that plats and subdivision construction plans for development within the District will not contain public roads meeting County road standards as set forth in the County Regulations, and therefore such roads will not be accepted by the County for maintenance. Therefore, such plats and subdivision construction plans need only be submitted to and approved by the City. No County review, comment, or further approval is required.

ARTICLE THREE GENERAL PROVISIONS

- 3.1. <u>Cooperation</u>. The Parties agree with each other in good faith at all times to effectuate the purposes and intent of this Agreement.
- 3.2. <u>Other Instruments, Actions</u>. The Parties hereto agree that they will take such other and further actions and execute such other and further consents, authorizations, instruments or documents as are necessary or incidental to effectuate the purposes of this Agreement.

- 3.3. Term; Annexation. This Agreement shall remain in effect for so long as the District remains in existence and shall terminate at such time as the City annexes the District. After annexation, the City shall be responsible for Maintenance of the Public Roads.
- 3.4. Notice. Any notice required or permitted to be delivered under this Agreement shall be deemed received on the earlier of (i) actual receipt by mail, Federal Express or other overnight delivery service, or hand delivery, or (ii) three business days after being sent by United States mail, postage prepaid, certified mail, return receipt requested, addressed to the City, County or the District.

- 3.5. <u>Remedies; Notice of Default</u>. Default by a party shall occur if the party fails to perform or observe any of the terms and conditions of this Agreement required to be performed or observed by that party. The party alleging the default will give the other party written notice of the default. If the party in default fails to cure the default within sixty (60) business days of the date of the notice (and an additional reasonable time after such receipt if (A) such failure cannot be cured within such sixty (60) business day period, and (B) the party in default commences curing such failure within such sixty (60) business day period, and thereafter diligently pursues the curing of such failures), the party giving the notice may pursue any remedies permitted by law including filing suit in a court of competent jurisdiction, whether state or federal, in Bastrop County, Texas, and seeking specific performance of the terms of the Agreement.
- 3.6. <u>Entire Agreement</u>. This Agreement contains the entire agreement of the Parties and supersedes all prior and contemporaneous understandings or representations, whether oral or written, respecting the subject matter hereof.
- 3.7. <u>Amendments</u>. Any amendment to the Agreement must be in writing and signed by the authorized representatives of all Parties.
- 3.8. <u>Interpretation and Authority</u>. The Parties acknowledge that this Agreement is entered into pursuant to the authority of Texas law, including, without limitation, the authority conferred in V.T.C.A. Govt Code, Chapter 791, et. seq., V.T.C.A. Water Code, Section 49.213. In the event of any conflict between the provisions of this Agreement and the provisions of any other agreement entered into by and between the Parties, the provisions of this Agreement shall prevail with respect to the subject matter hereof. Except as set forth above, this Agreement shall not be construed so as to modify, supplement or otherwise alter the provisions of any other agreement entered into by and between the Parties.
- 3.9. <u>Assignment</u>. Neither party may assign its rights and obligations under the Agreement either in whole or in part.
- 3.10. <u>No Third Party Beneficiaries</u>. Except as expressly provided above, nothing herein shall be construed to confer upon any person other than the parties hereto any rights, benefits or remedies under or by reason of this Agreement.
- 3.11. <u>No Joint Venture, Partnership, Agency</u>. This Agreement shall not be construed in any form or manner to establish a partnership, joint venture or agency, express or implied, or any employer-employee or borrowed servant relationship by and among the Parties.

- 3.12. <u>Responsibilities for Manner and Means of Performance</u>. The District is performing all its duties to this Agreement as an independent contractor. The District shall have the exclusive authority and responsibility for determining the manner and means of performance under this Agreement and for selecting and supervising the persons who perform the work.
- 3.13. <u>Applicable Law</u>. This Agreement shall be governed by and construed in accordance with the laws of the State of Texas.
- 3.14. <u>Venue</u>. Venue for any suit arising under this Agreement shall be Bastrop County, Texas, or in the United States District Court of the Western District of Texas, Austin Division.
- 3.15. <u>Duplicate Originals</u>. This Agreement may be executed in one or more duplicate originals, each of equal dignity.
- 3.16. <u>Effective Date</u>. This Agreement shall be effective on the later of the dates this Agreement is executed by the authorized representative of the Parties.

BACKGROUND/HISTORY:

Staff and the Development Review Committee (DRC) are charged with reviewing the B3 Code for amendments. There are inconsistencies between the adopted B3 Technical Manual and the State of Texas requirements for On-site Sewer Facilities (OSSF). Currently, the City code requires a one-acre lot size or greater for individual on-site sewage facility methods. The State requirements allow for a half-acre lot size or greater for the same individual on-site sewage facility methods. The codes need to be consistent and align with the state requirements.

FISCAL IMPACT:

The code amendment to align with state requirements has no fiscal impact.

RECOMMENDATION:

Recommend approving the first reading of Ordinance No. 2024-03, amending the City Code and B3 Technical Manual as submitted.

AN ORDINANCE OF THE CITY OF BASTROP, TEXAS, AMENDING THE BASTROP CODE OF ORDINANCES, CHAPTER 13, ARTICLE 13.04 ON-SITE SEWAGE FACILITIES AND AMENDING THE B3 TECHNICAL MANUAL, CHAPTER 3, ARTICLE 3.2 INFRASTRUCTURE REQUIREMENTS TO ALIGN WITH THE STATE REQUIREMENTS FOR SEPTIC SYSTEMS ON ONE-HALF ACRE LOTS; AND PROVIDING FOR FINDINGS OF FACT, REPEALER, SEVERABILITY, CODIFICATION, EFFECTIVE DATE, PROPER NOTICE AND MEETING.

- WHEREAS, pursuant to Texas Local Government Code Section 51.001, the City Council of the City of Bastrop has general authority to adopt an ordinance or police regulation that is for the good government, peace, or order of the City and is necessary or proper for carrying out a power granted by law to the City; and
- **WHEREAS,** the City of Bastrop recognizes the need to stay current with state regulations to ensure the health, safety, and welfare of its residents;
- WHEREAS, the Texas State requirements for septic systems on one-half acre lots have been updated to reflect advancements in technology and environmental considerations;
- **WHEREAS,** the City Council finds it necessary to amend the existing City Code to align with the aforementioned state requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS:

- **Section 1.** Findings of Fact: The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein.
- Section 2. Amendment To City Code And B3 Technical Manual: Section 13.04.007 of the City of Bastrop Code of Ordinances and Section 3.2.005 of the B3 Technical Manual are hereby amended to replace the phrase "one acre" with "one-half acre" in all instances referring to the minimum lot size requirements for septic systems and shall read in accordance with Exhibit "A", which is attached hereto and incorporated into this Ordinance for all intents and purposes. Any underlined text shall be inserted into the

Code and any struck-through text shall be deleted from the Code, as shown in each of the attachments.

- **Section 3. Repealer:** To the extent reasonably possible, ordinances are to be read together in harmony. However, all ordinances, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated.
- **Section 4. Severability:** Should any of the clauses, sentences, paragraphs, sections, or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.
- **Section 5. Codification:** The City Secretary is hereby directed to record and publish the attached rules, regulations, and policies in the City's Code of Ordinances as authorized by Section 52.001 of the Texas Local Government Code.
- Section 6: Effective Date: This Ordinance shall take effect upon the date of final passage noted below, or when all applicable publication requirements, if any, are satisfied in accordance with the City's Charter, Code of Ordinances, and the laws of the State of Texas.
- Section 7. Proper Notice & Meeting: It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.

BACKGROUND/HISTORY:

On April 11th, 2023, TX DOT conducted an engineering and traffic investigation regarding the speed and number of vehicles that utilized FM 969. The recommendation from TxDot was to lower the speed limit from 65 miles per hour, to 60 miles per hour.

POLICY EXPLANATION:

Texas Transportation Code

Chapter 545, Subchapter H. Speed Restrictions, Section 545.356 Authority Of Municipality To Alter Speed Limits and section 545.351 (a) Maximum Speed Requirement

Sec. 545.356. AUTHORITY OF MUNICIPALITY TO ALTER SPEED LIMITS. (a) The governing body of a municipality, for a highway or part of a highway in the municipality, including a highway of the state highway system, has the same authority to alter by ordinance prima facie speed limits from the results of an engineering and traffic investigation as the Texas Transportation Commission on an officially designated or marked highway of the state highway system. The governing body of a municipality may not modify the rule established by Section 545.351(a) or establish a speed limit of more than 75 miles per hour.

(b) The governing body of a municipality, for a highway or part of a highway in the municipality, including a highway of the state highway system, has the same authority to alter prima facie speed limits from the results of an engineering and traffic investigation as the commission for an officially designated or marked highway of the state highway system, when the highway or part of the highway is under repair, construction, or maintenance. A municipality may not modify the rule established by Section 545.351(a) or establish a speed limit of more than 75 miles per hour.

Sec. 545.351. MAXIMUM SPEED REQUIREMENT. (a) An operator may not drive at a speed greater than is reasonable and prudent under the circumstances then existing.

SPEED LIMIT ON FM 969

AN ORDINANCE OF THE CITY OF BASTROP, TEXAS; AMENDING THE CODE OF ORDINANCES, RELATED TO CHAPTER 12 TITLED "TRAFFIC AND VEHICLES", ARTICLE 12.05 TITLED "SPEED LIMITS", ADDING SECTION 12.05.011 TITLED "FM 969 SPEED LIMITS." ZONING FOR TRAFFIC AND RATE OF SPEED THEREIN, ON FM 969 IN THE CITY LIMITS OF THE CITY OF BASTROP; DEFINING SPEEDING AND FIXING A PENALTY THEREFORE; DECLARING WHAT MAY BE A COMPLAINT IN SUFFICIENT PROSECUTIONS HEREUNDER: REPEALING ALL PRIOR ORDINANCES THAT ARE IN CONFLICT HEREWITH; AND PROVIDING FOR FINDINGS OF FACT, ENACTMENT, CODIFICATION, **EFFECTIVE DATE, REPEALER, SEVERABILITY, PROPER** NOTICE AND MEETING.

- WHEREAS, the Texas Department of Transportation has determined upon the basis of engineering and traffic investigation that the prima facie maximum speed limit for that portion of FM 969 as shown on the attached Exhibit A, shall be as stated and described hereinafter; and
- WHEREAS, the City of Bastrop desires to protect and ensure the public health, safety, and welfare of its residents and business by regulating and guiding the general traveling public; and
- WHEREAS, the City Council desires to change the current prima facie speed limits on FM 969 in the city limits of the City of Bastrop, as provided herein, to 60 mph pursuant to Section 12.05.003 of the Code of Ordinances to better protect the convenience, health, safety, and welfare of the residents of the City and of the motoring public.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS, THAT:

- **Section 1.** The facts and recitations set forth in the preamble of this Ordinance are hereby found to be true and correct.
- **Section 2.** It is hereby determined upon the basis of an Engineering and Traffic investigation that the prima facie maximum speed limit on those portions of FM 969 routed in the City of Bastrop, is hereby stated, which prima facie maximum speed limit shall be effective at all times and signs will be erected giving notice of the prima facie maximum speed limit so declared to wit.

Speed Zone

FOR EASTBOUND TRAFFIC

Beginning at Control Section 1186-02 at milepoint 11.424 (Bastrop Northern City Limit - 755 feet South of Sam Houston Dr.) to milepoint 12.164 (SH 21-SH71), a distance of 0.740 miles, a prima facie maximum speed limit of 60 miles per hour.

FOR WESTBOUND TRAFFIC

Beginning at Control Section 1186-02 at milepoint 12.164 (SH 21-SH71) to milepoint 11.424 (Bastrop Northern City Limit - 755 feet South of Sam Houston Dr.), a distance of 0.740 miles, a prima facie maximum speed limit of 60 miles per hour.

Section 3. That all of the streets of this city, and all portions of any such streets, are hereby declared to be public streets and that the driving or operating of any motor vehicle on or along any portion of any street of this city at a rate of speed that is greater than the maximum rate of speed for said portion of said street, as fixed by this ordinance shall be guilty of a misdemeanor, which is named " The Offense of Speeding " and that the said offense is punishable by a fine in any sum not to exceed Two Hundred dollars (\$200.00). That the use of the word " Speeding " shall be sufficient to designate the said offense, and shall mean that a motor vehicle has been driven upon a public street at a greater rate of speed than fixed by City Ordinance for the street and for the zone thereof, that such motor vehicle was so being driven upon, if zoned.

That in prosecutions under this ordinance, for the offense of speeding, the complaint, if in other respects sufficient in form, shall as to the portion thereof seeking to acknowledge the offense, be sufficient if it in substance alleges that the defendant did while driving a motor vehicle in said city commit the offense of " Speeding ".

- Section 4. <u>Amendment To City Code.</u> The City of Bastrop Code of Ordinances shall be amended to add Chapter 12 "Traffic and Vehicles", Article 12.05 "Speed Limits", Section 12.05.011 "FM 969 Speed Limits." and Section 12.05.011 "FM 969 Speed Limits." of the Code of Ordinances shall read in accordance with Section 2 of this Ordinance.
- **Section 5.** <u>Passage.</u> Pursuant to Section 3.15 of the City Charter, the Council determined that the first reading of this Ordinance is sufficient for adequate consideration by an affirmative vote of a majority of members of the City Council during the first reading, and therefore, this Ordinance is adopted and enacted without further readings.

- Section 6. Codification. The City Secretary is hereby directed to record and publish the attached rules, regulations, and policies in the City's Code of Ordinances as authorized by Section 52.001 of the Texas Local Government Code.
- Section 7. Severability. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portion of the Ordinance, which shall continue to have full force and effect.
- Section 8. Repeal. This Ordinance shall be and is hereby cumulative of all other ordinances of the City of Bastrop, Texas, and this Ordinance shall not operate to repeal or affect any of such other ordinances except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this Ordinance, in which event such conflicting provisions, if any, in such other Ordinances, are hereby repealed.
- Section 9. Effective Date. That the fact that prompt action should be taken in the regulation of traffic, on the streets of this city, in the manner provided for in this ordinance creates an emergency requiring that the rules that provide that an ordinance shall be read at two separate meetings of the city council before final passage, be suspended; and that the said rules are hereby suspended, and this ordinance is here and now passed, and that it is ordered that it take effect from and after its passage and publication.
