2A. Today's "lunch and learn" presentation by Carollo Engineers will be focused on how an Owner Advisor/Representative can provide support on Construction Management At-Risk (CMAR) projects. While many of the services provided by an Owner Advisor/Representative on traditional Design Bid Build (DBB) project apply to CMAR projects, there are unique Owner Advisor/Representative services for CMAR delivery that are necessary to achieve the benefits of the model. This presentation will focus on the following topics:

- Summarize the typical Owner Advisor/Representative services performed for traditional DBB projects.
- Identify the benefits inherent with CMAR delivery and what steps need to be taken for these benefits to be realized.
- Discuss how CMAR delivery benefits are rooted in the services provided by the Designer and CMAR during the preconstruction phase.
- Identify the additional Owner Advisor/Representative services that can be performed to obtain the full benefits of CMAR delivery.
