BACKGROUND/HISTORY:

The Chief Financial Officer, or appointed staff, provides the City Council a monthly financial report overview for all funds to include detailed analysis for General Fund, Development Services Fund, Water-Wastewater Fund, Bastrop Power & Light and the HOT Tax Fund.

REVENUE

General Fund below the forecast by 8%.

Impact Fee Fund is now running 20.5% below forecast due to delays in receiving anticipated fees.

HOT Tax Fund is below forecast by approximately 13% due to timing of revenues.

Debt Service Funds are performing slightly lower than forecast due to tiAming of revenues.

Hunters Crossing PID is below forecast by approximately 29% also due to timing of revenues

NOTE: The General, Debt Service, and Hunters Crossing PID funds are all below forecast due to the timing of receipt of property taxes.

All other funds are positive to forecast.

EXPENDITURES

<u>Vehicle and Equipment Replacement Fund</u> running 5% over forecast due to purchasing vehicles needed by departments.

All other funds are below forecast.

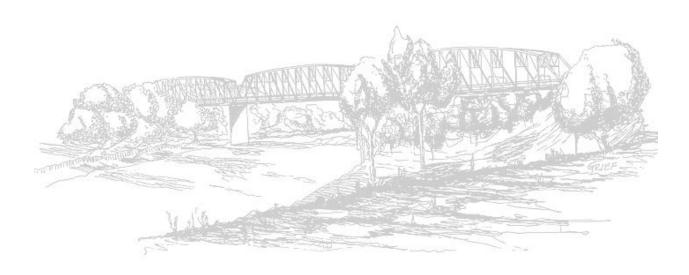

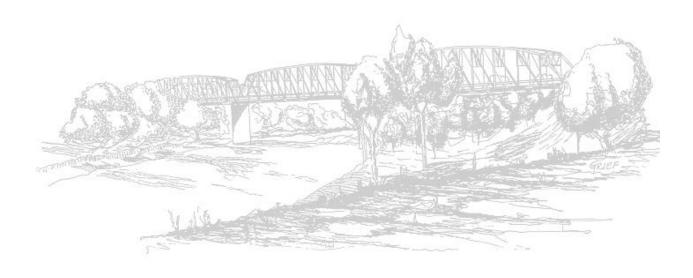

The Schedules of Uniform Submittal Dates will include dates applications will be accepted, when review for completeness checks will occur, when recommendations or approvals are made, and dates of any required Planning & Zoning Commission and/or City Council meetings.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS THAT:

Section 1: The City Council hereby adopts the 2024 Schedule of Uniform Submittal Dates, in accordance with B³ Code Section 2.3.004 Annual Adoption of Schedule of Uniform Submittal Dates for Site Plans, and Place Type Zoning Changes and B³ Technical Manual Section 1.2.002 Uniform Submittal Dates, as attached in Exhibit A.

Section 2: In the case of any conflict between the other provisions of this Ordinance and any existing Ordinance of the City, the provisions of this Ordinance will control.

<u>Section 3</u>: If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, that invalidity or the unenforceability will not affect any other provisions or applications of this Ordinance that can be given effect without the invalid provision.

Section 4: This Ordinance shall take effect immediately upon passage.

BACKGROUND/HISTORY:

On April 11th, 2023, TX DOT conducted an engineering and traffic investigation regarding the speed and number of vehicles that utilized FM 969. The recommendation from TxDot was to lower the speed limit from 65 miles per hour, to 60 miles per hour.

POLICY EXPLANATION:

Texas Transportation Code

Chapter 545, Subchapter H. Speed Restrictions, Section 545.356 Authority Of Municipality To Alter Speed Limits and section 545.351 (a) Maximum Speed Requirement

Sec. 545.356. AUTHORITY OF MUNICIPALITY TO ALTER SPEED LIMITS. (a) The governing body of a municipality, for a highway or part of a highway in the municipality, including a highway of the state highway system, has the same authority to alter by ordinance prima facie speed limits from the results of an engineering and traffic investigation as the Texas Transportation Commission on an officially designated or marked highway of the state highway system. The governing body of a municipality may not modify the rule established by Section 545.351(a) or establish a speed limit of more than 75 miles per hour.

(b) The governing body of a municipality, for a highway or part of a highway in the municipality, including a highway of the state highway system, has the same authority to alter prima facie speed limits from the results of an engineering and traffic investigation as the commission for an officially designated or marked highway of the state highway system, when the highway or part of the highway is under repair, construction, or maintenance. A municipality may not modify the rule established by Section 545.351(a) or establish a speed limit of more than 75 miles per hour.

Sec. 545.351. MAXIMUM SPEED REQUIREMENT. (a) An operator may not drive at a speed greater than is reasonable and prudent under the circumstances then existing.

Bastrop Code of Ordinances

Chapter 12, article 12.05 – Speed Limits, section 12.05.003 Specific speed limits Sec. 12.05.003 - Specific speed limits.

When signs are erected giving notice thereof, no person shall operate a vehicle on any road or highway within the city at a speed greater than that indicated in the schedule as maintained on file in the office of the City Secretary.

ZONING FOR TRAFFIC AND RATE OF SPEED THEREIN, ON FM 969 IN THE CITY LIMITS OF THE CITY OF BASTROP: DEFINING SPEEDING AND FIXING A PENALTY THEREFORE; DECLARING WHAT MAY BE A SUFFICIENT COMPLAINT IN PROSECUTIONS HEREUNDER: REPEALING ALL PRIOR ORDINANCES THAT ARE IN CONFLICT HEREWITH: AND PROVIDING FOR FINDINGS OF FACT, ENACTMENT, CODIFICATION, EFFECTIVE DATE, REPEALER, SEVERABILITY, PROPER NOTICE AND MEETING.

- WHEREAS, the Texas Department of Transportation has determined upon the basis of engineering and traffic investigation that the prima facie maximum speed limit for that portion of FM 969 as shown on the attached Exhibit A, shall be as stated and described hereinafter; and
- WHEREAS, the City of Bastrop desires to protect and ensure the public health, safety, and welfare of its residents and business by regulating and guiding the general traveling public; and
- WHEREAS, the City Council desires to change the current prima facie speed limits on FM 969 in the city limits of the City of Bastrop, as provided herein, to 60 mph pursuant to Section 12.05.003 of the Code of Ordinances to better protect the convenience, health, safety, and welfare of the residents of the City and of the motoring public.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS, THAT:

- **Section 1.** The facts and recitations set forth in the preamble of this Ordinance are hereby found to be true and correct.
- **Section 2.** It is hereby determined upon the basis of an Engineering and Traffic investigation that the prima facie maximum speed limit on those portions of FM 969 routed in the City of Bastrop, is hereby stated, which prima facie maximum speed limit shall be effective at all times and signs will be erected giving notice of the prima facie maximum speed limit so declared to wit.

FOR EASTBOUND TRAFFIC

Beginning at Control Section 1186-02 at milepoint 11.424 (Bastrop Northern City Limit - 755 feet South of Sam Houston Dr.) to milepoint 12.164 (SH 21-SH71), a distance of 0.740 miles, a prima facie maximum speed limit of 60 miles per hour.

FOR WESTBOUND TRAFFIC

Beginning at Control Section 1186-02 at milepoint 12.164 (SH 21-SH71) to milepoint 11.424 (Bastrop Northern City Limit - 755 feet South of Sam Houston Dr.), a distance of 0.740 miles, a prima facie maximum speed limit of 60 miles per hour.

Section 3. That all of the streets of this city, and all portions of any such streets, are hereby declared to be public streets and that the driving or operating of any motor vehicle on or along any portion of any street of this city at a rate of speed that is greater than the maximum rate of speed for said portion of said street, as fixed by this ordinance shall be guilty of a misdemeanor, which is named " The Offense of Speeding " and that the said offense is punishable by a fine in any sum not to exceed Two Hundred dollars (\$200.00). That the use of the word " Speeding " shall be sufficient to designate the said offense, and shall mean that a motor vehicle has been driven upon a public street at a greater rate of speed than fixed by City Ordinance for the street and for the zone thereof, that such motor vehicle was so being driven upon, if zoned.

That in prosecutions under this ordinance, for the offense of speeding, the complaint, if in other respects sufficient in form, shall as to the portion thereof seeking to acknowledge the offense, be sufficient if it in substance alleges that the defendant did while driving a motor vehicle in said city commit the offense of " Speeding ".

- Section 4. <u>Amendment To City Code.</u> The City of Bastrop Code of Ordinances shall be amended to add Chapter 12 "Traffic and Vehicles", Article 12.05 "Speed Limits", Section 12.05.011 "FM 969 Speed Limits." and Section 12.05.011 "FM 969 Speed Limits." of the Code of Ordinances shall read in accordance with Section 2 of this Ordinance.
- **Section 5.** <u>Codification.</u> The City Secretary is hereby directed to record and publish the attached rules, regulations, and policies in the City's Code of Ordinances as authorized by Section 52.001 of the Texas Local Government Code.

- **Section 6.** <u>Severability.</u> If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portion of the Ordinance, which shall continue to have full force and effect.
- **Section 7.** <u>Repeal.</u> This Ordinance shall be and is hereby cumulative of all other ordinances of the City of Bastrop, Texas, and this Ordinance shall not operate to repeal or affect any of such other ordinances except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this Ordinance, in which event such conflicting provisions, if any, in such other Ordinances, are hereby repealed.
- Section 8. <u>Effective Date.</u> This ordinance shall take effect upon the date of final passage noted below, or when all applicable publication requirements, if any, are satisfied in accordance with the City's Charter, Code of Ordinances, and the laws of the State of Texas.

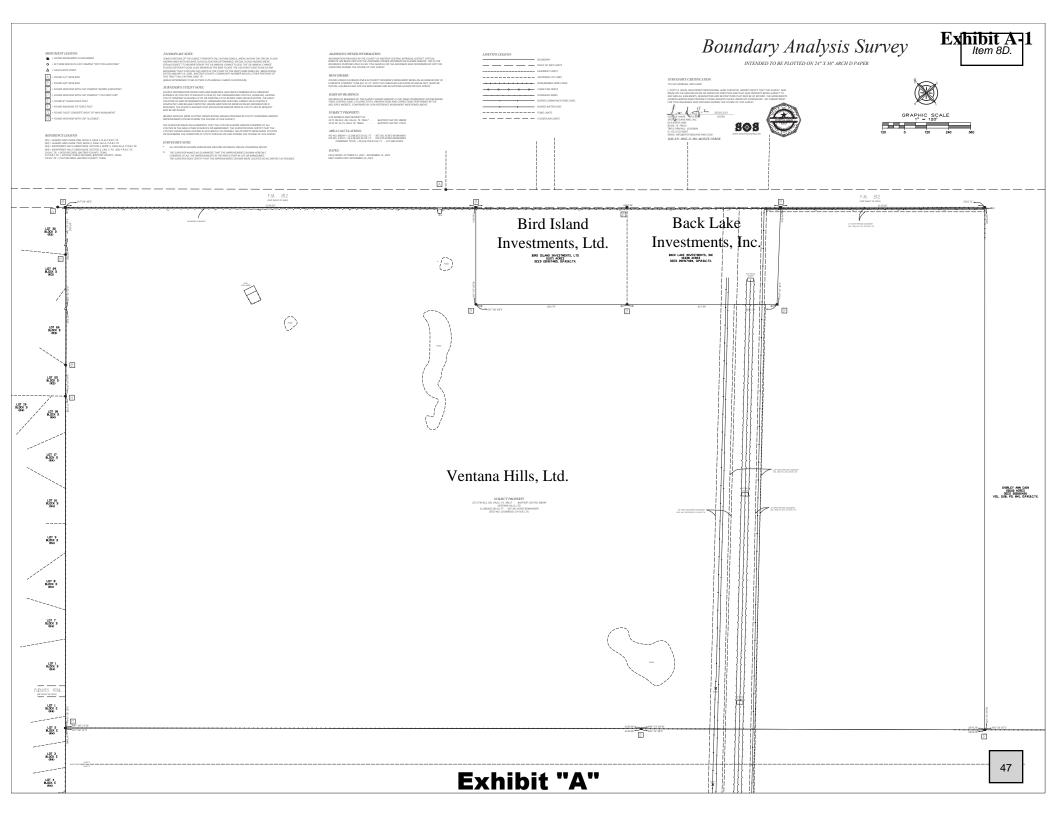

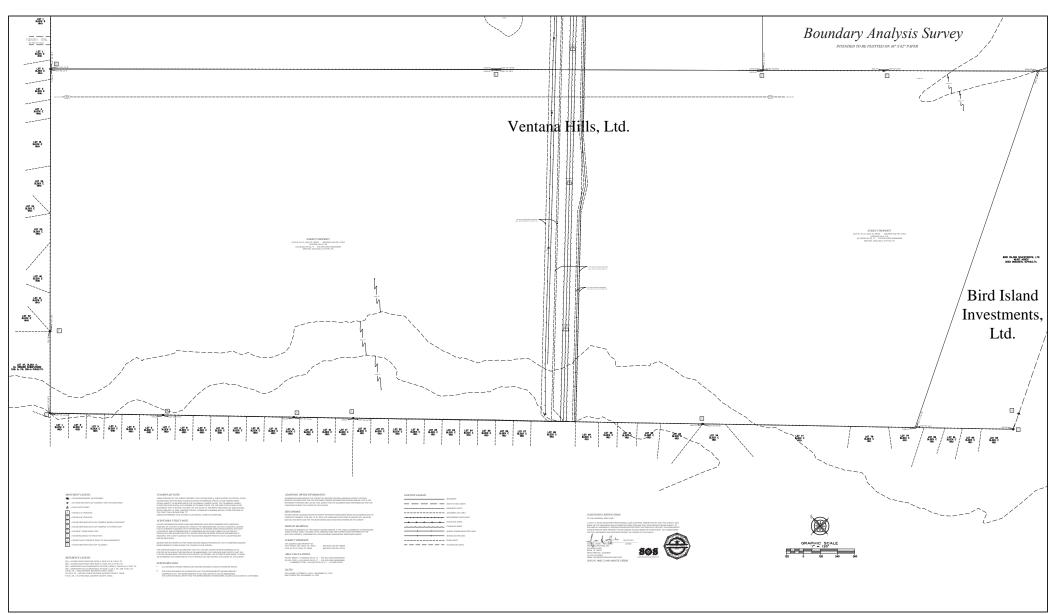

BACKGROUND/HISTORY:

Staff and the Development Review Committee (DRC) are charged with reviewing the B3 Code for amendments. There are inconsistencies between the adopted B3 Technical Manual and the State of Texas requirements for On-site Sewer Facilities (OSSF). Currently, the City code requires a one-acre lot size or greater for individual on-site sewage facility methods. The State requirements allow for a half-acre lot size or greater for the same individual on-site sewage facility methods. The codes need to be consistent and align with the state requirements.

FISCAL IMPACT:

The code amendment to align with state requirements has no fiscal impact.

RECOMMENDATION:

Recommend approving the first reading of Ordinance No. 2024-03, amending the City Code and B3 Technical Manual as submitted.

ORDINANCE NO. 2024-03

AN ORDINANCE OF THE CITY OF BASTROP, TEXAS, AMENDING THE BASTROP CODE OF ORDINANCES, CHAPTER 13, ARTICLE 13.04 ON-SITE SEWAGE FACILITIES AND AMENDING THE B3 TECHNICAL MANUAL, CHAPTER 3, ARTICLE 3.2 INFRASTRUCTURE REQUIREMENTS TO ALIGN WITH THE STATE REQUIREMENTS FOR SEPTIC SYSTEMS ON ONE-HALF ACRE LOTS; AND PROVIDING FOR FINDINGS OF FACT, REPEALER, SEVERABILITY, CODIFICATION, EFFECTIVE DATE, PROPER NOTICE AND MEETING.

- WHEREAS, pursuant to Texas Local Government Code Section 51.001, the City Council of the City of Bastrop has general authority to adopt an ordinance or police regulation that is for the good government, peace, or order of the City and is necessary or proper for carrying out a power granted by law to the City; and
- **WHEREAS,** the City of Bastrop recognizes the need to stay current with state regulations to ensure the health, safety, and welfare of its residents;
- WHEREAS, the Texas State requirements for septic systems on one-half acre lots have been updated to reflect advancements in technology and environmental considerations;
- **WHEREAS,** the City Council finds it necessary to amend the existing City Code to align with the aforementioned state requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS:

- **Section 1.** Findings of Fact: The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein.
- Section 2. Amendment To City Code And B3 Technical Manual: Section 13.04.007 of the City of Bastrop Code of Ordinances and Section 3.2.005 of the B3 Technical Manual are hereby amended to replace the phrase "one acre" with "one-half acre" in all instances referring to the minimum lot size requirements for septic systems and shall read in accordance with Exhibit "A", which is attached hereto and incorporated into this Ordinance for all intents and purposes. Any underlined text shall be inserted into the

Code and any struck-through text shall be deleted from the Code, as shown in each of the attachments.

- **Section 3. Repealer:** To the extent reasonably possible, ordinances are to be read together in harmony. However, all ordinances, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated.
- **Section 4. Severability:** Should any of the clauses, sentences, paragraphs, sections, or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.
- **Section 5. Codification:** The City Secretary is hereby directed to record and publish the attached rules, regulations, and policies in the City's Code of Ordinances as authorized by Section 52.001 of the Texas Local Government Code.
- Section 6: Effective Date: This Ordinance shall take effect upon the date of final passage noted below, or when all applicable publication requirements, if any, are satisfied in accordance with the City's Charter, Code of Ordinances, and the laws of the State of Texas.
- Section 7. Proper Notice & Meeting: It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.

Amendment to City Code and B3 Technical Manual

City Code of Ordinances

Sec. 13.04.007 Amendments.

The city, wishing to adopt more stringent rules for its on-site sewage facility ordinance, understands that the more stringent conflicting local rule shall take precedence over the corresponding requirement of the state commission on environmental quality or any successive agency. Listed below are the more stringent rules adopted by the city:

- (1) No lot having a surface area of less than one-half (0.5) acre shall be henceforth permitted to utilize individual on-site sewage facility methods for sewage disposal; except that lots in subdivisions properly platted, approved, and recorded prior to April 20, 1981, shall be exempt from this one-half (0.5) acre minimum lot size requirement, to the extent permitted by current design criteria for on-site sewage facilities and administrative rules of the state commission on environmental quality, or any successive agency.
- (2) All individual surface and subsurface methods for sewage disposal (including septic systems) within the stated city jurisdiction shall have a site-specific design by a registered professional engineer or a registered sanitarian; and such engineer or sanitarian shall, upon project completion, certify that the installation has been completed in accordance with that engineer's or sanitarian's approved design plans. Such certification and plans shall be satisfactory to the city's designated representative (City Engineer).

SEC. 3.2.002 WATER LINES

- (a) Piping for water mains and connections shall be ductile iron, or AWWA C900 polyvinyl chloride pipe. Service piping shall be copper for all commercial services and polyethylene for all residential services as approved by the City Engineer. All pipe and fittings shall be new and unused. All pipe and fittings shall conform to the latest standards as adopted by the City in Chapter 6, Construction Standards.
- (b) When recommended by the City Engineer and approved by the City Council and so noted in the preliminary plat or final plat review, larger lines shall be installed.

SEC. 3.2.003 VALVES

- (a) At intersections of water distribution lines, the number of valves shall be one less than the number of radiating lines,
- 2 valves for tee connection, and 3 valves for cross connection). Valves shall be located at the P.C. or P.T. of the nearest property line. All valves shall conform to the latest standards of the American Water Works Association.

SEC. 3.2.004 FIRE HYDRANTS

BACKGROUND/HISTORY:

The annual Corvette Invasion is the largest corvette only car show in Texas. In prior years, the event has a direct economic impact of over \$150,000 (see Attachment 2).

The organization has submitted a budget that shows approximately \$20,000 of eligible expenses that can be attributed directly as eligible for HOT funds reimbursement as marketing (advertising the city).

HOT fund use

Excerpt from TML – <u>The Hotel Tax Two-Step</u>.

"Part 1: Heads in Beds The first element of the two-part test is this: Every expenditure of hotel taxes must put "heads in beds." What this means is that every funded project must attract overnight tourists to the city's hotels and motels, thus promoting the city's hotel industry. For example, how about a weekend-long arts and crafts show? There's a very good chance that out-of-town guests might come to visit such an event, so expenditure of hotel tax money on that event would likely qualify. On the other hand, how about a quilting bee at a local nursing home? While a worthy cause, the quilting bee is unlikely to attract overnight tourists and, therefore, probably wouldn't qualify to receive hotel tax funds.

Part 2: The Nine Categories Once a project has cleared the first part of the test, it's time for – you guessed it – the second part of the test. Here it is: Every expenditure of hotel taxes must also fit into one of nine statutorily authorized categories. These are the nine categories: (1) convention and visitor centers; (2) convention registration; (3) advertising the city; (4) promotion of the arts; (5) historical restoration and preservation; (6) sporting events in a county under one million in population; (7) enhancing or upgrading existing sports facilities or sports fields (only in certain cities); (8) tourist transportation systems; and (9) signage directing the public to sights and attractions that are visited frequently by hotel guests in the city. Thus, even if an event puts heads in beds, it cannot receive hotel tax money unless it also fits into one of the nine categories."

TITLE:

Consider action authorizing the City Manager to issue a Request for Qualifications for engineering and surveying services for infrastructure projects including (but not limited to) the American Rescue Plan grant and Community Development Block Grants.

BACKGROUND/HISTORY:

Many of the city's projects are past due and over budget. In an attempt to streamline some processes for services, it is necessary to issue a new Request for Qualifications that would allow the City Manager and staff to best select those firms who best fit the needs of the City of Bastrop.

The process is mandated by state law.

Professional or Personal Services.

- (a) Selection of Professional. Services within the scope of practice, as defined by state law, of accounting, architecture, landscape architecture, land surveying, medicine, optometry, professional engineering, or real estate appraising professional must be selected in accordance with the Professional Services Procurement Act, Tex. Gov't Code §2254.001 et seq. The municipality must select the professional of its choice based on demonstrated competence and qualifications. Then a contract must be negotiated at a fair and reasonable price. The contract fees may not be higher than the recommended practices and fees published by the applicable professional association, nor may they be higher than any maximum provided by law. Tex. Gov't Code §2254.003. If any service is provided by a person licensed or registered to practice one of these professions, the Professional Services Procurement Act may apply.
- (b) Engineers, Surveyors, and Architects. Contracts for engineering, land surveying, and architectural services have additional requirements. To procure architectural, engineering services, or land surveying, a municipality must first select the most highly qualified provider on the basis of demonstrated competence and qualifications; and then attempt to negotiate a contract for a fair and reasonable price. Tex. Gov't Code §2254.004.
- (c) (c) Negotiations. If negotiations for the first-choice candidate fail, the municipality must formally end negotiations and begin negotiating with its next choice. The process continues until a contract is entered into. Tex. Gov't Code §2254.004.

FISCAL IMPACT:

Unknown at this time. Professional services cannot be scored on price, and must be scored on qualifications first.

RECOMMENDATION:

Authorize the City Manager to work with legal to release an RFP for engineering and surveying services within the next 7 days.
